

# TOTAL NUMBER OF FOREIGN SERVICE POSTS






# ORGANIZATION STRUCTURE

# ORGANIZATIONAL OUTCOME 1:

# FOREIGN RELATIONS STRENGTHENED TO PROMOTE A STABLE SECURITY ENVIRONMENT AND ECONOMIC GROWTH

### A. PRESERVATION AND ENHANCEMENT OF NATIONAL SECURITY

As the lead agency institution pursuing the Philippines' foreign policy under the guidance of the President, the Department of Foreign Affairs (DFA) actively promoted national security interests in the country's bilateral, regional, and global engagements in 2015.

Central to this is the Philippine advocacy for the rule of law, the deepening of partnerships with key allies, and the intensified dialogue and over-all cooperation with bilateral partners across the Asia Pacific, the Americas, Europe, and Middle East and Africa. Aside from the signing of the Enhanced Defense Cooperation Agreement (EDCA) with the United States in 2014, the Philippines likewise forged closer strategic partnerships with Japan, Vietnam and Australia in 2015.

The Philippines' peaceful, principled and rules-based approach to the West Philippine Sea/ South China Sea (WPS)/(SCS) disputes gained traction and wider support from the international community as the arbitration case against China in the Permanent Court of Arbitration (PCA) progressed towards the conclusion of the oral hearings on the merits on 30 November 2015.

The Philippines also made significant contributions in regional and global platforms to address non-traditional security issues including human trafficking and migration, the protection and promotion of human rights, disaster risk reduction and management (DRRM), disaster resilience and response, climate change, environmental protection, transnational crimes, and countering violent extremism (CVE).

In ASEAN, the Leaders declared the formal establishment of the ASEAN Community and adopted the Blueprint for realizing the ASEAN vision for a more integrated, peaceful, and stable Community by 2025. As one of ASEAN's founding members, the Philippines has consistently supported ASEAN's central role in strengthening the rules-based security architecture that anchors the peace and stability of the Asia Pacific region.

# ADVOCACY FOR THE RULE OF LAW

The maritime disputes in the West Philippine Sea (WPS)/South China Sea (SCS) became the DFA's foreign policy priority in 2015 and its Foreign Service Posts (FSPs) continued to actively engage international partners in both bilateral and multilateral fora to promote and protect Philippine national interests.

# THE PHILIPPINES' ARBITRATION CASE

The Philippines continued to work towards a peaceful, enduring, transparent and rules-based resolution to the maritime disputes in the WPS/SCS.

The Arbitral Tribunal issued a ruling on 25 October 2015 stating that it has jurisdiction over seven (7) out of 15 Philippine submissions, and that jurisdiction over the remaining submissions will be determined during the oral hearings on the merits of the case. A significant aspect of the ruling was the Tribunal's declaration that its decision would be legally-binding.

Spearheaded by the Philippine legal team, the Philippine Government Team collaborated in gathering documentation to bolster the Philippines' position. The DFA offices and FSPs engaged international partners in an effort to encourage China to: (1) participate in the arbitral proceedings; and (2) respect the Tribunal's rulings.

# ESTABLISHMENT OF THE PHILIPPINES' ARCHIPELAGIC SEA LANES AND MARITIME BOUNDARIES OF THE PHILIPPINES

The DFA continued to provide technical and substantive support to the Philippine Congress in the latter's consideration of the legislative bills on the Philippine Maritime Zones and the Philippine Archipelagic Sea Lanes.

# CO-CHAIR IN THE INTER-AGENCY COORDINATING COMMITTEE ON THE WEST PHILIPPINE SEA (ICC-WPS)

The ICC-WPS was formed through a memorandum issued by the Office of the President dated 17 January 2015. It meets regularly and submits appropriate reports and recommendations on the WPS/SCS issues.

Candid information exchanges on all issues related to the WPS/SCS are the fundamental outcome of this mechanism. Through these discussions, the policy directions, action plans, and public diplomacy strategies were formulated, which were then submitted for consideration by the President.

Since 2014, the ICC-WPS has served as a mechanism to exchange information and coordinate between and among 18 agencies on policy and operations issues. Other relevant agencies may be invited, as necessary. The DFA presided over a total of eight (8) ICC-WPS meetings in 2015.

# PURSUIT OF A RULES-BASED REGIME IN THE WEST PHILIPPINE SEA

For 2015, the DFA intensified efforts in pursuit of a lasting and legally-binding resolution to the disputes in the WPS/SCS including, inter alia, conferences and workshops on various aspects of the 2002 ASEAN-China Declaration on the Conduct of Parties in the South China Sea (DOC) and the Code of Conduct (COC) in the South China Sea.

The DFA focused on public diplomacy efforts on promoting greater understanding of the issue to the internal and external publics, including the academic community, think tanks and the media. There was an increase in the number of op-eds and articles that support the Philippines' position visà-vis China's assertive policy.

# PHILIPPINE ADVOCACY ON THE IMPLEMENTATION OF THE DOC

The DOC embodies the collective commitment of ASEAN and China to promote peace, stability, and mutual trust and to ensure the peaceful resolution of disputes in the South China Sea.

The Philippines continued to actively engage China, both in the bilateral and regional fora, to diplomatically advance Philippine interests and a principled foreign policy.

The Philippines hosted the Seminar-Workshop on the Implementation of the 2002 ASEAN-China Declaration on the Conduct of Parties in the South China Sea (ASEAN-China JWG) from 14 to 15 May 2015.

The two-day Seminar-Workshop was undertaken within the framework of the ASEAN-China Joint Working Group (ACJWG) on the Implementation of the DOC. By hosting the workshop, the Philippines promoted focused discussions on the DOC particularly on critical provisions on the non-use of force or self-restraint.

# **DEEPENING OF BILATERAL PARTNERSHIPS**

To further advance its national security and economic interests, the Philippines intensified its dialogue and over-all cooperation with its key partners in 2015. This intensified engagement is rooted in the Philippines' advocacy for the rule of law and principled cooperation.

# STRATEGIC AND COMPREHENSIVE PARTNERSHIPS

## • Strengthened Strategic Partnership with Japan

The Philippines and Japan signed the Joint Statement on Strengthened Strategic Partnership for Advancing the Shared Principles and Goals of Peace, Security, and Growth in the Region and Beyond on 04 June 2015, on the occasion of President Aquino's State Visit, in Tokyo.

The Declaration, which includes an Action Plan for the Strengthening of the Strategic Partnership, reaffirmed the two strategic partners' joint commitment to the maintenance of regional peace and stability, the achievement of an enduring peace in Mindanao, sustained economic growth in the region, and greater collaboration, dialogue, and people-to-people exchanges.

## • Strategic Partnership with Viet Nam

Viet Nam became the Philippines' third strategic partner upon the signing of the Joint Statement of Strategic Partnership by President Aquino and Vietnamese President Truong Tan Sang on 17 November 2015 in Manila.

The Joint Statement provides the framework to elevate the level and intensity of bilateral exchanges between the two countries, and harness advantages for common development. The partnership shall build upon and enhance existing bilateral mechanisms, operationalize concluded agreements and seek even newer avenues to deepen cooperation in various fields in order to carry out the partnership's vision. The governments of both countries will work together on the following key areas: political cooperation; economic cooperation; defense, security, judicial and law enforcement cooperation; maritime and ocean affairs cooperation; scientific and other technical cooperation; socio-cultural cooperation; and multilateral cooperation.

Under the partnership, both countries agreed to convene a Joint Commission on Maritime and Ocean Cooperation which will develop joint projects and activities to promote cooperation in all aspects of maritime and ocean-related affairs, taking into account their obligations under international law particularly the United Nations Convention on the Law of the Seas (UNCLOS); maintain hotlines between both sides' coast guards and fisheries agencies, and continue existing cooperation among the said agencies; and establish a Technical Working Group in Hydrology, Meteorology, Marine Hydro-Meteorology, Climate Change and Marine Environment in order to develop specific projects and programs that will enhance cooperation in this scientific field.

## • Comprehensive Partnership with Australia

On 18 November 2015, President Aquino and Prime Minister Malcolm Turnbull signed the Joint Declaration on Philippines-Australia Comprehensive Partnership.

Under this Declaration, both countries agree that their "ministers and senior officials will meet regularly, including through the biennial Philippines-Australia Ministerial Meeting (PAMM) to maximize the opportunities to advance cooperation between Australia and the Philippines, including trade, development assistance, defense, education, people-to-people linkages, counter-terrorism and countering transnational crime."

# POLITICAL CONSULTATIONS

The Philippines conducted bilateral consultation meetings with 13 countries in 2015. Bilateral consultation meetings are held to review the status of the Philippines' relations with its partners around the world to discuss key issues and concerns, and to further develop these relations.

# HIGH LEVEL BILATERAL ENGAGEMENTS

# ASIA AND THE PACIFIC

### • Australia

On 18 November 2015 on the sidelines of APEC in Manila, President Aquino and Australian Prime

Minister Malcolm Turnbull met and signed the Joint Declaration on Comprehensive Partnership. During their bilateral meeting, the two Leaders focused on the 70th Anniversary of Relations; enhancement of trade and investment, including the Philippines' interest to join the Trans Pacific Partnership (TPP); enhancement of cooperation in defense, counter-terrorism including foreign terrorist fighters (FTF), and closer cooperation on Countering Violent Extremism (CVE) activities; and disaster risk reduction and management (DRRM). The two Leaders also discussed the WPS/ SCS issue where Prime Minister Turnbull said the maintenance of the rule of law is absolutely critical.

On 17 November 2015, also on the sidelines of APEC, Secretary del Rosario and Australian Foreign Minister Julie Bishop discussed Australia's recent AU\$4 million in assistance over the next three (3) years, in partnership with the United Nations Development Program (UNDP), to support the joint security and justice mechanisms of the peace process. They also discussed the Philippines' arbitration case against China, Philippine migration policy, counter-terrorism, and the sharing of intelligence information to fight terror.

In an earlier meeting with Australian Foreign Minister Julie Bishop on 28 September 2015 in New York, Secretary del Rosario expressed appreciation for Australia's donation of two (2) landing craft heavy (LCH) vessels to the Philippine Navy. He informed the Foreign Minister that the DFA is working with the Department of National Defense (DND) on the proposed transfer of three (3) additional LCH vessels to the Philippines.



## • Bangladesh

Secretary del Rosario and Bangladeshi Foreign Secretary Md. Shahidul Haque signed the Memorandum of Understanding (MOU) establishing Foreign Policy Consultations between the Philippines and Bangladesh on 25 March 2015. On the same day, both countries held the first Foreign Policy Consultations.

Both sides noted the potential to increase trade in goods and services between the two countries. Following the formation of the Philippines-Bangladesh Business Council on 21 January 2015, both countries hoped to generate more activities fostering greater interaction between Filipino and Bangladeshi businessmen and to increase awareness of each country's products.

The Philippine and Bangladeshi delegations also discussed the exchanges between their members of Parliament, education and training exchanges between their Armed Forces and extended invitations to the officers to attend military and defense-related courses in their respective defense colleges. They also explored how the recently concluded MOU on Sports Cooperation can be implemented.

#### • China

Chinese Foreign Minister Wang Yi was in Manila on 10 November 2015 for a one-day working visit where he met with Secretary del Rosario. The meeting was an opportunity for both sides to revisit the agreement between President Aquino and then Chinese President Hu Jintao in 2011 that contentious issues could be separated from the rest of the bilateral relations. Foreign Minister Wang expressed his view that both sides can take steps to contribute to the improvement of bilateral relations and said China values its relationship with the Philippines. Both sides also discussed China's participation in the Asia Pacific Economic Cooperation (APEC) Economic Leaders' Meeting (AELM).

### • India

The 3rd meeting of the Philippines-India Joint Commission on Bilateral Cooperation (JCBC) was

held in New Delhi, India on 15 October 2015. Secretary del Rosario and Indian counterpart Minister for External Affairs Sushma Swaraj agreed to further intensify cooperation through the regular holding of relevant Joint Working and Technical Working Groups, including on trade and investments, pharmaceuticals, and information communications technology (ICT).

The meeting resulted in India's support for the peaceful resolution of the WPS/SCS dispute and its agreement on the importance of settlement of all disputes by peaceful means and of refraining from the threat or use of force, in accordance with international law.

In a joint statement, the Philippines and India asserted the importance of safeguarding the



freedom of navigation and overflight in the South China Sea.

Earlier, the Department of National Defense (DND) co-chaired the 11<sup>th</sup> Philippines-India Policy Consultations/2nd Strategic Dialogue on 05 March 2015 in Manila with the DFA. The Strategic Dialogue discussed possibilities of strengthening the defense and security relations between the two countries. These include strengthening of relations between Coast Guards of the Philippines and India, combating terrorism and transnational crimes, and other issues of regional and global concerns such as WPS/ SCS issue, ISIS, etc.

#### • Indonesia

The visit of Indonesian President Joko Widodo from 08 to 10 February 2015 was an opportunity for the two Leaders to establish a better working relationship in order to build upon significant gains in the relations between the Philippines and Indonesia. During the two Leaders' bilateral meeting, they discussed the resumption of the talks on the Extended Continental Shelf, Indonesia's policy against illegal fishing, the WPS/SCS issue, and the Philippines-Indonesia Border Crossing and Border Patrol Agreement.

# • Japan

President Aquino and Japanese Prime Minister Shinzo Abe signed the Philippines-Japan Joint Declaration on a Strengthened Strategic Partnership for Advancing the Shared Principles and Goals of Peace, Security, and Growth in the Region and Beyond at the Akasaka Palace during the third day of the President's State Visit to Japan on 04 June 2015. Both Leaders declared that the relationship between the two countries has entered the stage of Strengthened Strategic Partnership. They reaffirmed the guiding principles for its future relations and goals within the Asia Pacific region and beyond, while recognizing the relationship of the two countries' shared universal values of freedom, democracy, adherence to the rule of law and respect for basic human rights.

As of September 2015, Japan was the largest source of Official Development Assistance (ODA) for the Philippines among all partners with USD 3.50 billion consisting of ODA loans worth USD 3.37 billion and ODA Grants worth USD 130.17 million (as of September 2015). On 19 November 2015 on the sidelines of the APEC Summit, both countries signed an Exchange of Notes on the North-South Commuter Railway Project worth JPY 241.991 billion. As part of the bilateral cooperation Roadmap for Quality Infrastructure Development for the Transport Section, the project aims to improve efficiency of the land transportation capacity of Metro Manila and provide a more environmentally sustainable mode of transport by constructing a new 36.7 km commuter railway from Malolos, Bulacan to Tutuban, Manila.

Both sides also signed a bilateral Social Security Agreement on 19 November 2015. The Agreement will maintain the benefit rights of workers who have divided their careers between the Philippines and Japan.

### New Zealand

President Aquino and New Zealand Prime Minister John Key met on 19 November 2015 on the sidelines of APEC and discussed Philippines-New Zealand partnership on political matters and defense; trade and investment, including the Philippines' interest to join the TPP; New Zealand's development assistance in the fields of disaster risk reduction; and scholarship provisions to Filipinos. Prime Minister Key mentioned that Filipinos are present in different sectors in New Zealand, including in the dairy sector. President Aquino thanked New Zealand for its support in the development of the Philippine dairy sector.

#### Pakistan

(Photo credit: DFA-PISU) The 4<sup>th</sup> Philippines-Pakistan Policy Consultations were held in Manila on 22 January 2015. The Philippine delegation was led by Undersecretary Evan P. Garcia. The Pakistani delegation paid a courtesy call on Secretary del Rosario who congratulated both delegations for the successful conduct of the consultations. He expressed gratitude to Foreign Secretary Aizaz Ahmad Chaudhry for the assistance that Pakistan gave to the victims of Super Typhoon Haiyan, and extended his sincere condolences to the families of the victims of the Peshawar school massacre.

Foreign Secretary Chaudhry stated that Prime Minister Nawaz Sharif's government is focused on economic development and that Pakistan also seeks to increase its economic engagement with ASEAN Member States. He said that he is pleased with the friendly relations between the Philippines and Pakistan and that he looks forward to further improving cooperation between the two countries in several areas.

## • Republic of Korea (ROK)

As of September 2015, ROK is the 6<sup>th</sup> largest source of ODA among all partners with USD 522.82 million of ODA (Loan and Grant Net Commitments of USD 453.31 million and USD 87.51 million), respectively.

The Philippines acquired from ROK the following:

- 1. One (1) Patrol combat corvette (donation approved by ROK on 24 February 2015);
- 2. One (1) landing craft utility and rubber boats under the Transfer Arrangement singed on 30 March 2015, which arrived in the Philippines on 29 May 2015;
- 3. 12 FA-50 Fighter/ Surface Attack/ Lead-in Fighter Aircraft from the Korea Aerospace Industry, with two (2) of the aircraft delivered last November 2015.

The DND and the Ministry of National Defense of ROK signed a MOA on the Protection of Classified Military Information on 14 September 2015 in Camp Aguinaldo, Quezon City. The Agreement aims to enhance support and cooperation in the field of defense by promoting the exchange of information, including classified military information. This is relevant given the volatility of the security situation in the Korean Peninsula and Asia Pacific.

Meanwhile, the President's Bilateral Meeting with President Park Geun-hye on the sidelines of APEC-AELM on 18 November 2015 discussed the strengthening of bilateral relations through the holding of more frequent bilateral consultations and meetings.

## Singapore

On 15 July 2015, the Singapore Ministry of Foreign Affairs hosted the 3<sup>rd</sup> Round of Informal Consultations on the Philippines-Singapore Action Plan. Both sides discussed the Philippines' proposal to institutionalize bilateral defense engagements including officers exchanges, intelligence training between the Philippine Military Academy and the Singapore Armed Forces Training Institute, and the conclusion of an MOU between the Philippine and Singapore Navies.

### • Thailand

On 28 August 2015, President Aquino and Thai Prime Minister Gen. Prayut Chan-o-cha met to discuss the overall bilateral relations between the Philippines and Thailand, and the 6th Philippines-Thailand Joint Commission for Bilateral Cooperation (JCBC). Prime Minister Prayut expressed Thailand's readiness to complete the commitments and pending agreements covering various areas of cooperation between the Philippines and Thailand. These include defense and law enforcement cooperation, where the President noted the talks between the Philippine and Thai Navies and Thai

Armies, and the negotiations on the draft MOU on Cooperation in Combating Illicit Trafficking in Narcotic Drugs and Controlled Precursors and Essential Chemicals (CPECs) between the Philippine Drug Enforcement Agency (PDEA) and the Royal Thai Police.

During the bilateral meeting between Secretary del Rosario and then Foreign Minister Patimapragorn on 07 April 2015, the two Ministers expressed satisfaction on the status of bilateral relations between the Philippines and Thailand and expressed their hope for more high-level exchanges and further deepening of relations. Both agreed to the conduct of the Joint Trade Committee (JTC) and the Joint Commission on Military Cooperation (JCMC).

#### • Viet Nam

President Aquino met with Vietnamese President Truong Tan Sang on the sidelines of the AELM on 17 November 2015. The two Leaders discussed ways to push bilateral cooperation forward in light of the elevation of Philippines-Viet Nam relations to a Strategic Partnership. President Aquino also took the opportunity to discuss issues concerning the WPS/SCS, including the recent favorable ruling of the PCA regarding jurisdiction. The two Presidents agreed on the vital importance of ensuring the full and effective implementation of the DOC, as well as the urgent need for the Parties to conclude negotiations on a legally-binding COC.

After the bilateral meeting, the two Leaders witnessed the signing of the Joint Statement on the Establishment of a Strategic Partnership and the exchange of the signed Protocol to amend the 2010 Philippines-Viet Nam MOA on the Supply of Vietnamese Rice to the Philippines.



Secretary del Rosario and Vietnamese Deputy Prime Minister and Foreign Minister Pham Binh Minh agreed during the 8<sup>th</sup> Meeting of the Philippines-Viet Nam Joint Commission for Bilateral Cooperation (JCBC) to fully implement the MOA on Defense Cooperation signed in October 2010. Both sides welcomed the activation of a dedicated hotline between the Philippine Coast Guard (PCG) and Viet Nam Coast Guard (VCG) pursuant to the MOA on the Establishment of a Hotline Communication Mechanism between PCG and VCG. Both sides underscored the importance of the full and effective implementation of the 2002 ASEAN-China DOC.

#### • Canada

President Aquino embarked on a State Visit to Canada from 07 to 09 May 2015. This was the first State Visit by a Philippine president to Canada in 18 years. During his meetings with Governor General David Johnston and Prime Minister Stephen Harper, President Aquino discussed issues of mutual concern such as regional security and increasing the flow of trade and investments, highlighting potential areas where both countries could deepen bilateral cooperation. Following these discussions, the President and Prime Minister Harper witnessed the signing of three (3) major agreements in labor, economic

cooperation, and development assistance aimed at strengthening engagement in these key areas.

On 10 November 2015, on the sidelines of the AELM, President Aquino met with newly elected Canadian Prime Minister Justin Trudeau. The two Leaders affirmed their intention to maintain and further expand the strong bilateral ties between the Philippines and Canada, particularly in the areas of development cooperation and bilateral trade and investment. The two Heads of State reiterated their commitment to furthering people-topeople ties, particularly by promoting the welfare of the growing Filipino community in Canada.

#### • Chile

During the State Visit of Chilean President Michelle Bachelet on 16 November 2015, President Aquino and President Bachelet underscored the consistently positive bilateral relations between

the Philippines and Chile, and expressed optimism that this partnership could be further strengthened and enhanced by maximizing available Bilateral Consultation Mechanisms.

President Aquino and President Bachelet witnessed the signing of the LOI on the Enhancement of Trade Relations, aimed at conducting a joint study on the possibility of establishing a bilateral free trade agreement.

The two Leaders also witnessed the signing of the MOU on DRRM, which would facilitate the exchange of best practices and experiences on disaster management.

#### Colombia

On 17 November 2015, President Aquino and Colombian President Juan Manuel Santos agreed during their bilateral meeting to share best practices and experiences with regard to their respective counter-insurgency programs, peace negotiations, and the war against illicit drug trafficking.

Colombia was present during APEC as a special guest of the Chair. Colombia is a member of the Pacific Alliance alongside Chile, Mexico and Peru. The Alliance aims to establish deeper bloc-to-bloc relations with APEC and held a dialogue with APEC member economies in Manila.

In a separate bilateral meeting, following that of the two Presidents, Secretary del Rosario and Foreign Minister Maria Angela Holguin signed the MOU between the DFA-FSI and Colombia's Diplomatic Academy-Augusto Ramirez Ocampo.

## • Mexico

Mexican President Enrique Peña Nieto came to Manila on a State Visit on 17 November 2015. He also attended the AELM. The meetings between President Aquino and President Peña Nieto opened a new era in the Philippine-Mexican bilateral relations aimed at providing more frequent political dialogues at all levels of government, continued active economic engagement that would also capitalize on their respective strengths as entry points into their regions, and stronger people-to-people ties underpinned by rich and longstanding historical and cultural linkages. The two Leaders also exchanged views on and secured mutual support for regional and international issues.

The following bilateral agreements were signed during the State Visit:

- 1. Agreement on the Avoidance of Double Taxation with Respect to Taxes on Income and the Prevention of Fiscal Evasion;
- 2. Memorandum of Understanding on Tourism Cooperation; and,
- 3. Memorandum of Understanding on Combating Illicit Traffic in Narcotic Drugs, Psychotropic Substances, their Analogues, Precursor Chemicals and Essential Chemical Products, as well as Products or Preparations Containing Them.

#### United States

The highlight of Philippines-US relations in 2015 was the visit of President Barack Obama to the Philippines from 17 to 20 November to attend the AELM. During the visit, President Obama announced increased US assistance to the Philippines of USD 79 million for maritime security, and the transfer of two (2) vessels: (a) an oceanographic research vessel; and, (b) a high-endurance all-weather cutter. President Obama reiterated the US' "ironclad commitment" to the defense of the Philippines. President Obama also called on China to halt its islandbuilding, construction, and militarization activities in the WPS/SCS. President Obama also expressed support for the Philippines' decision to pursue arbitration under UNCLOS to peacefully resolve maritime disputes.

On 06 August 2015, Secretary del Rosario and US Secretary of State John F. Kerry had the opportunity to meet on the sidelines of the 48<sup>th</sup> ASEAN Ministerial Meetings in Kuala Lumpur to discuss bilateral and regional issues, including the resolution of the disputes in the South China Sea.

They also discussed new areas and initiatives for defense and security cooperation, which in recent years have focused on maritime security and maritime domain awareness. They reaffirmed the importance of the early implementation of the Enhanced Defense Cooperation Agreement and agreed to reconvene the Philippines-United States 2 + 2 Ministerial Consultations.

On 11 May 2015, Secretary del Rosario visited Washington DC where he engaged members of the US Congress. The Philippines has been engaging the US Senate and House of Representatives to help strengthen the Philippines' defense capabilities and for assistance in enhancing Philippine maritime security and maritime domain awareness. US legislators conceptualized the Maritime Security Initiative in the 2016 National Defense Authorization Act to help the Philippines and other littoral states in Southeast Asia build capacity in maritime security. An even closer engagement with the US House of Representatives increased the membership of the US-Philippines Friendship Caucus to 69.

#### • France

by an incumbent President of France since the establishment of diplomatic relations in 1947. The meeting between the two Leaders served to launch the Manila Call to Action on Climate Change. The launch was participated in by Senator Loren Legarda and French actress Marion Cotillard.

President Hollande addressed the opening of the Forum on Climate Change held at the National Museum and also attended the inauguration of the Ferrante Ferranti Photo Exhibit on Philippine baroque churches.

#### • Italy

President Aquino conducted an Official Visit to Italy from 02 to 03 December 2015. He met with both President Sergio Mattarella and Prime Minister Matteo Renzi and discussed issues including trade relations, the WPS/SCS issue, AFP Modernization Program, Philippines-EU Free Trade Agreement, Mindanao Peace Process, and the migrant crisis. The President also met with the Filipino community in Italy.

#### • Russia

The bilateral meeting between President Aquino and Russian Prime Minister Dmitry Medvedev on 18 November 2015 on the sidelines of the AELM discussed cooperation on trade and investment and political-security. The two Leaders also witnessed the signing of the New Air Services Agreement between the Philippines and Russia and the Memorandum of Cooperation between the Philippine Drug Enforcement Agency and Russian Federal Service on Narcotics Trafficking on Combating New Psychoactive Substances.

## • Sovereign Military Order of Malta

His Most Eminent Highness Prince and Grand Master Frá Matthew Festing of the Sovereign Military Order of Malta (SMOM) visited the Philippines from 01 to 07 March 2015. The visit coincided with the commemoration of the 50<sup>th</sup> Anniversary of the Establishment of Diplomatic Relations between the Philippines and the SMOM. The visit centered on the humanitarian work of the SMOM in the Philippines. Among the highlights of the visit are as follows:

- Turnover of the symbolic key to 700 new shelters built by the SMOM in Bantayan Island, Cebu and Basey, Samar for victims of Super Typhoon Haiyan; and,
- Exchange of decorations with the Prince and Grand Master Frá Festing conferred the Order of Sikatuna Rank of Rajah (Grand Collar) and President Aquino conferred the Order Pro Merito Melitensi (Grand Collar) by SMOM.

### • Holy See

His Holiness Pope Francis conducted a State and Apostolic Visit to the Philippines from 15 to 19 January 2015 with the theme "Mercy and Compassion". President Aquino received Pope Francis in Malacañang Palace on 16 January 2015. Pope Francis had a general audience with senior government officials and members of the Diplomatic Corps.

The Pope held a mass at the Quirino Grandstand attended by a record 6 to 7 million people. He also held an Encounter with the Youth at the University of Santo Tomas and an Encounter with the Families at the Mall of Asia Arena.

Pope Francis visited Tacloban and held mass at the Tacloban International Airport with an estimated 150,000 attendees. He likewise visited the Cathedral of the Transfiguration of Our Lord in Palo, Leyte, had a brief meeting with priests, religious people, seminarians, and families of survivors, and blessed the Pope Francis Center for the Poor.

On 04 December 2015, President Aquino visited the Vatican and had a meeting with Pope Francis. He had a private audience with Pope Francis and discussed the following topics: (1) the Pope's request for prayers, (2) the Mindanao Peace Process, and (3) an invitation extended by the President for the Pope to visit the Philippines again in the future.

President Aquino witnessed the unveiling of the mosaic image of the Our Lady of Peñafrancia, designed by Italian artist Roberto Cassio, at the Vatican Gardens. The Philippines is the 10<sup>th</sup> country to have a representation of one of its most revered images of the Blessed Mother at the Vatican Gardens.

### **3rd European Ambassadors' Forum**

To foster closer cooperation and facilitate regular exchanges of views and information with the European region, the DFA through the Office of European Affairs (OEA) held several

### REGIONAL CONSULTATION MEETING FOR POSTS IN THE MIDDLE EAST AND AFRICA

In 2015, the series of Regional Consultation Meetings (RCMs) began with the Middle East and African region. The RCM with Heads of Post in the Middle East and Africa was convened from 01 to 04 December 2015 in Manila with the participation of 20 Heads of Post (19 HoPs from the Middle East and Africa + Turkey), high-ranking officials of the DFA, resource speakers from Philippine Government agencies, and field experts who spoke and delivered presentations on various immediate and important topics affecting the region.

The RCM was convened to take stock of urgent developments domestically and regionally (WPS, Terrorism, Terrorist Financing, Human Trafficking, Labor Migration Issues and Illegal Recruitment, Mindanao Peace Process and the Bangsamoro Basic Law (BBL), the Philippines' bid for Observer Status in the Organization on Islamic Cooperation (OIC), Economic and Cultural



Diplomacy, Promoting Tourism in MEA Countries) in order to recalibrate strategies in pursuing Philippine interests and aligning programs of the DFA towards emerging realities.

The RCM was held from 01 to 04 December 2015 in Manila and was participated in by 20 Heads of Posts, high-ranking DFA officials, resource speakers from various government agencies and field experts, Manila.

### MIDDLE EAST AND AFRICA

### • Egypt

The Philippines participated in the 9<sup>th</sup> Philippines-Egypt Joint Commission Meeting (JCM) held in Cairo, Egypt from 18 to 19 May 2015.

The Philippine delegation was led by Undersecretary for Migrant Workers' Affairs Jesus I. Yabes while the Egyptian delegation was led by Assistant Foreign Minister for Asian Affairs and the Affairs of Australia, New Zealand and the Pacific Islands Yasser Mourad.

During the 9<sup>th</sup> JCM, the two sides discussed ways to move forward pending agreements, and possible fields of cooperation in skills training and training of diplomats of both countries. The meeting also discussed the preparations to commemorate the 70<sup>th</sup> Anniversary of Philippines-Egypt bilateral relations in 2016. The JCM discussed the launch of the Memorandum of Understanding (MOU) on Cooperation between the Philippine Chamber of Commerce and Industry (PCCI) and the Federation of Egyptian Chambers of Commerce (FECC) signed on 18 May 2015.

### • Israel

The 8<sup>th</sup> Philippines-Israel Joint Commission Meeting (JCM) was held at the DFA on 04 February 2015 with Undersecretary for Policy Evan P. Garcia leading the Philippine delegation and Deputy

Director General Mark Sofer of the Ministry of Foreign Affairs heading the Israeli delegation.

During the 8<sup>th</sup> JCM, the two countries exchanged views on how to strengthen economic, defense, labor, and development cooperation. Both sides said they are looking forward to carrying out projects on capacity building and knowledge transfer which will be beneficial to both the Philippines and Israel.

A soft launch of the Philippines-Israel Joint Commemorative Stamp was held at the Manila Diamond Hotel on the sidelines of the JCM. The launch of the Joint Commemorative Stamp honored the historic rescue by the Philippines of Jewish people from the Holocaust during the presidency of Manuel L. Quezon. A similar launch of the Joint Commemorative Stamp was held in Rishon LeZion, Israel on 29 January 2015.

Secretary del Rosario also received Israeli Minister of Tourism Yariv Levin on 18 September at the DFA during the latter's official visit to the Philippines from 16 to 21 September 2015 upon the invitation of Tourism Secretary Ramon R. Jimenez, Jr. The visit of Minister Levin to the Philippines was his first official trip abroad as Minister of Tourism since his appointment in May 2015.

The two officials discussed matters concerning tourism cooperation. They agreed that there is a huge potential in increasing the volume of tourism traffic between the two countries by maximizing the Air Services Agreement signed in 2014.

In 2014, Israel was the third largest tourist market of the Philippines in the Middle East, next to Saudi Arabia and the United Arab Emirates while the Philippines ranked 6<sup>th</sup> in Israel's top markets in Asia in 2013.

### South Africa

Assistant Secretary for Middle East and African Affairs Julius D. Torres led the Philippine delegation to the 3rd Philippines-South Africa Bilateral Consultations Forum held in Pretoria, South Africa from 13 to 14 April 2015. Deputy Director-General for Asia and the Middle East of South Africa's Department of International Relations and Cooperation (DIRCO) Dr. Anil Sooklal headed the South African delegation.

During the consultations, the two countries shared insights and information on domestic and regional concerns. The Philippines briefed South Africa on recent developments in the arbitral proceedings on the WPS/SCS, Mindanao Peace Process, ASEAN Community, and the Philippine economy.

### • Tunisia

On 23 and 24 November 2015, Undersecretary for Migrant Workers' Affairs Jesus I. Yabes led the 17-member delegation of Philippine officials to the Inaugural Philippines-Tunisia Joint Commission Meeting (JCM), which he co-chaired with Secretary of State Mohamed Ezzine Chelaifa of the Tunisian Foreign Ministry, held in Manila. During the JCM, both delegations discussed initiatives and possible bilateral cooperation in the fields of political, economic, people-to-people exchange, culture, and tourism-related activities.



With their common desire to fulfill their commitment to combat terrorism, the two countries agreed on a proposal to cooperate in the field of intelligence sharing and other counter-terrorism related projects.

Prior to the commencement of the JCM, three (3) bilateral agreements were signed namely:

- 1. MOA on the Establishment of a Bilateral Consultations Mechanism between the DFA and the Tunisian Ministry of Foreign Affairs (MFA);
- 2. Agreement on Cultural Cooperation between the Philippines and Tunisia; and,
- 3. MOI between the FSI and the Diplomatic Institute for Training and Studies (IDFE) of Tunisia.

The close relations between the Philippines and Tunisia were manifested by Tunisia's assistance to the Overseas Filipinos (OFs) during the Libyan crisis and its approval of the establishment of a Philippine Temporary Mission in Tunis in September 2014.

In order to facilitate the growing bilateral trade relations of the Philippines and Tunisia, both sides established a Joint Philippines-Tunisia Business Council on 24 November 2015.


### ENHANCING REGIONAL AND MULTILATERAL ENGAGEMENTS

### **KEY ADVOCACIES**

### • Human Rights

In ASEAN, the ASEAN-Philippines (ASEAN-PH) National Secretariat, in cooperation with the University of the Philippines Law Center Institute of Human Rights, hosted the ASEAN Intergovernmental Commission on Human Rights (AICHR) Workshop on the Development of ASEAN Legal Instruments on Human Rights from 14 to 15 September 2015 in Manila. The workshop provided an opportunity for participants to identify strategies for strengthening cooperation among ASEAN bodies and other concerned national government bodies and stakeholders on human rights promotion and protection work.

The ASEAN-Philippines National Secretariat and the Office of the Philippine Representative to the AICHR of the DFA convened the Regional Consultation Workshops on Strengthening AICHR's Protection Mandate through Exploring Mechanisms and Strategies to Protect Women and Girls from Violence, in Manila on 27-29 March 2015.



In the UN, the UN Subcommittee on Prevention of Torture and Other Cruel, Inhumane or Degrading Treatment or Punishment of the Optional Protocol to the Convention Against Torture (SPT-OPCAT) visited the Philippines from 25 May to 03 June 2015.

The SPT-OPCAT delegation headed by Ms. Suzanne Jabbour met with the House Committees on Human Rights and Public Order and Safety. The meeting focused on the proposed legal framework to establish a National Preventive Mechanism (NPM) against torture.

The SPT-OPCAT delegation also met with officials of the Commission on Human Rights and visited detention facilities.

### • Disaster Risk Reduction and Management (DRRM)

The DFA contributed to the work of the National Disaster Risk Reduction Management Council (NDRRMC) on DRRM related discussions, issues, and developments in bilateral, regional and international platforms.

In 2015, the DFA participated in numerous DRRM-related meetings and workshops, namely:

- Indonesia-Australia 2015 East Asia Summit Rapid Disaster Response Workshop, June 2015;
- Republic Act No. 10121 (otherwise known as "Philippine Disaster Risk Reduction and Management Act of 2010") Sunset Review Policy Workshop, 6-10 July 2015;
- Visit to Leyte of Special Representative of the UN Secretary-General (SRSG) for Disaster Risk Reduction Margareta Wahlström to inspect rehabilitation projects and conduct briefings on Disaster Risk Reduction (DRR), 13-14 September 2015;
- High-level Dialogue: "Implementing the Sendai Framework for Resilient Development with Special Representative of UN Secretary-General (SRSG) for DRR Margareta Wahlström, 15 September 2015;
- Visit of Special Representative of the UN Secretary-General (SRSG) Margareta Wahlström, to Leyte to inspect rehabilitation projects and conduct meeting/briefing regarding Disaster Risk Reduction (DRR), (13-14 September 2015); and,
- 9th Senior Officials Disaster Management Forum, 22 September 2015; and,
- Consultation Workshop on the Results of the Greater Metro Manila Area Risk Assessment Project Phase II Bridging Activity, 09 October 2015.
- The DFA also took the lead in drafting the International Humanitarian Assistance Cluster (IHAC) Operational Guidelines of the NDRRMC.

At the UN, the Philippines was active in the preparatory sessions, the negotiations and the roundtable discussions on the post-2015 framework for disaster risk reduction at the Third United Nations World Conference on Disaster Risk Reduction (3WCDRR) in Sendai, Japan in March 2015. The Conference resulted in the historic adoption of the Sendai Framework for Disaster Risk Reduction 2015-2030. The Philippines advocated for the central role of States in DRR and in preventing and reducing disaster risk as well as in enhancing risk governance, transparency and accountability; the full engagement of all State institutions at all levels and clear articulation of responsibilities across public and private stakeholders; the empowerment of local authorities and local communities in DRR; the importance of Pre-Disaster Risk Assessment in undertaking risk; and the inclusion of climate change and health issues in the DRR conversation.

### • Prevention of Child Abduction

The Hague Convention on the Civil Aspects of International Child Abduction was signed on 25 October 1980 and entered into force on 01 December 1983. As of November 2015, there are 93 State Parties to the Convention. The Convention is one of the conventions of the Hague Conference on Private International Law (HCCH). The Convention is aimed at protecting children from the harmful effects of abduction and retention across international boundaries by providing a procedure to bring about their prompt return.

The DFA coordinated with the Department of Justice (DOJ), Department of Social Welfare and Development (DSWD), Office of the Solicitor General (OSG), Council for the Welfare of Children (CWC) and Inter-Country Adoption Board (ICAB) regarding the Philippines' accession to the Convention. All agencies concurred in the proposed accession. President Aquino signed the Instrument of Accession on 16 December 2015.

#### • Climate Change and Environmental Protection

At the Leaders Event of the 21<sup>st</sup> Session of the Conference of Parties (COP21) to the United Nations Framework Convention on Climate Change (UNFCCC), President Aquino delivered the National Statement outlining Philippine achievements and plans for cutting carbon emissions as part of its contribution to addressing the adverse effects of Climate Change.

President Aquino also delivered his Keynote Speech at the Climate Vulnerable Forum (CVF) High Level Event, where he highlighted the Philippines' efforts to address climate change and Philippine initiatives as the current Chair of the CVF, a group of 20 developing countries most vulnerable to climate change.

### • Women's Issues

The Philippines advocated for the inclusion of language on priority issues which, among others, are as follows: (1) protection of migrant workers; (2) protection of persons living with HIV, indigenous peoples, and women and girls; (3) ensuring access to decent work and all other proposed insertions related to domestic work and the informal sector; and, (4) participation of women and girls in decision-making in climate change adaptation and disaster risk reduction in the international and regional fora.

The key recommendations of the two conferences are: (1) AIPR should continue to provide a platform to discuss women's participation in peace processes and conflict resolution; (2) AIPR should organize training and workshops for women to become peace mediators; (3) AIPR should consider organizing an ASEAN network of women on peace and security, including a pool of experts on peace and mediation; and, (4) ASEAN Member States (AMS) should continue undertaking activities to formulate policy recommendations, including the development and implementation of national action plans on women, peace, and security in accordance with UN Security Council Resolution 1325.

### DR. RAUL C. PANGALANGAN'S CANDIDATURE TO THE INTERNATIONAL CRIMINAL COURT (ICC) 2015-2021

Dr. Pangalangan will serve in the ICC for six (6) years from 2015 to 2021 and his election to the ICC will guarantee the Philippines'

continuing support for the Court's work in ending impunity by ensuring that individual criminal responsibility is enforced through the highest judicial standards.

# PHILIPPINE CANDIDATURE TO THE HUMAN RIGHTS COUNCIL (HRC) 2016-2018

The Philippines secured the fifth slot in the Asia Pacific Group in the Human Rights Council (HRC) for the term 2016-2018. The Philippines will serve in the Council for three (3) years. With its election to the HRC, the Philippines will continue its commitment to promote and protect human rights and to serve in the Council as a bridge for genuine dialogue and cooperation on human rights issues, in relation to migrant workers and climate change.

### UN COMMISSION ON INTERNATIONAL TRADE LAW (UNCITRAL) 2016-2022

The Philippines was re-elected to the UN Commission on International Trade Law (UNCITRAL) for the term 2016-2022 at elections held on 09 November 2015 in New York.

The Philippines, along with 22 other countries, will serve in the Commission from June 2016 to June 2022.

With its re-election to the UNCITRAL and its continued participation in the activities of UNCITRAL Working Groups, the Philippines will be constantly updated on international commercial law conventions, model laws, and important legal texts. It will also be able to take advantage of the technical assistance to Member States in their efforts toward commercial law reform and adoption of UNCITRAL texts.

### COUNCIL OF THE INTERNATIONAL MARITIME ORGANIZATION (IMO) UNDER CATEGORY C 2016-2017

The Philippines was re-elected to the Council of the International Maritime Organization (IMO) under Category C for the term 2016-2017 at elections held during the 29<sup>th</sup> Regular Session of the IMO Assembly on 27 November 2015 in London.

With its re-election to the IMO Council, the Philippines will continue its commitment to ensure maritime safety and security, marine environment protection, and the protection and enhancement of the welfare and rights of all seafarers.

### • ASEAN Foreign Ministers' Retreat

Secretary del Rosario attended the ASEAN Foreign Ministers' (AMM) Retreat held on 28 January 2015 in Kota Kinabalu, Sabah, where he proposed that ASEAN ask China to stop its island-building activities in the WPS/SCS, and that the ASEAN appeal to the international community to urge China to do so.

The Retreat reaffirmed the importance of maintaining peace and regional stability, and the need to establish trust and confidence among parties.

### ASEAN Summit

Secretary del Rosario, as member of President Aquino's Official Delegation, participated in the 26<sup>th</sup> ASEAN Summit held in Kuala Lumpur and Langkawi, Malaysia from 27 to 28 April 2015 with the theme "Our People, Our Community, Our Vision". The Philippines pursued the following advocacies:

- ASEAN Centrality;
- Conclusion of the Regional Comprehensive Economic Partnership (RCEP);
- Greater participation of stakeholders in peace and reconciliation initiatives;
- Empowering the people through increased support in various social programs;
- The Philippines as a responsible partner of the regional and international community in addressing current issues such as Extremism and Humanitarian Emergencies; and
- Welcoming new members and Dialogue Partners.



During the 27<sup>th</sup> ASEAN Summit and Related Summits held in Kuala Lumpur, Malaysia from 20 to 22 November 2015, the ASEAN Leaders signed three (3) documents, namely:

- 2015 Kuala Lumpur Declaration on the Establishment of the ASEAN Community;
- Kuala Lumpur Declaration on the ASEAN 2025 (with three blueprints—ASEAN Political-Security Community Blueprint 2025; ASEAN Economic Blueprint 2025; and ASEAN Socio-Cultural Community Blueprint 2025); and
- ASEAN Convention Against Trafficking in Persons (ACTIP), Especially Women and Children.

The Philippines served as the volunteer country shepherd for ACTIP and played a crucial role in finalizing this agreement within the ambit of the ASEAN Ministerial Meeting on Transnational Crimes (AMMTC) after eight (8) years of negotiations.

President Aquino also announced that the Philippines will ensure implementation of ASEAN's Vision 2025 in line with its Philippine Development Plan (PDP). He called for the involvement of the broadest spectrum of society in the community-building efforts and the implementation of Vision 2025. The President also highlighted the urgency of developing a post-2025 ASEAN Connectivity Agenda.

### • UN General Assembly

The 70<sup>th</sup> United Nations General Assembly (UNGA) adopted as its theme, "*Transforming our World: the 2030 Agenda for Sustainable Development*", during the UN Summit from 25 to 27 September 2015 in New York. The Agenda is composed of 17 Sustainable Development Goals (SDGs) and 169 targets



covering economic, social, and environmental dimensions of development which defines the international, regional and national development priorities to eradicate poverty in all its forms, fight inequality and tackle climate change over the next 15 years. It is a plan of action for people, planet and prosperity that also seeks to strengthen universal peace. All countries and all stakeholders, acting in collaborative partnership, will implement this peoplecentered Agenda.

The 2030 Agenda is firmly founded on these four principles: (1) human rights; (2) equality, equity, people empowerment, social cohesion, and justice; (3) accountable governance; and (4) sustainable and inclusive development. All of these principles are embedded in the 1987 Philippine Constitution.

### Asian-African Conference Summit

The Government of Indonesia hosted the Asian-African Conference with the theme "Strengthening South-South Cooperation to Promote World Peace and Prosperity" from 19 to 24 April 2015 in Jakarta and Bandung. The Conference served as a Commemoration of the 60th Anniversary of the First Asian-African Conference and the 10<sup>th</sup> Anniversary of the Establishment of the New Asian-African Strategic Partnership (NAASP).

It brought together representatives from 93 Asian and African countries. The Philippine delegation was headed by Vice President Jejomar C. Binay and supported by the DFA.

The Conference consisted of a Senior Officials Meeting on 19 April, followed by a Ministerial Meeting on 20 April and a Summit from 22 to 23 April held at the Jakarta Convention Centre. On 24 April, a Commemoration of the 60<sup>th</sup> Anniversary of the First Asian-African Conference was held in Bandung.

The Conference adopted three (3) Outcome Documents, namely:

- Bandung Message 2015;
- Declaration on Reinvigorating the New Asian-African Strategic Partnership (NAASP); and
- Declaration of Palestine.

### • Forum for East Asia-Latin American Cooperation (FEALAC)

Speaking during the Plenary of the 7<sup>th</sup> Forum for East Asia-Latin American Cooperation (FEALAC) Foreign Ministers Meeting held in San Jose, Costa Rica from 18 to 21 August 2015, Head of Philippine Delegation Undersecretary for Policy Evan P. Garcia expressed the Philippines' support for FEALAC as the primary link in facilitating cooperation between East Asia and Latin America. ### • Group of 77 (G77)

The Philippines assumed the chairmanship of the Geneva chapter of the G77 and China in January 2015. This was the first time that the Philippines held this office in Geneva. From this position of leadership, the Philippines was able to help shape the multilateral discourse on trade and investment and related issues.

As Chairman of the G77 and China 50 years after the founding of both the Group and United Nations Conference on Trade and Development (UNCTAD), the Philippines provided leadership to help achieve the organization's avowed goal of "prosperity for all" through its three (3) pillars of consensus building, research and analysis, and technical cooperation. The Philippines' leadership resulted in an agreement on the theme and subthemes for the 14<sup>th</sup> meeting of UNCTAD that will be held in Nairobi in July 2016. The main theme, "*From Decision to Action: Moving*

### • OIC

In 2015, the DFA sponsored and participated in various Organization of Islamic Cooperation (OIC)-related meetings, workshop and activities, namely:



- 42<sup>nd</sup> OIC Council of Foreign Ministers Meeting in Kuwait from 27 to 28 May 2015;
- Preparatory Meeting on the Tripartite Review Process wherein the DFA sponsored a meeting, together with Office of the Presidential Adviser on the Peace Process (OPAPP), National Commission on Muslim Filipinos (NCMF), Office of the Executive Secretary (OES), and the members of the OIC Peace Committee on Southern Philippines (PCSP) based in the Philippines to brief the body for the Technical Meeting on the Tripartite Review Process; and
- Technical Meeting on Tripartite Review Process where DFA Officials and personnel participated in the two-day meeting on the Tripartite Review Process from 07 to 08 September 2015.

### **B. PROMOTION AND ATTAINMENT OF ECONOMIC SECURITY**

In 2015, the DFA continued to lead the government's efforts in promoting and advancing the Philippines's economic interests through the One Country Team Approach. With the support and assistance of the Philippine FSPs, the DFA strengthened its relationship with bilateral, regional, and multilateral partners through various initiatives which are aimed at contributing to sustainable development through inclusive growth.

With the DFA Strategic Plan for 2012-2016 in place, the FSPs have been guided by the following overarching goals for economic diplomacy:

- a. Strengthen DFA structures and capacities in relation to economic security;
- b. Contribute to jobs generation; and
- c. Assist in poverty reduction.

In 2015, the Philippines signed 25 economic agreements including in labor, trade, education, and air services. The senior officials at the DFA also continue to be trained in economic diplomacy as an instrument of statecraft through our partnership with the Asian Institute of Management (AIM).

Moreover, the DFA worked closely with various agencies and business organizations in crafting strategies and implementing programs to enhance the country's competitiveness and create greater and better trade, investment and tourism opportunities for the Philippines.

The DFA also supported the conduct of inbound and outbound business missions to promote Philippine goods and services and to attract foreign investments.

# Philippine hosting of APEC 2015























## ASIA PACIFIC ECONOMIC COOPERATION (APEC)

### THE PHILIPPINES' APEC CHAIRMANSHIP

The Philippine hosting of the 2015 APEC Meetings commenced in December 2014 with the holding of the Informal Senior Officials' Meeting at the Shangri-la Hotel, Makati. From December 2014 to November 2015, 219 APEC-related meetings were held in the country, while 10 meetings, including three (3) APEC Business Advisory Council (ABAC) Meetings, were held abroad.

The meetings were guided by the APEC 2015 theme of "Building Inclusive Economies, Building a Better World", consistent with the Philippine development goal of promoting inclusive growth. Initiatives pursued in the APEC meetings contributed to the following 2015 priorities:

- Enhancing the Regional Economic Integration Agenda;
- Fostering Micro, Small, and Medium Enterprises' (MSMEs) Participation in Regional and Global Markets;
- Investing in Human Capital Development; and,
- Building Sustainable and Resilient Communities.

The Philippines' Chairmanship of APEC 2015 not only built on APEC's achievements over the past 25 years, but also steered APEC towards a more inclusive development agenda through the Philippine-led focus on inclusive growth: one that expands the region's growth story to include a vision of economic prosperity and interconnectedness felt at all levels, such that no one individual or country is left behind.

Through various initiatives, projects, and policy recommendations, APEC enriched its multi-year trade and investment agenda by looking at the human and societal dimensions of economic growth. APEC's focus on inclusive growth thus meant delving into widening people's access to opportunities and enabling them to realize their full potential, which would result in more productive employment opportunities, dynamic economic growth, and greater well-being.

The Philippines, as host economy, led APEC-wide efforts to contribute to the four (4) APEC 2015 priorities and generate these outcome documents. These documents – except (1) APEC Strategy for Strengthening Quality Growth and (2) APEC Services Cooperation Framework, which were annexed to the Leaders' Declaration – were annexed to the Joint Ministerial Statement, for endorsement to Leaders.

The APEC meetings culminated in the AELM from 18 to 19 November 2015, with the Retreat theme: *"The Way Forward: Beyond 2020."* At the end of the Retreat, the Leaders adopted the APEC Leaders Declaration.

- APEC Strategy for Strengthening Quality Growth. This Strategy embedded the principles of *institution building, social cohesion/equity, and concern for environmental impact* of economic/industrial activities as new dimensions to consider in generating quality growth. The Strategy underscored how quality growth was about the economic well-being of every individual and of every economy, focusing on how growth can be sustained over the medium- to long-term. Thus, governments of each APEC member economy were called to ensure the principles of good governance, transparency, and inclusion in their individual economic pursuits.
- APEC Services Cooperation Framework (ASCF). The ASCF is a long-term strategic document which provides a common direction and more coherence in APEC's work on services and helps economies gain a deeper understanding of the policy and regulatory settings that will best facilitate innovative, productive, and vibrant services sectors, as appropriate to their needs. This Framework recognizes that more competitive services sectors help create jobs, produce quality goods, widen choices for consumers, and harness opportunities for businesses particularly for micro, small, and medium enterprises (MSMEs).

The Declaration outlined new commitments for APEC member economies to move forward over the coming year to build inclusive economies; foster MSMEs participation in regional and global markets; build sustainable and resilient communities; invest in human capital development; and enhance the regional economic integration agenda.

The Declaration stated that while achieving ongoing economic transformation will not be easy, APEC Leaders were confident that APEC member economies would continue to drive regional and global economic prosperity through quality economic growth, as supported by these collective commitments:

- To support comprehensive and ambitious structural reforms, achieve positive economic, social, and environmental outcomes; and promote good governance;
- To deepen our financial markets and mitigate risks;
- To foster an enabling trading environment that was responsive to new ways in which goods and services were produced and delivered and that promoted inclusiveness, especially for MSMEs;

- To build sustainable and disaster-resilient economies;
- To make urbanization work for growth;
- To redouble our efforts to empower our people with the tools to benefit from and participate in economic growth;
- To achieve an integrated community in a comprehensive and systematic manner;
- To develop the services sector as an enabler of economic growth and inclusion;
- To work with stakeholders to address common challenges; and,
- To strongly support the work of our Ministers, the APEC Process, and all its Committees and Fora.

### APEC BUSINESS MOBILITY GROUP

The DFA successfully hosted the APEC Business Mobility Group (BMG) meetings during the First and Third Senior Officials' Meetings (SOM1 and SOM3) in Subic from 30 January to 02 February and in Cebu from 22 to 24 August 2015, respectively. As a result of these meetings, investors can stay longer in APEC member economies. This further enhanced the Philippines' investment-friendly environment.

### **APEC 101**

The DFA, as the Philippine National Secretariat for APEC, conducted the "APEC 101" information roadshow series on the APEC 2015 Philippine Host Year in 20 universities across the Philippines, as well as in various institutions and business events from September 2014 to December 2015.

In support of the Philippines's hosting and APEC Chairmanship in 2015, the DFA aimed at reaching out to stakeholders, particularly students, to elevate the public's understanding of APEC as an organization,



the Philippines's role in APEC, and the benefits derived from the Philippines' APEC membership, particularly in terms of economic growth and development. The APEC 101 series was also conducted in Cebu, Iloilo, Clark and Manila, cities that hosted APEC 2015 meetings.

### WORLD TRADE ORGANIZATION

At the World Trade Organization (WTO), the Philippines sustained its strong development interests in the core areas of agriculture, industrial goods, and trade in services.

In December 2015, at the 10<sup>th</sup> WTO Ministerial Conference in Nairobi, the Philippines was one of the strong voices that pushed for the agreed package on Agriculture and Development outcomes, including the immediate elimination by developed countries of export subsidies, and by 2018 by developing countries. The Philippines was a main proponent of the G33 proposals on public stocktaking for food security purposes and the safeguard mechanism. These important outcomes would help correct distortions in international agricultural trade and protect our stakeholders, as well as promote food security, livelihood security and rural development of the Philippines. In addition, the expansion of the Information Technology Agreement (ITA II) was envisioned to significantly contribute to the increase of Philippine electronics and IT exports, both key to employment generation and inclusive growth.

The Philippines is known in the WTO as a member of good standing and as a champion of good governance. The country exerted utmost efforts not to be the subject of disputes, preempting them

by faithfully abiding by multilateral trade rules. Part of this good governance thrust and support to the multilateral trading system has been the Philippines' contribution of two (2) WTO Appellate Body Members, six (6) panelists, and a few legal experts who worked for the WTO Secretariat. Furthermore, the Philippines provided leaderships through the appointment of its officials as Chairs of various WTO bodies and meetings. Philippine Permanent Representative to the WTO Ambassador Esteban B. Conejos, Jr. chaired the APEC Geneva Caucus. The Philippines served as Alternate Coordinator of G33 and as ASEAN Committee in Geneva Coordinator for Trade in Services, Agriculture, SPS, and ITA/ecommerce.

### • Philippine Application to the European Union's Generalized Scheme of Preferences-Plus (GSP+)

The DFA worked with the Department of Trade and Industry (DTI) and other relevant government agencies in lobbying for the inclusion of the Philippines in the GSP+ program of the EU, a scheme that aims to assist developing countries in their efforts to alleviate poverty, advance good governance, and promoting sustainable development. The Philippines filed its GSP+ application in February 2014, which the European Commission endorsed in August 2014, and referred to the Council and the Parliament for their approval. After the Parliament's approval of the Philippines' GSP+ application on 18 December 2014, the EU Director General on Trade (DGT) conducted a GSP+ Monitoring Mission to the Philippines from 14 to 18 September 2015 to discuss the Philippines' GSP+ Monitoring Scorecard. The members of the Mission lauded the Philippines' commitment to implement the 27 international conventions on

human rights, labor rights, environment, and governance. The EU DGT was expected to come up with a commission report in January 2016 that will be submitted to the European Parliament.

### • Philippines-European Union Free Trade Agreement Scoping

In 2015, the DFA concluded scoping discussions between the Philippines and EU to lay down the parameters, objectives, and key principles of Philippines-EU Free Trade Agreement (FTA) negotiations. The prospective FTA will cover a broad range of areas that affect trade and economic relations, including trade in goods, customs and trade facilitation, technical regulations, services and investment, public procurement, intellectual property rights, competition and trade and sustainable development. It will also include a comprehensive chapter to ensure that closer economic relations between the Philippines and the EU will go hand in hand with environmental protection and social development.

### • Lifting of the EU Ban on Philippine Air Carriers

The European Commission Directorate General on Mobility and Transport sent an Air Safety Assessment Team to the Philippines from 16 to 24 April 2015. These visits were undertaken following the EU's overall assessment that the Philippines had made sufficient progress to warrant an EU Air Safety List on-site visit after the Air Safety Technical Meeting in March 2015. The EU decision on 25 June 2015 to lift the ban allows Philippine air carriers to operate in Europe.

### • Philippine Action Plan on Illegal, Unregulated, and Unreported (IUU) Fishing

The European Commission lifted on 21 April 2015 its warning or "yellow card" to the Philippines after the country made significant progress in the implementation of its laws and regulations to prevent, deter, and eliminate illegal, unreported, and unregulated (IUU) fishing.

### ORGANIZATION FOR ECONOMIC COOPERATION AND DEVELOPMENT (OECD)

The DFA conducted a Seminar on Philippines-OECD Engagement on 23 March 2015, in cooperation with the OECD. The OECD Delegation of seven (7) officials, led by Mr. Marcos Bonturi, Director for Global Relations, provided a briefing on the Organization and its initiatives on trade, investments,

finance, enterprise, and agriculture and fisheries, as well as on specific topics of interest to the Philippines. Each session also presented initial proposals to further strengthen Philippines-OECD relations.

### ASEAN-HONG KONG SAR

The Philippines actively participated in the 5<sup>th</sup> Round of the ASEAN-Hong Kong, China Trade Negotiating Committee Meeting from 29 November to 03 December 2015 that discussed ways to expand trade and investment between the ASEAN and Hong Kong and deliberated on the key elements and provisions of the free trade agreement.

### HIGHLIGHTS OF BILATERAL ECONOMIC ENGAGEMENTS

### ETHIOPIA

Following the successful Philippines-Ethiopia Air Services Talks, Ethiopian Airlines launched its inaugural

direct flight to Manila on 09 July 2015. Ethiopian Airlines is the first African airline to fly directly to the Philippines, thus making this a historic flight that will open doors to the entire African continent *(Ethiopian Airlines currently serves 52 African countries).* The direct flights will augur more dynamic and vibrant bilateral trade, and investment and tourism opportunities.

### FRANCE

The Philippine Embassy in Paris hosted a dinner for a dozen top French companies on 23 November 2015 as part of its efforts to promote the Philippines as an Information Technology and Business Process Management (ITBPM) destination. These companies belong to various industry sectors, from aeronautics to construction, and are already present or doing business in the Philippines. Undersecretary

### Hong Kong SAR

Invest Hong Kong (InvestHK) conducted a seminar and networking luncheon in Manila on 24 September 2015. During the event, the Board of Investments of the Department of Trade and Industry (BOI-DTI) signed a Memorandum of Intent on Cooperation with InvestHK.

Highlights of the agreement focused on: (1) information exchange on the investment opportunities and best practices in investment promotion; (2) incentives in expanding business opportunities; and (3) provision of policy and technical support to facilitate inward investment.

In addition, inbound medical tourism can be one of the tourism products that the Philippines can offer to Hong Kong SAR given the number of ISO-accredited health facilities in the country.

### THE MIDDLE EAST

As a follow up to the success of a business matching mission in November 2014, the Philippines conducted an Outbound Business Mission (OBM) to the Middle East from 03 to 17 November 2015 which covered Jordan, Qatar, and the United Arab Emirates (Dubai). The DFA assisted DTI's Export Marketing Bureau and the members of the mission composed of four (4) Philippine Government representatives and 30 delegates from the food sector (fresh/processed and halal), personal care, and health & wellness products sector.

### **REPUBLIC OF KOREA (ROK)**

During the three-day outbound business missions to Seoul from 27 to 29 May 2015 to promote Subic, Clark, and Bataan to Korean locators and investors, the business delegation participated in the following activities: (1) Investment Promotion Conference held at the ASEAN-Korea Center; (2) Business-tobusiness meetings with Korean companies at the Embassy of the Philippines; and (3) Briefings for the investment promotion agencies at the LS Industrial Systems (LSIS) headquarters and at the Incheon Free Economic Zone (IFEZ).

A Memorandum of Understanding (MOU) for a joint study on designing an ODA model was signed on 28 August 2015 between the DOST-Metals Industry Research and Development Center and the Korea Association of Machinery Industry, as part of the latter's Industry Technology Official Development Assistance (ODA) Initiative for the Philippines' Mold and Die Industry. This MOU presented an invaluable opportunity for the Philippines to avail itself of Korea's technological expertise in advancing the strategic development of the country's industrial sector through KIAT's proposed ODA Initiative on a Comprehensive Molding Technology Roadmap for the Philippines.

### **UNITED STATES**


The Philippine Embassy in Washington, DC, in partnership with the Philippine Consulate General in Chicago, organized the Roundtable Meeting of President Aquino with the US business community in Chicago on 06 May 2015. The event was co-organized by the US-ASEAN Business Council, the US Chamber of Commerce and the National Center for Asia Pacific Economic Cooperation (NCAPEC).

In June 2015, a High Level Trade and Investment Mission to the US took place from 24 to 29 June 2015. The Mission was led by DOF Secretary Cesar V. Purisima, DTI Secretary Gregory L. Domingo, and DPWH Secretary Rogelio L. Singson for public sector representatives, while National Competitiveness Council (NCC) Co-Chairman Guillermo Luz led the private sector delegates. The Mission included Conferences in Washington DC (24 June), New York (25-26 June), and San Francisco (29 June).

The mission to the US was considered to be an important follow-up to the Philippines-US Memorandum of Cooperation on the Infrastructure Collaboration Platform, which was signed in February 2015 during the 8th Global Infrastructure Leadership Forum (GILF) in New York.



#### PUTTING THE PHILIPPINES ON THE MAP

New York and the whole world saw the Philippines in a glimmering light, thanks to the exhibit, Philippine Gold: Treasures of Forgotten Kingdoms, at the Asia Society in Manhattan from 11 September 2015 to 03 January 2016. The collection, consisting of about 120 pieces of gold ornaments, ceremonial masks, weapons, worship icons and fashion accessories were from the 10th to the 13<sup>th</sup> century, unearthed only during the past 40 years on the Philippine islands of Luzon, Visayas and Mindanao. The gold artifacts attest to the recently discovered evidence of prosperity and achievement of Philippine polities that flourished long before the Spanish discovered and colonized the region.

Majority of the gold pieces are on loan from the Ayala Museum, with the Central Bank of the Philippines

and from the private collection of Architect Leandro Locsin lending more from their collections to complete the exhibit. Ayala Museum Consulting Curator Nina Capistrano Baker and Asia Society Senior Curator for Asian Art Adriana Proser shared their expertise to the exhibit.

More than 200 distinguished guests came to the opening gala of the Asia Society New York during formal launch of the cultural spotlight on the Philippines on 10 September 2015. The glamorous evening featured a ceremonial ribbon cutting, speeches from dignitaries, musical performances, a live auction, and a gourmet Filipino dinner to kick off the four-month season of programming at Asia Society.

#### **D. PUBLIC DIPLOMACY**


Public diplomacy is a key instrument in the DFA's efforts to develop effective policy responses to international issues and challenges, and secure international and domestic support for the Philippines' foreign policy priorities and objectives. In 2015, the DFA continued its robust engagement with domestic and international audiences on diverse subjects relevant to the country's foreign policy.

#### INFORMATION, EDUCATION, AND COMMUNICATION (IEC) PUBLIC DIPLOMACY CAMPAIGN PLAN WITH THE PHILIPPINE INFORMATION AGENCY (PIA)

To increase the level of public awareness and understanding of the issues relating to the WPS,

the DFA signed a one-year MOA with PIA to embark on a campaign plan composed of the following activities:

- WPS Multi-Sectoral Forum conducted by Assistant Secretary and DFA Spokesperson Charles C. Jose, across the country and attended by national and local government units (LGUs), regional police and military officials, business professionals, teachers, students, and fisher folks; 36 interviews and campus tours in universities nationwide.
- A three-episode documentary focusing on the economic, historical, and legal aspects of the WPS/SCS issue, produced by both the DFA and the Presidential Communications Operations Office (PCOO), which was first aired on PTV4 on 12 June 2015. The

documentary is being shown in all DFA RCOs, SOs and FSPs, as well as in airport terminals, bus stations, and ports across the country.

• The DFA and PIA also produced 100,000 copies of the West Philippine Sea comic book in Filipino, English, Cebuano, and Ilokano for the Filipino Youth, particularly the upper grade



school audience. 1,500 copies have been distributed to students in General Santos City, Legazpi City, Quezon City, Sorsogon City, and Zamboanga City.

#### HISTORIC TRUTHS AND LIES: SCARBOROUGH SHOAL IN ANCIENT MAPS

The DFA Archives celebrated its first anniversary with a cartographic exhibit entitled "*Historical Truths and Lies: Scarborough Shoal in Ancient Maps.*" The exhibit ran from 26 to 30 October 2015 at the DFA Lobby.

The material for the exhibit was loaned to the DFA Archives by the Institute for Maritime and Ocean Affairs (IMOA), which featured a selection of 14 maps from the collection of Supreme Court Senior Associate Justice Antonio T. Carpio. The maps document the territorial extent of the Philippines since

the Spanish colonial era to the present, covering the Scarborough (Panatag) Shoal, and China's historical territorial extent and present-day claims in the WPS/SCS.

One of the highlights of the exhibit is a 1734 map, published in Manila by the Jesuit Pedro Murillo, considered as the "Mother of all Philippine Maps."

Discussants were Professor Renato C. de Castro, PhD of De La Salle University (DLSU) and Professor Ferdinand C. Llanes, PhD of the University of the Philippines (UP).

Undersecretary Garcia's lecture marked the first time a senior official from the DFA participated in the event.

#### **2ND RIZAL-NEHRU LECTURE SERIES**

Secretary del Rosario delivered a lecture entitled "Challenges and Opportunities: The Way Forward for Philippines-India Relations" on 14 October 2015 in New Delhi in response to the invitation from the ASEAN-India Centre's Research and Information System (RIS) for Developing Countries. The lecture served as a platform of the Philippine Government to discuss the possibilities of strengthening bilateral relations between the Philippines and India, as well as to provide more information on the WPS/SCS issue.

## ORGANIZATIONAL OUTCOME 2:

#### OVERSEAS FILIPINOS PROTECTED AND ENGAGED

#### ASSISTANCE-TO-NATIONALS (ATN)

At the end of June 2015, the number of overseas Filipinos was placed at 7,979,716. As of November 2015, 27,145 were provided assistance using the DFA's Assistance-to-Nationals (ATN) Fund while an additional 810 were provided with lawyers and other legal services funded by the DFA's Legal Assistance Fund (LAF).

The DFA maintained and concluded retainer agreements with reputable law firms in Egypt, Jordan, Lebanon, Oman, Qatar, Saudi Arabia and Syria to ensure that prompt legal services are made available to Filipinos requiring legal assistance. Lawyers were engaged on a per-case basis in other countries.

The empathy for and care of foreign service personnel were evident in the continued humanitarian and prison visits conducted by consular teams from the Home Office and the FSPs to ascertain the condition and welfare of detained Filipinos. Pioneer missions of the DFA medical teams were sent to Sabah, the Kingdom of Saudi Arabia, and the United Arab Emirates to provide primary care and advice to the Filipino communities in these areas. The DFA also sent a medical Rapid Response Team (RRT) to West Africa in order to assist in the mandatory repatriation of the Filipino communities in Ebola-stricken countries of Guinea, Liberia and Sierra Leone. This was the first pandemic-related mission undertaken by the DFA.

In addition to its services on the ground, active involvement in policy discussions in international fora including the Global Forum on Migration and Development (GFMD) was high on the DFA's agenda with interventions conveyed at regional and multilateral for a such as the Bali Process, the Asia-Europe Meeting (ASEM), ASEAN, and in high-level events organized at both the UN Headquarters in Geneva and New York.

#### UTILIZATION OF THE ATN FUND AND LAF

The DFA continued to provide immediate ATN and legal assistance to Filipino nationals abroad through the utilization of the Assistance-to-Nationals (ATN) Fund and Legal Assistance Fund (LAF).

In 2015, PHP 299,067,558.58 out of the total 2015 ATN budget of PHP 301 million was utilized from the ATN Fund to provide temporary shelter, basic necessities, emergency medical treatment, repatriation, and other immediate ATN services to Filipino nationals. This represents a utilization rate of 99.32%.

Meanwhile, PHP 148,784,391.91 was utilized from the 2015 LAF budget of PHP 100,051,893.79 and PHP48,900,000.00 realigned from the ATN budget,



PHP48,900,000.00 realigned from the ATN budget, for the hiring of lawyers, obtaining legal retainers and other legal services for Filipinos facing legal problems abroad, representing a utilization rate of 99.89%.

In the spirit of the Christmas season and as regular assistance provided by the DFA to Filipino detainees in foreign jails and Filipino wards sheltered in all Filipino Workers Resource Centers (FWRC), a token financial assistance was given to them from the ATN Funds to allow them to purchase basic necessities.

## MARY JANE VELOSO CASE

As a reflection of continued government efforts to obtain relief for overseas Filipinos in distress, the situation of Mary Jane Veloso mirrored the positive dividends derived from diplomatic efforts – a combination of high level interaction and quiet diplomacy. Her last minute reprieve from the death sentence meted by the Indonesian courts allowed both the Philippine and Indonesian governments to uncover the syndicate behind her predicament. The DFA's coordination with DOJ made possible

the prosecution of identified suspects which may prove that Mary Jane Veloso is a victim rather than a member of a drug smuggling syndicate.

At the end of November 2015, a total of 27,145 Filipinos were assisted through ATN Funding, including walk-ins, referrals, and those who availed of the government's Mass Repatriation Program (MRP). More than 800 Filipinos were also provided with lawyers and other legal services through the LAF.

In 2015, a total of 10,145 walk-in clients and referrals sought legal assistance from the DFA Home Office on behalf of their family members or relatives who were in distress while working or travelling overseas.

#### MIGRATION AND DEVELOPMENT

#### • Global Forum on Migration and Development

As focal person for the GFMD, Undersecretary for Migrant Workers' Affairs Jesus I. Yabes led the Philippine Delegation to the GFMD Conference held in Istanbul, Turkey from 12 to 16 October 2015. The Philippines co-chaired one of the three round-table discussions at the Istanbul Conference.

#### • Joint Manual of Operations

On the provision of ATN to Overseas Filipinos in distress, the DFA took the lead in finalizing the Joint Manual of Operations adopted by

The Philippine Embassy in Riyadh, through the assistance of the Philippine Honorary Consulate in Sana'a, Yemen, evacuated 626 Filipinos out of a total of 1,078 registered Filipino the commencement of 'Operation Decisive Storm,' the Saudi-led intervention in Yemen in March 2015 aimed at restoring its central government from rebel Houthi forces. Embassy officials, led by Ambassador Ezzedin H. Tago, were on the ground in Sana'a to repatriate Filipinos.

DFA, Department of Labor and Employment (DOLE), Department of Health (DOH), Philippine Overseas Employment Administration (POEA), and Overseas Workers' Welfare Administration (OWWA) to harmonize their individual operations manual to ensure prompt and efficient delivery of ATN services to Overseas Filipinos. The Manual was signed by the principals of the concerned agencies last August 2015.

## TRAFFICKING IN PERSONS

The DFA assisted a total of 318 victims of trafficking in persons in 2015. Of this number, 170 were trafficked to the Middle East, most of whom end up as household service workers who experience maltreatment and other forms of labor exploitation; 107 were trafficked to the Asia and the Pacific Region, 12 to Europe and 29 to the Americas.

In an effort to build the capacity and raise the awareness of Foreign Service Personnel, the DFA conducted a series of Regional Workshops on Anti-Trafficking in Persons in

September 2014), Asia Pacific (Osaka, Japan; 11-15 December 2014), Europe (Vienna, Austria; 16-20 March 2015). The last leg of the workshop was held in Tagaytay City from 06 to 07 June 2015 for the Home-Based Personnel. The workshops were held in partnership with the United Nations Office on Drugs and Crime (UNODC), International Organization for Migration (IOM), Department of Social Welfare and Development (DSWD), Department of Justice (DOJ), and the Department of Labor and Employment (DOLE). Representatives from the US Embassy, Australian Embassy, and the host governments also participated in the workshops as resource speakers.

#### **REPATRIATION EFFORTS IN LIBYA**

Libya remained under Alert Level 4 (Evacuation/Mandatory Repatriation Phase). The Philippine Embassy in Tripoli continued to monitor the political and security situation in Libya to ensure the safety of the Filipinos still remaining in the country. A Rapid Response Team was deployed to assist Tripoli PE's Crisis Management Team in the evacuation and repatriation efforts of the Philippine government. The DFA continued to enjoin Filipinos in Libya to come home at the Philippine government's expense under the Mandatory Repatriation Program (MRP).

Since 2011, a total of 15,661 OFWs had been successfully repatriated through the Department's efforts. In 2015 alone, 5,524 OFWs were repatriated. As of 01 November 2015, an estimated 3,030 OFWs remain in Libya.




# FAST, ACCESSIBLE, CITIZEN-ORIENTED AND EFFICIENT DELIVERY OF CONSULAR SERVICES FOR FILIPINOS

The DFA exerted efforts to provide efficient, prompt and responsive frontline services to all Filipinos. The enhancements to the ePassport system, increase of overseas registered voters for the 2016 National Elections and, in general, the modernization of our consular services and systems, are all a part of its efforts to achieve said goal. The DFA aimed at sustaining these improvements for the provision of more efficient and people-friendly consular services and assistance for our nationals abroad and, wherever appropriate, here in the Philippines.

The year 2015 is particularly marked by critical steps taken by the DFA in pursuing its goal of delivering fast, accessible, citizen-oriented, and efficient consular services. Of significance is the forging of partnerships with government and private institutions to undertake projects that would enhance consular services, to wit:

- Upgrading of the new ePassport system with the APO Production Unit Inc.;
- Adoption of a database management and e-registry system for authentication services, that would lead to Philippine accession to the Apostille Convention; and
- Opening of additional mall-based Regional Consular Offices (RCOs) to bring services closer to the public.

The DFA conducted the Year-End Monitoring/Inspection Visit to 14 out of 21 RCOs in December 2015. The general objective of the Monitoring/Inspection Teams was to assess the performance of the RCOs according to the Quality Management System (QMS) Framework, which is comprehensive in scope and is a program in itself requiring follow-up activities. The teams discussed the ISO 9001:2008 QMS and Customer Service, in preparation for the ISO Certification of the DFA's Authentication Division.

#### A. Regional Consular Offices (RCOs)/Satellite Offices (SOs)

In 2015, the DFA opened RCOs in Calasiao, Pangasinan (16 November 2015) and Dumaguete City (22 November 2015).



#### **B.** Passport Services

In 2015, the DFA issued a total of 3,052,324 passports. A total of 70 Mobile Passport Services (MPS) missions were conducted in various cities, municipalities, and provinces in the country, benefitting more than 30,000 Filipinos.

APO Production Unit, Inc., one of the three recognized government printers under the Presidential Communications Operations Office (PCOO), and the DFA signed a Service Level Agreement (SLA) for the Personalization, Maintenance, and Repair Services for the Existing Electronic Passport System.

Led by President Aquino, the Inaugural Marker of APO Production Unit's High Security Plant in LIMA Technology Center, Malvar, Batangas was unveiled on 20 July 2015 by several local and national government officials. The capacity of the new ePassport system was demonstrated through combined on-site and off-site, end-to-end processing of commemorative ePassports.

On 20 August 2015, the ePassport Personalization site was transferred from the Bangko Sentral ng Pilipinas (BSP) to APO Production Unit's secure facility in Batangas.

The DFA signed a Memorandum of Agreement (MOA) with APO Production Unit, Inc. on 05 October 2015 designating APO Production Unit as the new partner of the DFA in printing electronic passports from 2016 to 2026.

#### C. Other Services

#### VISA SERVICES

In 2015, the DFA issued a total of 337,648 visas.

The Visa Division is the Philippine Desk for APEC Business Travel Card (ABTC) matters and manages the day-to-day operations of ABTC-Philippines. The DFA issued a total of 452 ABTCs, as of October.

In July 2015, the DFA launched the new Philippine Machine Readable Visa (MRV) Sticker. The new visa stickers comply with the specifications unique to Format-B machine readable visas (MRV-B).

#### DUAL CITIZENSHIP

In 2015, the DFA transmitted a total of 18,090 approved applications for dual citizenship to the Bureau of Immigration.

The DFA acted as Co-Chair of the Inter-Agency Working Group on the "Assessment/ Review of the IRR for RA 9225", and in the process formulated 64 legal opinions and/or referrals to the DOJ on different aspects of RA 9225, to address various queries from FSPs.

In 2015, the DFA processed a total of 859,438 authentication certificates at DFA-OCA ASEANA, SOs, and RCO Pampanga.

On 20 February 2015, the Document Management System (DMS) and e-Registry was rolled out. The DMS, a software solution co-developed by the DFA and APO Production Unit, will standardize and streamline the current authentication back-end processes. On the other hand, the e-Registry System is a database of specimen signatures and issued Authentication Certificates. This database will ensure more efficient authentication of documents and verification of issued Authentication Certificates.

To develop and tap local expertise to produce eyelet riveters, the DFA signed a MOA for the Joint Research Project for the Prototyping and Pilot Production of Eyelet Riveters for the DFA's Authentication Certificates with the Metals Industry Research and Development Center of the Department of Science and Technology (DOST-MIRDC) on 27 April 2015. Eyelet riveters bind Authentication Certificates and its underlying documents to ensure the integrity and security of a public document authenticated by the DFA.

The DFA and APO Production Unit signed a MOA for the Printing of Authentication Certificates on 13 October 2015. The security features of these authentication certificates will make official Philippine documents more acceptable in foreign countries, impacting employment, trade, justice, and private concerns.



During the registration period for the 2016 National Elections, there was a total of 826,880 newly-registered Overseas Filipino voters. This was attained through partnerships with TV and media outlets, the implementation of iREHISTRO, an internet-based voter registration system developed by COMELEC, and by operationalizing the Overseas Voter Registration Centers (OVRC) in RCOs and SOs.

The figure is 105% of the FSPs total target of 788,887. It is also 107% over the previous registration period's total of 398,108 new overseas registered voters. After deactivating 163,019 overseas voters who have failed to vote in the last two (2) consecutive elections, and the filtering of double

registrants, the 2016 national elections will have 1,401,620 overseas registered voters who are qualified to vote. This is the first time that there are over one million overseas voters who can cast their votes in a national election.

The DFA negotiated and signed four (4) partnership agreements with the following TV and media outlets: (1) ABS-CBN in support to their coverage/campaign and other related activities for the 2016 Presidential Elections "Halalan 2016: IPANALO ANG PAMILYANG PILIPINO"; (2) UBE Media and Air 21; (3) ABS-CBN's The Filipino Channel (TFC); and (4) TV5 International. The said partnerships enhanced awareness for overseas voter registration procedures and systems as well as stressed the importance of empowering Filipinos. As a result, an effective omni-media overseas registration campaign was conducted at no cost to the DFA.

The iREHISTRO program was implemented in 77 FSPs. The DFA conducted regional onsite trainings in Abu Dhabi (22-23 April), Madrid (28-29 April), San Francisco (28-29 April), and Macau (28-30 May). The iREHISTRO was recognized by the Civil Service Commission with the 2015 CSC Pag-Asa Awards. In addition, 102 new Voter Registration Machines (VRMs), including peripherals, were distributed to various FSPs.

#### **OTHER ACTIVITIES**

In order to update the capabilities of Foreign Service personnel, the DFA conducted a Consular Retooling Seminar in Dubai, UAE from 07 to 11 January 2015. The latest regulations and guidelines on visas, ePassports, authentication, immigration regulations, and civil registry matters were discussed. The DFA also conducted an Orientation Workshop on Public Key Infrastructure (PKI) on 20 February 2015 at OCA for DFA personnel. PKI is one of the services being offered by the Integrated Government Philippines (iGovPhil) Project. It aims to improve processes in government to provide better services to both citizens and businesses, as well as promote public participation.

The DFA adopted a number of institutional reforms and organizational adjustments in its continuing efforts to improve the quality and efficiency of public service delivery and transform the DFA into an efficient and results-oriented organization. These reforms cover the areas of procurement, QMS, and the rationalization of the DFA's organizational set-up and processes.

#### A. HUMAN RESOURCES

The DFA has 2,239 regular employees. 906 are based in the Philippines (Home Office, RCOs, SOs), and 1,333 are assigned abroad.

The DFA has 853 casuals, contractual, and COS personnel of which 667 are in the Home Office, and 186 in the RCOs and SOs.

In the FSPs, the DFA has 493 locally hired personnel.

In 2015, the DFA finalized and rolled out the Customized Gender Sensitivity Training (GST) Manual for DFA personnel. In line with the DFA's commitment to Gender and Development (GAD) initiatives and the continuous capacity-building for a gender-sensitive personnel, the series of customized GST were facilitated by GAD advocates and a core group of 24 gender focal persons (GFP) who underwent Trainer's Training for the roll-out of the GST Manual.

The DFA conducted 19 GSTs; three (3) for the Home Office, 12 for RCOs, and four (4) Regional Seminars in Berlin, Chicago, Jakarta, and Manama. There was a total of 355 participants.

#### • Foreign Language Program

The Foreign Service Institute (FSI) offered the Foreign Language program to personnel at the Home Office. 73 personnel completed the program. 17 FSPs implemented similar programs.

#### • **PRAISE 2015**

On 04 September 2015, the following Departmental Level Awards were conferred upon personnel recommended by the Program on Rewards, Awards and Incentive for Service Excellence (PRAISE) Committee:

- Felipe Agoncillo Distinguished Service Award to 6 retired Chiefs of Mission;
- Outstanding Employee Award to 56 personnel from various Offices and FSPs;
- Assistance-to-Nationals Award to 1 FSP and 16 individuals; and,
- Loyalty Award to 359 DFA personnel, 54 local hires, and 8 Honorary Consuls.

#### • Trainings/Seminars

The DFA conducted 22 trainings/courses related to Career Development and skills training of personnel with a total number of 538 participants from various offices.

#### **B. FINANCE**

#### • Trainings/Seminars

To keep DFA personnel attuned to the provisions of the Government Procurement Act, it continued holding training courses on procurement. These courses were designed to help DFA personnel become better informed of the intricacies of government procurement regulations. A total of six (6) training courses and briefing sessions on procurement were held in 2015.

The Bids and Awards Committee (BAC) also had several briefings/dialogues with relevant DFA personnel and offices to address the issues and problems relevant to the government procurement. BAC is in the process of streamlining the procurement process of the DFA, especially for FSPs.

#### • Budget

The DFA secured a 59% increase in its budget for FY 2016 to allow the DFA to undertake important projects such as the new ePassport System, retrofitting of the old DFA Building, preparatory activities for the 2017 ASEAN Summit in Manila, Building Fund, among others.

In 2015, the DFA disbursed PHP 1.28 billion, or 82%, from its Building Fund, a significant increase from the previous year's utilization. The DFA's Building Fund, which was equivalent to 20% of its consular income for 2013, was used in the acquisition of chanceries in Phnom Penh and Berlin and the renovation of chanceries and buildings in Agana, Islamabad, New York, Riyadh, Singapore, Washington D.C., and Wellington.

#### • Foreign Service Allowances and Other Entitlements

In order to provide personnel assigned abroad with adequate means to enable them to represent the country with distinction and dignity, the DFA in 2015 undertook an extensive study and data gathering in setting the parameters and adjusting the rates of the allowances of Foreign Service personnel.

Department Orders and Foreign Service Circulars were either issued or amended resulting in increases in benefits and entitlements of DFA personnel such as:

- 1. Increase in excess baggage allowances entitlement from 40 lbs (18.14 kgs) to 110 lbs (50 kgs) per person;
- 2. Increase in the Home Adjustment Allowance;
- 3. Increase in the Hotel Allowance from 7 to 15 days for those to be assigned abroad; and,
- 4. 100% receipt of Performance Enhancement Initiative (PEI) bonus because the DFA was able to accomplish its target of 90% utilization of its budget for FY 2014.

#### • Reforms in Financial Management Service

- 1. Implementation of the enhanced electronic National Government Accounting System (e-NGAS);
- 2. Implementation of both manual and electronic tracking system of documents (i.e., Disbursement Vouchers (DVs), Obligation Requests (ObRs);
- 3. On-going reconciliation of GSIS contributions of DFA employees; and
- 4. Proposed Cashiering System in the Authentication Division, OCA

#### C. SYSTEMS AND PROCESSES

#### • Institutional Strengthening and Productivity Improvement

The Department of Budget and Management (DBM) approved Phase 1 of the DFA's Institutional Strengthening and Productivity Improvement (ISPI) initiative. Phase 1 of ISPI aims to strengthen the DFA's focus on its vital and core functions.

Under Phase 1, three (3) new offices were created, namely: the Office of Assets Management and Support Services (OAMSS), the Maritime and Ocean Affairs Office (MOAO), and the Office of Public Diplomacy (OPD). In addition, the Office of Personnel and Administrative Services (OPAS) was renamed the Human Resource Management Office (HRMO) and the Office of Strategic Planning and Policy Coordination (OSPPC) was renamed the Office of Policy Planning and Coordination (OPPC).

# • Signing of the Joint Circular on the Guidelines on the Foreign Assignment of Representatives of Partner Agencies

The Joint Circular established Guidelines on the Assignment of Representatives of Partner Agencies to FSPs pursuant to the relevant provisions of RA 7157 or "The Philippine Foreign Service Act" and Executive Order No. 74, Series of 1993, or "The One Country Team Approach." It aims to:

- 1. Provide uniform rules and regulations on the assignment at FSPs of officers and employees of Partner Agencies;
- 2. Strengthen cordial and productive interaction among officers and employees of the Philippine Government assigned at FSPs; and,
- 3. Ensure compliance with applicable Philippine and host country laws, rules and regulations by all officers and employees of the Philippine Government assigned at FSPs.

#### • Internal Control System

The DFA conducted compliance and management audit in four (4) FSPs and seven (7) RCOs, as well as follow-up of audits of five (5) FSPs, and nine (9) RCOs.

The audits determined the degree of compliance with existing laws, rules, and regulations, and evaluated the existence and effectiveness of internal controls on Passport and Notarial Services, Collections and Deposits, Administrative Management, and Property and Inventory Management.

To better enhance and develop effective and efficient internal controls in the bureaucracy, the DFA organized two (2) seminars attended by 95 participants. Deputy Executive Secretary for Internal Audit Alberto A. Bernardo of the Internal Audit Office in the Office of the President conducted the seminars on Internal Control System for Top Management, Middle Management, and Accountable Officers.

#### • Quality Management System (QMS)

The DFA created awareness among its employees on the QMS and formed the DFA QMS Core Team. The goal is to establish an ISO 9001:2008 certifiable QMS in the DFA's Authentication Division by 2016.

To develop the capacities of the DFA Core Team, the Development Academy of the Philippines (DAP) conducted technical guidance workshops and sessions. These workshops resulted in the drafting of a DFA Quality Manual, Quality Policy, and the mandatory QMS procedures which are the building blocks for QMS implementation.

#### **D. INFRASTRUCTURE**

#### • Quality Management System (QMS)

The DFA started the Architectural and Engineering Design Phase in July 2015 and completed the Schematic Design in October 2015. The second phase is expected to be completed in March 2016.

#### • Inventory

The DFA completed the Actual Physical Inventory-taking of all its owned properties in September 2015.

#### FOREIGN AFFAIRS SECRETARY ALBERT F. DEL ROSARIO: Staunch Advocate of a Principled Philippine Foreign Policy

#### Personal

The Honorable Albert F. del Rosario was born in Manila on November 14, 1939 and has worked for both the private sector and government. He attended Xavier High School in New York City and subsequently graduated from New York University with a Bachelor of Science Degree in Economics. Secretary del Rosario is married to Gretchen de Venecia. They have five children and six grandchildren.

#### Impact on Public Welfare and National Development

As Philippine Ambassador to the United States of America (2001-2006):

As Philippine Ambassador to the U.S.A., he was instrumental in securing US\$1.2 Billion U.S. funding assistance for the Philippines; achieved reciprocal State Visits within the period of six (6) months in 2003; obtaining bilateral cooperation in counter terrorism and peace and development in Mindanao; realizing investments in the country's Business Process Outsourcing (BPO) industry; and acquiring greater access for Philippine exports. His enduring legacy which continues to benefit the Philippines includes a first-time formation of the Philippines-US Friendship Caucus composed of over 80 legislators from the US House of Representatives; successfully launching an unprecedented challenge to the decision of the California Public Employees Retirement System (CalPERS), to remove the Philippines' Modernization Program (AFPMP) by negotiating major Excess Defense Articles (EDA); worked for the Philippines' designation as a Major Non-NATO Ally (MNNA); successfully lobbied before the U.S. Congress not to prejudice the Philippine canned tuna industry as a result of a preferential treatment for Andean countries; undertook efforts to realize major benefits for Filipino and Filipino-American veterans; and pioneered both the Ambassadors/ Consuls General Tour (ACGT) of the Philippines, and the *Bayan Ko-Bahay Ko* Program.

In end of August 2006, Ambassador del Rosario preferred to be removed from the Philippine Foreign Service rather than agree to support the incumbent administration's request for his support on their plans to lift the writ of *habeas corpus* and initiate an emergency rule.

As Secretary of Foreign Affairs (February 24, 2011 - present):

When the Secretary entered the Department, he had a clear vision in mind for the organization – to maximize its potentials and transform it into a strong, professional, and high performing organization with members who are not only the best and the brightest, but also with the highest degree of commitment to serve the country and the Filipino people.

The SFA has embarked on and continues to pursue a carefully thought-out DFA transformation program, namely:

Restoring morale by limiting the number of political appointees;

- Upgrading economic diplomacy skills through a partnership with AIM;
- Placing merit over seniority in the career advancement process;
- Rationalizing PH presence overseas resulting in the closure of ten (10) Foreign Service posts and reallocating resources where these are most needed;
- Bringing cost-effective consular services closer to the people by moving DFA offices to malls such as Ayala, Gaisano, Robinsons, SM, and Ali Mall;
- Developing effective strategies to negotiate and assert the rightful position of the Philippines in the community of nations;
- Submitted and awaiting the President's approval of a new scheme for the Non-Resident Ambassadors

(NRAs) to cover Africa and Central America; and

- Strongly encouraging all foreign service personnel to reach beyond their grasp, at all times, to promote the national interest.
- Emphasizing the management approach of leadership by example; and
- Embarking on 151 Official Missions over five (5) years to advance the three (3) Foreign Policy Pillars of the Philippines.

Under the Secretary's leadership, the DFA has consistently ranked as one of the top government agencies in terms of efficiency and effectiveness, in surveys conducted by the Social Weather Stations (SWS) and the Makati Business Club (MBC).

Under the Secretary's leadership, the DFA has consistently ranked as one of the top government agencies, in terms of efficiency and effectiveness, in surveys conducted by the Social Weather Stations (SWS) and the Makati Business Club (MBC).

In the SWS' December 2015 survey results on the Aquino administration's performance, four (4) out of 14 issues received the highest grade of "GOOD." These are: "Helping the poor;" "Foreign relations;" "Promoting the welfare of OFWs;" and "Protecting the country's territorial rights." The DFA was directly responsible for delivering three (3) of the top 4 (four) issues. On "Helping the poor", DFA's efforts have also directly and indirectly contributed by increasing to record-levels the Official Development Assistance or ODAs to the Philippines.

For the MBC survey for the Top 10 Government Agencies in the last three (3) years, DFA's ranking has improved from 11th spot in 2012 (no 2013 rankings), to #6 in 2014 and ranked #4 in 2015.

### Impact on Professional Field

In accordance with President Benigno S. Aquino III's directives, Secretary del Rosario has pursued a Philippine Foreign Policy that is independent, principled, and based on the rule of law; standing firmly in promoting and defending the Philippine national interest in the global arena.

Through his dynamic interactions with his counterparts, the Secretary was able to enhance the Philippines' bilateral relationships and partnerships with international institutions. He has done so by steadfastly articulating Philippine interests and initiatives ranging from maritime security to economic cooperation, from counter-terrorism to people-to-people exchanges.

The Secretary has staunchly defended the sovereignty and territorial integrity of the country, raised the standards of economic diplomacy as a tool of statecraft and proactively ensured the safety and security of overseas Filipinos everywhere.

With President Aquino's guidance, the Secretary has provided leadership in the following major Philippine advocacies and priorities: signing of Agreement between the Republic of the Philippines and the Republic of Indonesia Concerning Delimitation of the Exclusive Economic Zone Boundary on 23 May 2014, successful hosting of the 2015 APEC Economic Leaders' Meeting (AELM) in November 2015, the launch of the ASEAN Community in December 2015, the Supreme Court's favorable decision on the PH-US Enhanced Defense Cooperation Agreement (EDCA) and the Philippines' arbitration case before the Permanent Court of Arbitration in The Hague.

Other milestones in international diplomacy actively led by Secretary Del Rosario include the broadening and deepening of Philippine bilateral relations with valued partners through the signing of cooperation agreements, namely, Philippines-Japan Joint Declaration on a Strengthened Strategic Partnership, Joint Declaration on Philippines-Australia Comprehensive Partnership, and Joint Statement on the Establishment of a Philippines-Viet Nam Strategic Partnership.

In 2015, the Philippines signed 58 economic agreements covering labor, trade, education, and air services.

Under the guidance of President Aquino, since 2011 the Philippines has repatriated 24,000 Filipinos from countries torn by civil strife and devastated by natural disasters. From February 2011 to 2015, DFA extended assistance to over 80,000 Overseas Filipinos and members of their families.

In other frontline services, the DFA established more efficient and streamlined electronic passport processing facilities in cooperation with partner agencies such as the APO Production Unit, Inc., while our 21 Regional Consular Offices and 5 Satellite Consular Offices make our services more accessible to the general public.

Since 2011, Secretary del Rosario has conducted 151 Official Missions in almost 50 countries for the purpose of negotiating and asserting the rightful place of the Philippines in the international community.

Mount Saint Vincent College, based in New York City, conferred a Doctor of Laws degree (Honoris Causa) on Secretary Albert F. del Rosario in recognition of his "principled commitment to democracy, integrity, and the rule of law both at home and around the globe."

"Albert del Rosario, as Secretary of Foreign Affairs, you are celebrated for fulfilling President Aquino's vision both within the Department of Foreign Affairs and in relations with other nations... And with your leadership, the Department now seeks the peaceful, legal resolution of territorial disputes in the South China Sea—one of the world's most perilous and potentially consequential international conflicts," read Charles L. Flynn, President of 'The Mount, who conferred the degree upon Secretary del Rosario.

The Secretary said that the Department of Foreign Affairs shares The Mount's commitment to institutional integrity and commitment. "I consider the honor bestowed on me today as recognition also for the hardworking men and women of the Philippine Foreign Service," he said.

After the conferment of the Honorary Degree, Secretary del Rosario discussed in his remarks key Philippine Foreign Policy advocacies such as migration governance, the Philippines-US alliance, the South China Sea, and the future of Philippine Foreign Policy.

Founded in 1847 by the Sisters of Charity as the first institution to offer higher learning for women in New York, the Academy of Mount Saint Vincent's Charter was amended in 1911 to become the College of Mount Saint Vincent, which, in 1974, became a co-ed institution.

"The Honorary Doctor of Laws that the Mount Saint Vincent has conferred upon me will always be my treasure as well as my inspiration," the Secretary stated at the conclusion of his acceptance speech.
