

## INVITATION TO BID FOR THE PROCUREMENT OF LEASE OF MOTOR VEHICLES

1. The Department of Foreign Affairs, through the authorized appropriations under the General Appropriations Act for year 2018, intends to apply the sum of Twenty-Four Million Three Hundred Sixty Thousand Nine Hundred Ninety-Six Pesos (PhP 24,360,996.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Lease of Motor Vehicles. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Department of Foreign Affairs now invites bids for the “Procurement of Lease of Motor Vehicles”, described as follows”

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
  - (i) Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
4. Interested bidders may obtain further information from the Department of Foreign Affairs and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on 27 April 2018 from the address below.  
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
