

INVITATION TO BID FOR THE PROCUREMENT OF COMMON AND NON-COMMON OFFICE SUPPLIES, EQUIPMENT AND PARAPHERNALIA FOR THE DFA MAIN BUILDING AND DFA-ASEANA FOR 2018

1. The Department of Foreign Affairs, through the authorized appropriations under the General Appropriations Act for year 2018, intends to apply the sum Three Million Six Hundred Forty-One Thousand Seven Hundred Forty-Five Pesos and Ninety-Eight Centavos (PhP 3,641,745.98) only being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Common and Non-Common Office Supplies, Equipment and Paraphernalia for the DFA Main Building and DFA-ASEANA for 2018. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Department of Foreign Affairs now invites bids for the “Procurement of Common and Non-Common Office Supplies, Equipment and Paraphernalia for the DFA Main Building and DFA-ASEANA for 2018”, described as follows”

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
4. Interested bidders may obtain further information from the Department of Foreign Affairs and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on 26 September 2018 from the address below.
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
