EXECUTIVE SUMMARY

In 2017, the Department of Foreign Affairs (DFA) actively led national efforts to advance Philippine interests in the global arena, as directed by President Rodrigo Duterte, the country's chief foreign policy architect.

With one of the most professional and dedicated workforces in the government, the DFA worked relentlessly to fulfill its mandate to pursue an independent foreign policy that is responsive to the demands of national development and the challenges presented by a rapidly changing global environment.

The year saw a leadership change at the DFA. In May, Foreign Affairs Secretary Alan Peter S. Cayetano took over the helm of the Department from former Foreign Affairs Secretary Perfecto R. Yasay, Jr., with Undersecretary for Policy Enrique A. Manalo easing the transition as Acting Secretary in between.

Building on past gains, Secretary Cayetano led the Department in harnessing the country's network of strategic international linkages to contribute to domestic growth and bring it closer to the national vision of a "strongly rooted, comfortable, and secure life" for the Filipino people by 2040.

In this mission, new partnerships were forged. The thrust was to "build, bridge and build" friendships and understanding, consistent with the Administration's foreign policy strategy of being a friend to all and enemy to none.

In the year, the DFA was also active at the regional and multilateral fronts to enhance international understanding of the country's development imperatives. It actively promoted cooperation on key advocacies, which include the protection of its maritime sovereign interests, countering terrorism and violent extremism, curbing human trafficking, migration and development, and the promotion of micro, small, and medium-sized enterprises.

Overall, the three pillars of Philippine foreign policy-- national security, economic diplomacy, and promoting the welfare and protecting the rights of our overseas Filipinos—remain as the DFA's top work priorities. In fulfilling this mandate, the Department pursued an independent foreign policy that is, to quote Secretary Cayetano, "patient, prudent and purpose-driven, with the Filipino people at its center."

Some of the highlights of the DFA's accomplishments in 2017 were as follows:

PHILIPPINES AS 2017 ASEAN CHAIR

In 2017, the country's foreign policy directions were best articulated in the Philippines' role as ASEAN Chair during the regional organization's 50th foundation anniversary year, with the theme, *"Partnering for Change, Engaging the World."*

The Philippines' chairmanship of the Association throughout the year was widely lauded as it helped the Association to move forward on various initiatives and action points to realize the ASEAN Community Vision 2025.

The outcome documents from the Philippines' chairmanship committed ASEAN to six priorities which will improve the lives of Filipinos and the rest of the ASEAN peoples. The Philippines together with the rest of ASEAN bound themselves to conduct activities and craft work plans towards the following:

- 1. A People-Oriented and People-Centered ASEAN, which will prioritize the health and nutrition of its citizens, the social protection of the vulnerable including migrant workers, and ensuring that they will not be exploited or mistreated.
- 2. Peace and Stability in the region, where ASEAN will work together to stop the proliferation of illegal drugs and counter terrorism that destroys lives.
- 3. Maritime Security and Cooperation, to ensure that we protect our seas and our fishermen who depend on it for livelihood.
- 4. Inclusive, Innovation-led Growth, helping people become successful entrepreneurs especially in micro, small, or medium enterprises.
- 5. A Resilient ASEAN, to boost the region's capability to respond to storms, droughts, and other natural catastrophes and be adaptable to climate change.
- 6. ASEAN as a Model of Regionalism and a Global Player, to strengthen ASEAN unity so as to effectively address critical issues that challenge our desire for better lives for our citizens.

The Philippines hosted a total of 141 meetings during its ASEAN Chairmanship: two Summits, 19 Ministerial Meetings, 42 Senior Officials' Meetings, and 78 Technical Working Group Meetings. A total of 56 outcome documents were noted, issued, adopted and signed throughout the year. Most noteworthy is the "ASEAN Consensus on the Protection and Promotion of the Rights of Migrant Workers" signed by the ASEAN Leaders at the 31st ASEAN Summit held in Manila on 14 November, a landmark document that aims to develop an instrument that will establish a framework for cooperation in safeguarding the interests and welfare of the thousands of migrant workers in the region.

BUILD, BRIDGE, BUILD — ENHANCING BILATERAL RELATIONSHIPS

Consistent with the foreign policy strategy of the President to be "a friend to all and enemy to none", steps were taken to fortify relations with traditional allies, as well as to revitalize and forge greater exchanges with non-traditional partners.

Friendly, cooperative, and mutually beneficial ties with all nations were endeavored, guided by the principle that in a globalized and interdependent world, the country's strength and standing can be enhanced greatly by partnerships built on the basis of mutual respect and benefit. The momentum of high-level exchanges between the Philippines and China continued in the year with President Duterte hosting Chinese Premier Li Keqiang during the latter's official visit to the Philippines in November. Agreements on infrastructure projects, finance, and economic and technical cooperation were signed during the visit.

Earlier, in January, the President also hosted Japanese Prime Minister Shinzo Abe for a two-day official visit, which also saw the signing of agreements on infrastructure and defense projects.

Meanwhile, President Duterte and US President Trump reaffirmed their commitment to the long-standing defense alliance between the Philippines and the US. Cooperation focused on counter-terrorism assistance from the US, the rehabilitation of Marawi, and assistance on addressing illegal drug demand reduction.

The Philippines also actively engaged Russia, with President Duterte undertaking an official visit and meeting with Russian President Vladimir Putin. During the visit, eleven agreements were signed in the fields of defense cooperation, tourism, agriculture, trade and industry, energy, transportation, and culture and the arts. President Duterte also met with Russian Prime Minister Dmitry Medvedev in Manila, where they witnessed the signing of nine more agreements in the areas of security, energy, mass communication, intellectual property, and education. An inaugural meeting of the Joint Working Group on Defense Cooperation was also held between the Philippines and Russia in 2017.

With the Gulf States continuing to be a top destination for overseas Filipinos, President Duterte engaged the leaders of Bahrain, Qatar, and Saudi Arabia during his state visits in 2017, where focus was given to labor cooperation and investment promotion.

Building on the Trilateral Cooperative Agreement signed among the Philippines, Indonesia and Malaysia in July 2016 to conduct maritime patrol, enhance intelligence and information exchange and maintain a hotline among respective command centers, the DFA continued to facilitate efforts to strengthen cooperation and coordination with Indonesia and Malaysia to address common threats of terrorism and violent extremism confronting the region.

TOWARDS A FAST, EFFECTIVE AND SECURE PASSPORTING SYSTEM

A core part of the DFA's operations is the provision of consular services to its nationals, particularly the issuance of passports, considered the most important security document for Filipino citizens.

To better provide the Filipino people a fast, effective, and secure passporting system, the DFA undertook several measures to improve its services in the year, foremost of which was the amendment of the 1996 Passport Law extending the validity of the Philippine passport from five to 10 years. The new law, Republic Act No. 10928 (2017) otherwise known as "An Act Extending the Validity of Philippine Passports", was signed on 02 August 2017.

To enhance passport production capacity and improve access of Filipinos to consular services, on 20 October 2017, the President also signed Executive Order No. 45, "Providing for the Reorganization of the Field Offices of the Office of Consular Affairs of the Department of Foreign Affairs", which provides a legal basis for DFA to open additional Consular Offices all over the country.

Overview

In 2017, passport issuances increased an annual 19.38% to 3,712,920.

PROTECTING FILIPINOS ABROAD: MORE EFFECTIVE ASSISTANCE TO NATIONALS SERVICES

The third pillar of Philippine foreign policy is the promotion and protection of the rights and interests of Filipinos working abroad to provide a comfortable life for their families at home.

During the year, the DFA provided various forms of assistance to a total of 27,871 overseas Filipinos (OFs), with 15,282 OFs as beneficiaries of the Assistance to Nationals (ATN) Fund and 744 OFs as beneficiaries of the Legal Assistance Fund (LAF).

Seeing the necessity to have more funds and flexibility to assist as many OFs in distress as possible, the Department worked to secure Congressional approval to increase the ATN Fund from P400 million to P1 billion and the LAF from P100 million to P200 million for 2018.

Following this development, Secretary Cayetano signed new guidelines on the use of both the ATN Fund and the LAF on 18 December 2017. With the new rules, the DFA is now in a position to more effectively respond to the growing number of distressed Filipinos abroad. The rules expand the scope of the services covered and allow more flexibility in the disbursement of the funds, thereby enabling the DFA to be more responsive to the needs of distressed Filipinos abroad.

The LAF may be availed of by a distressed overseas Filipino who is unable to engage the services of private counsel, and who is in a country where there is no system of legal aid or public defenders, or where there is no access to counsel de officio, or any lawyer provided by the foreign host government.

The ATN Fund, on the other hand, shall be used to cover welfare assistance, and repatriation for distressed Filipinos abroad, including those sick and deceased. These now include door-to-door repatriation from the host country to the actual residence in the Philippines, and in case of death, the cost of cremation or embalming and transport of remains to the final destination in the Philippines, with assistance on burial costs.

Under the new guidelines, the DFA will not only provide care packages and basic supplies for Filipinos on death row or serving life sentences abroad but will also shoulder the cost of compassionate visits by their next of kin to the country of incarceration. This also covers Filipinos with life-threatening illnesses abroad.

The ATN Fund shall also be utilized to cover: the cost of medical services and hospitalization for emergency treatments; the opening and maintenance of shelters for distressed Filipinos; the establishment of a 24/7 communications and operations center in the Philippines and abroad; paralegal, security and other training for ATN personnel; and the establishment of an online ATN Case Management System to facilitate case retrieval and direct access to ATN cases and the development of mobile applications.

PH IN APEC 2017: VISION OF MEANINGFUL GLOBALIZATION

At the APEC in 2017, the Philippines made a strong pitch for an inclusive economic and business agenda, underscoring that the 21st century global economic agenda should help those who have been left behind by globalization.

The 25th APEC Economic Leaders Meeting in Vietnam in 2017 adopted a Leaders' Declaration that was of special significance to the Philippines, given the focus on micro-, small-, and medium-sized enterprises (MSMEs).

This was a sector the Philippines advocated through several Chairmanships, especially in 2015 when it last chaired APEC. The 2017 Declaration recognized the need to empower MSMEs by increasing their capacities to innovate, improving their access to digital infrastructure, enhancing their digital capacities, competitiveness and resilience, and creating a business environment and ecosystem that supports start-ups.

In the first ever APEC-ASEAN Informal Leaders' Dialogue on 10 November 2017, President Duterte linked the two regions' shared aspirations by describing how ASEAN brings to APEC's advocacy of free and open trade its own viable and open trade architecture and its open regionalism.

Economic empowerment, especially of women, was highlighted in the APEC 2017 Leaders' Declaration. This was also an area where the Philippines was particularly recognized.

THE PHILIPPINE PAVILION AT THE 2017 VENICE ART BIENNALE

The DFA spearheaded a number of cultural projects to promote greater understanding and awareness of the richness and diversity of Philippine culture, heritage and arts and to strengthen people-to-people linkages with bilateral and multilateral partners.

One of the highlights was the Philippines' participation in the Venice Art Biennale, the world's biggest contemporary art event, for the second time since its return in 2015 after a 51-year hiatus. The Philippines' exhibition, "*The Spectre of Comparison*", was curated by Joselina Cruz, and featured the works of Filipino artists Lani Maestro and Manuel Ocampo.

The exhibition's take off point was Jose Rizal's protagonist in *Noli Me Tangere*, Crisostomo Ibarra, who experienced a double vision when he gazed out at the botanical gardens of Manila. The exhibition looks at how Maestro and Ocampo see the events of the Philippines and their adopted countries through an inverted telescope.

The site of the 2017 Philippine Pavilion was the Arsenale, one of the main exhibition spaces of the Venice Biennale. The Arsenale is the largest pre-industrial pre-industrial production center of the world, then a symbol of the military, economic and political power of Venice at the time.

The Philippine participation at the Venice Biennale was a joint project of the NCCA, the DFA, and the Office of Senator Loren Legarda, with the support of the Department of Tourism (DOT).

The Philippine Pavilion was open to the public from 13 May 2017 until 26 November 2017.

GLOBAL CONFERENCE OF HEADS OF POST

To help build a more resilient foreign service, the Department gathered more than 80 Heads of Philippine Foreign Service Posts to the Global Conference of Heads of Post held on 30 January - 02 February 2017 in Makati City, only the second activity of its kind since the first conference of Heads of Post in March 2007.

The conference provided briefings on the current administration's policy, directions and agenda, discussed current and emerging trends and issues in various regions, and presented the Department's Strategic Plan 2017-2022. All key officials of the DFA and officials of partner government agencies attended the conference.

The conference was one of several initiatives undertaken by the DFA in 2017 to strengthen the institution, particularly its policy formulation and implementation processes, in line with the Department's vision of "A resilient foreign service for a strong Philippines."

Foreign Relations Strengthened to Promote a Stable Security Environment for Economic Growth

PRESERVATION AND ENHANCEMENT OF NATIONAL SECURITY

The Department of Foreign Affairs (DFA) is the lead agency that implements Philippine foreign policy in the areas of political and security affairs, under the guidance of the President.

Consistent with the country's independent foreign policy and with the Administration's policy to be "a friend to all and enemy to none", the DFA pursued a foreign policy that is "patient, prudent and purpose-driven, with the Filipino people at its center."

Thus guided and to help realize the Government's vision of a secure and prosperous Philippines that is confident of its place in the community of nations, the DFA actively led efforts to strengthen foreign relations to promote a stable security environment for the country's economic growth.

The country's foreign affairs in 2017 was capped by its successful chairmanship of ASEAN during the regional organization's 50th foundation anniversary year. The Philippines hosted a total of one hundred and forty-one meetings throughout the year, and a total of fifty-six outcome documents were noted, issued, adopted, and signed by Leaders. The Philippines' leadership resulted in a more inclusive, people-centered, resilient and relevant ASEAN community ready for the future and benefitting the Filipino people.

The DFA actively engaged both traditional and non-traditional bilateral partners, and actively participated in multilateral fora, to promote and protect Philippine national interests. This included the implementation of a whole-of-government strategy to address maritime issues in accordance with an independent foreign policy.

KEY ADVOCACIES ON NATIONAL SECURITY

PROMOTION AND PROTECTION OF MARITIME SOVEREIGN INTERESTS

With President Duterte paving the way for improved relations with China, the DFA conducted bilateral visits and made full use of cooperative mechanisms to further create an improved environment for managing issues in the West Philippine Sea (WPS).

The DFA, as chair of the Politico-Legal and Diplomatic Working Group under the National Task Force (NTF) on the West Philippine Sea (WPS), contributed to the whole-of-government efforts in safeguarding Philippine interests in the WPS.

Among the DFA's key contributions are:

- The DFA continued to engage China relative to the Philippines' concerns on the West Philippine Sea. The First Meeting of the Philippines-China Bilateral Consultation Mechanism on the South China Sea (BCM), which serves as a venue for the Philippines and China to manage differences amicably, was held on 19 May 2017. Positive developments include improvement in the ability of both sides to manage developments in the WPS so as not to escalate tensions; wider access of Filipino artisanal fishermen in Scarborough Shoal; and measures to protect the environment and marine ecosystem in the South China Sea.
- The DFA spearheaded the Philippines' active participation in the ASEAN-China processes on the peaceful management and resolution of disputes in the South China Sea (SCS).

While underscoring the importance of the full and effective implementation of the Declaration on the Conduct of Parties in the South China Sea (DOC) in its entirety, the Philippines also worked actively with its ASEAN neighbors to push for the early conclusion of an effective Code of Conduct (COC). The draft framework for the COC was finalized at the 14th ASEAN-China SOM on the DoC on 18 May 2017; adopted by the ASEAN Foreign Ministers and the Chinese Foreign Minister during the ASEAN-China Post Ministerial Conference on 06 August 2017; and noted by the ASEAN Leaders and Chinese Premier Li Keqiang at the 20th ASEAN-China Summit on 13 November 2017.

The adopted framework will serve as the basis for the beginning of substantive negotiations between China and ASEAN member states on the actual Code of Conduct, which is scheduled to commence in early 2018.

• The Philippines shepherded the adoption of the Declaration for a Decade of Coastal and Marine Environmental Protection in the South China Sea (2017-2027) during the 20th ASEAN-China Summit in November 2017. The Declaration takes off from previous and existing commitments and mechanisms to protect, manage, conserve, preserve, and restore the area's fragile coastal and marine environment. The Declaration also calls for the

formulation of a Plan of Action as an early harvest and confidence building measure. The Declaration is a fitting milestone to commemorate both the 50th anniversary of ASEAN and the 15th anniversary of the 2002 DOC.

- The DFA was at the forefront of operationalizing the ASEAN-China Foreign Ministry-to-Foreign Ministry Hotlines in 2017. The Hotlines agreement is intended to manage incidents arising from the implementation of the DOC, and will play a crucial role in preventing tensions from escalating in the WPS.
- The DFA, together with the Philippine Coast Guard (PCG), organized a second meeting with the Chinese Coast Guard on 20-21 February 2017. Cooperation between the PH and Chinese coast guards will boost efforts in addressing drug trafficking and other illegal activities at sea, promoting marine environmental protection and strengthening emergency response to maritime incidents.

• Together with other government agencies, the DFA worked on the draft that was to become E.O. No. 25, renaming the Benham Rise to Philippine Rise. The E.O., signed by the President on 16 May 2017, will reinforce the Philippines' exercise of its sovereign rights and jurisdiction over said area.

The Philippine Rise Region is an underwater feature with an approximate area of 24 million hectares located within the Philippines' EEZ and continental shelf, as well as the outer limits of the continental shelf in accordance with the recommendations of the Commission on the Limits of the Continental Shelf issued on 12 April 2012.

ADDRESSING NON-TRADITIONAL SECURITY THREATS

Counter-Terrorism and De-radicalization

Throughout 2017, the DFA participated in various efforts to build consensus among stakeholders in the government, civil society organizations and academe in relation to preventing and countering violent extremism (PCVE). This included developing the National Action Plan (NAP) on PCVE shepherded by the Anti-Terrorism Council – Program Management Center (ATC-PMC). The NAP was completed in December 2017 and was submitted to the Executive Secretary/ATC Chairman and for approval of the ATC members.

The DFA also participated in the Technical Working Group meetings initiated by the ATC-PMC on the Amendment of the Human Security Act of 2007. The proposed amendment, completed on 06 December 2017, contains provisions relating to suppressing recruitment and incitement with respect to the new elements of Security Council Resolution 2178 (2014).

On the international front, the DFA worked towards strengthening cooperation and coordination on counter-terrorism and in managing non-traditional security threats.

The Trilateral Meeting on Security Among the Philippines, Indonesia, and Malaysia held in Manila on 22 June 2017 aimed to enhance cooperation to address terrorism and violent extremism confronting the region. Participating in the meeting were the three countries' Foreign Ministers and leading officials of their Armed Forces, National Police and Intelligence agencies.

This meeting was followed on 12 November 2017 by the Informal Trilateral Ministerial Meeting on Security among the Foreign Ministers of the Philippines, Indonesia, and Malaysia, which was held on the sidelines of the 31st ASEAN Summit in Manila. The meeting is a follow-up on the commitments made during the Trilateral Meeting on Security held in June, and focused on the liberation of Marawi City, the enhancement of Trilateral Cooperation, and the sharing of best practices in Madrasah education and de-radicalization efforts, and religious tolerance.

The Trilateral Roundtable on Legal Frameworks was held in Manila on 21 November 2017 as part of the commitment for a cross comparison of each countries' laws on terrorism. Present were security, intelligence, law enforcement officials, and representatives from the Foreign Ministries of Indonesia and Malaysia as well as representatives from Philippine agencies such as the DFA, DOJ, ATC-PMC and PCTC.

The Philippines also participated in the Aqaba Process Meeting on Southeast Asia held on 06-07 May 2017 in Aqaba, Jordan. The Aqaba meetings are hosted by Jordan as part of efforts to enhance global coordination in countering terrorism and violent extremism. The Philippine delegation was led by National Security Adviser General Hermogenes Esperon, Jr., with DFA represented by the Assistant Secretary for Middle East and African Affairs Hjayceelyn M. Quintana and Philippine Ambassador to Jordan Junever Mahilum-West.

Among the topics discussed during the meeting were the unique challenges in the Southeast Asia region, the identification of capacity gaps in terms of equipment and training, and the exchange of best practices and expertise from a diverse network of senior intelligence, military, and policy experts.

Continued active engagement with the US led to cooperation on counter-terrorism and extremism, defense, law enforcement, anti-drugs and anti-trafficking, and the rehabilitation of Marawi.

Australia, as the Philippines' second largest partner in defense and security, dispatched mobile training teams for urban warfare training and maritime security training, and deployed relief assistance for Marawi. The Philippines also engaged Japan and China on counter-terrorism initiatives and on the rehabilitation and reconstruction of Marawi.

Disaster Risk Reduction and Management

The DFA participated in the crafting of the Enhanced Philippine International Humanitarian Assistance Guidelines, which was approved during the Fourth Quarter National Disaster Risk Reduction and Management Council (NDRRMC) Full Council Meeting on 05 December 2017.

The thrust of the Guidelines is to develop national resiliency through exhausting all national resources prior to accepting international foreign donations, and the provision of guidelines for the acceptance of foreign donations without the call for international humanitarian assistance.

DEEPENING OF BILATERAL PARTNERSHIPS

Under the Philippines' policy of being "a friend to all and enemy to none", the DFA continued to build, bridge and build relationships and partnerships. It led active engagements with foreign partners in pursuit of amity and cooperation, and the deepening of strategic partnerships, through high-level meetings and visits.

Several agreements were signed during the President's various state visits, in the areas of defense and security cooperation, science and technology, energy, labor, agriculture, tourism, and economic development. Some of the economic agreements signed will feed into the Administration's Build-Build-Build Program to strengthen the country's infrastructure and connectivity.

HIGH LEVEL BILATERAL ENGAGEMENTS

ASIA AND THE PACIFIC:

Australia

Then Acting Foreign Affairs Secretary Enrique A. Manalo met with Australian Foreign Minister Julie Bishop during the latter's visit to the Philippines on 16-17 March 2017 to discuss the status of Philippines-Australia relations which were elevated to the status of Comprehensive Partnership in 2015.

On 10 October 2017, President Duterte visited the largest ship of the Royal Australian Navy, the HMAS Adelaide. It is designed to provide medical and humanitarian assistance during regional emergencies, and has capabilities to deploy personnel for rapid disaster response deployment.

President Duterte met with Australian Prime Minister Malcolm Turnbull on the sidelines of the 31st ASEAN Summit and Related Summits in Manila on 12 November 2017. Discussions focused on Marawi and on economic cooperation.

Bangladesh

Secretary Cayetano and Foreign Minister Abul Hassan Mahmood Ali of the People's Republic of Bangladesh met on the Sidelines of the 50th ASEAN Ministerial Meetings (AMM) and Related Meetings in Manila on 07 August 2017. The foreign ministers discussed the resolution of the Bangladesh bank heist, and improving air links between the Philippines and Bangladesh.

Brunei

President Rodrigo Roa Duterte received H.M. Sultan Haji Hassanal Bolkiah of Brunei Darussalam during the latter's State Visit on 27 April 2017. The leaders discussed ways to strengthen the two countries' political, economic and people-to-people ties, and witnessed the signing of two agreements: (1) Agreement on Cultural Cooperation and (2) MOU on Halal Industry and Halal Export Development and Promotion.

Cambodia

Prime Minister Hun Sen of the Kingdom of Cambodia paid a courtesy call on President Duterte on the sidelines of the 30th ASEAN Summit on 29 April 2017. The Cambodian Prime Minister took the opportunity to personally invite the President to the World Economic Forum for Asia in Cambodia in May 2017, which the President accepted.

On 05-06 December 2017, Cambodian Senior Minister and Minister of Foreign Affairs and International Cooperation Prak Sokhonn paid an official visit to the Philippines and co-chaired with Foreign Affairs Secretary Alan Peter S. Cayetano the Second Meeting of the Joint Commission for Bilateral Cooperation (JCBC).

The two countries also signed the Memorandum of Understanding (MOU) on Defense Cooperation and the Agreement on Prevention of Looting and Illicit Trafficking of Cultural Property during the visit.

China


Vice Premier Wang Yang of the People's Republic of China visited the Philippines on 16-19 March 2017 to attend the Opening Ceremony of the ASEAN-China Year of Tourism on 16 March. During the visit, he paid a courtesy call on President Duterte in Davao on 17 March, met with the country's economic managers, and delivered the keynote speech at the business forum "Chartering New Heights in the Philippines-China Economic Relations: SME Cross-Border Trade and Investment Matching" held in Manila on 18 March.

On 13 May 2017, President Duterte visited Hong Kong SAR and met with the Filipino community. The President acknowledged the role of Overseas Filipino Workers (OFWs) in national development. Hong Kong hosts around 211,545 Filipinos, one of the largest in the world.

Upon the invitation of Secretary Cayetano, Chinese Foreign Minister Wang Yi paid an official visit to Manila on 24-25 July 2017. With the signing of a Memorandum of Agreement on strengthening cooperation between the DFA and Chinese Foreign Ministry, Secretary Cayetano expressed optimism that both sides shall harness the positive momentum generated by the improvement of Philippines-China cooperation in the areas of tourism, trade, finance, cooperation against illegal narcotics, terrorism, sports, arts, culture, and science and technology.

Chinese Defense Minister Chang Wanquan visited the PH to participate in the 11th ASEAN Defense Ministers Meeting (ADMM) and the 4th ADMM-Plus held on 23-24 October 2017 in Clark Field, Angeles City, Pampanga. Following the ADMM meetings, Minister Chang met with Defense Secretary Delfin Lorenzana on 25 October 2017 to discuss and explore avenues wherein the two countries can improve defense and military-to-military relations.


On 11 November 2017, President Rodrigo Roa Duterte met with Chinese President Xi Jinping in Da Nang, Vietnam, following their participation in the 25th Asia Pacific Economic Cooperation Economic Leaders Meeting (AELM). During the meeting, President Duterte thanked President Xi for China's counter-terrorism assistance to the Philippines during the Marawi siege.

On 15-16 November 2017, Chinese Premier Li Keqiang paid an official visit to the Philippines, during which fourteen (14) agreements and memoranda of understanding on various fields of cooperation were signed. These included agreements on finance, economic and technical cooperation, infrastructure projects, climate change, intellectual property, youth, industrial parks development, production capacity, and defense industry cooperation.

From 29 November to 04 December 2017, Secretary Cayetano paid official visits to Hong Kong SAR and Macau SAR. In Hong Kong, he officiated the opening ceremony of the *Ifugao Sculpture: Expressions in Philippine Cordillera Art* which showcased Ifugao culture. Secretary Cayetano also paid a courtesy call on HK SAR Chief Executive Carrie Lam Cheng Yuet-Ngor on 01 December to discuss opportunities to further strengthen cooperation in the areas of trade and investments, labor, tourism, and people-to-people exchanges, especially with the signing of the ASEAN-HK Free Trade Agreement (AHKFTA).

In Macau, Secretary Cayetano met with the Filipino community and participated in the annual Christmas Party celebration *Paskong Pinoy 2017*, held at the St. Joseph the Worker Church Activity Hall.

India

Secretary Cayetano met with Minister of State for External Affairs Vijay Kumar Singh of the Republic of India on the sidelines of the 50th ASEAN Ministerial Meetings and Related Meetings on 08 August 2017 in Manila. Secretary Cayetano expressed gratitude for the Indian government's donation of USD 500,000 for the rehabilitation of Marawi, while State Minister Singh emphasized India's readiness to support the Philippines in counter-terrorism and to provide humanitarian assistance. Defense and security matters, multilateral cooperation, and regional issues were also discussed.

On 13 November 2017, President Duterte held a bilateral meeting with Prime Minister Narendra Modi on the sidelines of the ASEAN Summit and Related Summits in Manila. The two leaders witnessed the exchange of four recently signed agreements on foreign service institutes, micro, small, and medium enterprises (MSME), agriculture, and defense industry and logistics.

Indonesia

President Duterte received President Joko Widodo of the Republic of Indonesia during the latter's state visit to the Philippines on 28 April 2017, where they discussed the possible convening of the next Joint Commission for Bilateral Cooperation (JCBC), the review of the 1975 Border Agreements, increased cooperation in the fight against illegal drugs, maritime security cooperation and transnational crime. The leaders also witnessed the signing of two agreements: 1) MOU on Agricultural Cooperation and 2) Joint Declaration on the Establishment of Sea Connectivity between Davao/General Santos, Southern Mindanao and Bitung, North Sulawesi. On 30 April 2017, President Duterte and President Widodo graced the formal launch of the Davao-General Santos-Bitung RoRo sea linkage route.

Japan

Highlighting the close and deep relations between the Philippines and Japan, Japanese Prime Minister Shinzo Abe, accompanied by Mme. Akie Abe, undertook a two-day Official Visit to the Philippines on 12-13 January 2017.

The Prime Minister was welcomed and hosted to a State Banquet by President Duterte in Manila during the first day, and was invited by the President to his private residence in Davao City on the second day. The Prime Minister was also honored with the privilege of adopting a Philippine eagle, the Philippines' national bird, which was named "Sakura".

On 05-07 June 2017, Secretary Cayetano undertook a working visit to Japan, where he officially met with Japanese Foreign Minister Fumio Kishida for the first time since his appointment as Secretary of Foreign Affairs. Secretary Cayetano expressed his gratitude for the unrelenting support of Japan for Philippine development, citing the over one trillion-yen Official Development Assistance package for social infrastructure projects. Secretary Cayetano also held a press briefing for the Japan National Press Club at its headquarters, and delivered a speech at the 23rd Nikkei International Conference on the Future of Asia.

On 29-31 October 2017, President Duterte paid an official visit to Japan, during which he met with His Majesty Emperor Akihito and Her Majesty Empress Michiko at the Imperial Palace in Tokyo.

In the President's meeting with Japanese Prime Minister Shinzo Abe, issues relating to economic relations and tensions in the Korean Peninsula were discussed. In a joint statement, both leaders expressed strong commitment to further enhance bilateral ties.

Following the meeting, the two leaders witnessed the signing of an exchange of notes on the provision of a yen loan of up to 15.928 billion yen for the Cavite Industrial Area Flood Risk Management Project by Secretary Cayetano and Japanese Foreign Minister Taro Kono. The President also witnessed the signing of letters of intent on cooperation between Philippine officials and Japanese businessmen.

On 13 November 2017, Prime Minister Shinzo Abe, who was visiting the Philippines to attend the ASEAN-Related Summit Meetings in Manila, held a meeting with President Duterte to discuss bilateral and regional matters. The leaders witnessed the signing of five agreements and exchanges of notes on infrastructure and defense projects.

According to the National Economic and Development Authority (NEDA), in 2017, Japan remained the top provider of ODA to the Philippines, with a total outstanding account of USD 5.33 Billion in loans and grants, accounting for 36.18 percent of the country's total ODA portfolio.

Laos

Prime Minister Thongloun Sisoulith of the Lao People's Democratic Republic paid a courtesy call on President Duterte on the sidelines of the 30th ASEAN Summit on 29 April 2017, during which the two leaders discussed the good trajectory of bilateral relations.

On 12-14 July 2017, the Lao Foreign Minister Saleumxay Kommasith paid an official visit to the Philippines upon the invitation of Secretary Cayetano. Minister Kommasith also headed the Lao PDR delegation to the Inaugural Meeting of the Philippines-Lao PDR Joint Commission for Bilateral Cooperation (JCBC). With Secretary Cayetano as head of the Philippine delegation, various aspects of the bilateral relations were discussed with Laos, including the great potential for expanding tourism and trade and investments through possible mutual agreements on Air Services and Investment Promotion and Protection.

The Philippine and Lao delegations witnessed the signing of the Memorandum of Understanding (MOU) on Academic Cooperation on Higher Education between the Philippine Commission on Higher Education and Laos' Ministry of Education and Sports.

Myanmar

President Duterte undertook a state visit to the Union of Myanmar on 19-20 March 2017 and met with President U Htin Kyaw, State Counsellor Daw Aung San Suu Kyi, and Commander-in-Chief of Defense Services Senior General Min Aung Hlaing of Myanmar. President Duterte and President U Htin Kyaw witnessed the signing of the Memorandum of Understanding on Food Security and Agricultural Cooperation.

New Zealand

Secretary Cayetano held a bilateral meeting with Foreign Minister Gerry Brownlee of New Zealand on the sidelines of the 50th ASEAN Ministerial Meeting and Related Meetings on 08 August 2017, where they discussed economic and trade cooperation.

On 14 November 2017, President Duterte and Prime Minister Jacinda Ardern of New Zealand met on the sidelines of the 31st ASEAN and Related Summits in Manila. The leaders focused on trade relations and on possible exchanges in science and technology.

Papua New Guinea

President Duterte met with Prime Minister Peter O'Neill of Papua New Guinea on the sidelines of the Asia-Pacific Economic Cooperation (APEC) Economic Leaders' Meeting (AELM) on 09 November 2017.

President Duterte conveyed the Philippines' support for Papua New Guinea's chairmanship and hosting of the APEC in 2018.

Singapore

Secretary Cayetano received Foreign Minister Vivian Balakrishnan of the Republic of Singapore during the latter's visit to the Philippines on 13 June 2017. They affirmed the excellent state of the two countries' ties and resolved to continue to cooperate in ASEAN. Singapore is among the Philippines' top trade and investment partners. The two countries will commemorate 50 years of diplomatic relations in 2019.

Sri Lanka

Secretary Cayetano and State Minister of Foreign Affairs Vasantha Senanayake of the Democratic Socialist Republic of Sri Lanka met on the sidelines of the 50th ASEAN Ministerial Meetings and Related Meetings in Manila on 05 August 2017. The two sides discussed opportunities in tourism, agriculture and investments, and on labor cooperation.

Thailand

On 20-22 March 2017, President Duterte paid an official visit to the Kingdom of Thailand and met with Thai Prime Minister Prayut Chan-o-cha. The leaders witnessed the signing of a Memorandum of Understanding on cooperation on science and technology, and an implementing program on tourism and agriculture.

Secretary Cayetano and Thai Foreign Minister Don Pramudwinai held a bilateral meeting on 05 August 2017 on the sidelines of the 50th ASEAN Ministerial Meeting in Manila.

Secretary Cayetano also visited Thailand as Special Envoy of President Duterte for the Royal Cremation of His Majesty King Bhumibol Adulyadej on 26 October 2017 at the Royal Pavilion, Sanam Luang Grounds in Bangkok.

Timor-Leste

Secretary Cayetano and Foreign Minister Hernani Coelho Da Silva of the Democratic Republic of Timor-Leste held a bilateral meeting on 05 August 2017 on the sidelines of the 50th ASEAN Ministerial Meeting in Manila. Foreign Minister Coelho briefed the Secretary on the political developments in Timor-Leste, especially the establishment of its new government.

On the sidelines of the 31st ASEAN Summit on 14 November 2017, Secretary Cayetano met with newly-appointed Foreign Minister Aurelio Guterres of Timor-Leste. Foreign Minister Guterres handed over a letter from Timorese President Francisco Guterres Lu'Olo who was invited as Guest at the Closing Ceremony of the Philippine Chairmanship of ASEAN.

Viet Nam

On 20 February 2017, then Foreign Affairs Secretary Perfecto R. Yasay, Jr. met with Deputy Prime Minister Pham Binh Minh of the Socialist Republic of Viet Nam in Boracay, where they discussed matters related to defense, economic relations, the West Philippine Sea, and the Philippine Chairmanship of ASEAN 2017.

President Duterte held a bilateral meeting with Vietnamese Prime Minister Nguyen Xuan Phuc on the sidelines of the 30th ASEAN Summit on 29 April 2017, where they discussed Viet Nam's commitment to provide long-term supply of rice to PH and progress on the ASEAN-China Code of Conduct (CoC) in the South China Sea.

MIDDLE EAST AND AFRICA

Bahrain

On 13-14 April 2017, President Duterte met with His Majesty King Hamad bin Isa Al Khalifa during his state visit to the Kingdom of Bahrain. The leaders witnessed the signing of four agreements on the establishment of a High Joint Commission that is aimed at enhancing economic and political cooperation, training of diplomats, air services, and agreement on the avoidance of double taxation.

The President also witnessed the signing of a Memorandum of Understanding between the AMA Group Holdings, Inc. and the Nader and Abraham Sons of Hassan Company W.L.L. on the additional investment of USD 250 million, which will see the expansion of the operations of the banana plantation of RP Bahrain Harvest, Inc. in Mindanao. This project is expected to provide 40,000 jobs for farm workers.

Earlier in the year, on 24 January 2017, then Foreign Secretary Yasay conducted a town hall meeting with over 200 Filipino Community leaders and members in Bahrain at the Our Lady of Arabia Auditorium of the Sacred Heart Church in Manama during his short visit to the Kingdom of Bahrain on 24 January 2017.

Egypt

Then Foreign Affairs Secretary Yasay visited the Arab Republic of Egypt on 22 January 2017 to meet with his counterpart. Equptian Foreign Minister Sameh Shoukry. During the meeting at the Foreign Ministry, Secretary Yasay and Minister Shoukry signed the Memorandum of Understanding between the Foreign Service Institute of the Philippines and the Institute for Diplomatic Studies of Egypt. The MOU will strengthen institutional linkages diplomatic between the two academies, specifically on research and seminars.

Qatar

During his state visit to Qatar on 15-16 April 2017, President Duterte met Sheikh Tamim bin Hamad Al-Thani, the Emir of the State of Qatar, and discussed bilateral relations. The two leaders then witnessed the signing of four agreements in the areas of culture, health, technical and vocational education and training, and investment promotion and protection. The last agreement provides favorable conditions for inbound investments from Qatar in the areas of infrastructure and other strategic sectors.

During the visit, President Duterte also attended the Philippines-Qatar Business Forum and witnessed the signing of USD 206 million worth of business deals between Qatari businessmen and the PEZA, which is expected to create almost 5,770 jobs in the Philippines.

Saudi Arabia

On 10-12 April 2017, President Duterte met with Saudi Arabian King Salman bin Abdulaziz Al Saud, Custodian of the Two Holy Mosques, at the latter's private residence during a state visit to the Kingdom of Saudi Arabia.

President Duterte and King Salman witnessed the signing of the following agreements: (1) Agreement on Labor Cooperation for General Workers Recruitment and Employment between the Department of Labor and Employment of the Republic of the Philippines and the Ministry of Labor and Social Development of the Kingdom of Saudi Arabia; (2) Memorandum of Understanding Regarding Political Consultations between the Department of Foreign Affairs of the Republic of the Philippines and the Ministry of Foreign Affairs of the Republic of the Philippines and the Ministry of Foreign Affairs of the Republic of the Philippines and the Toreign Affairs of the Kingdom of Saudi Arabia; and (3) Cooperation Program Between the Foreign Service Institute of the Republic of the Philippines a nd Prince Saud Al Faisal Institute for Diplomatic Studies of Saudi Arabia's Ministry of Foreign Affairs.

Earlier, then Secretary Yasay visited Riyadh on 21-22 January 2017. He engaged the Filipino community in Riyadh in an open forum at the Riyadh Marriott Hotel, where around 150 leaders of the different Filipino organizations in the Kingdom were in attendance.

United Arab Emirates

On 02 March 2017, during his official visit to the United Arab Emirates, then Foreign Affairs Secretary Yasay met with the UAE Minister of State for Foreign Affairs Dr. Anwar bin Mohammed Gargash.

Secretary Yasay and Dr. Gargash discussed the tentative date for the visit of President Duterte to the UAE, and expressed their commitment to finalize pending bilateral agreements on consular, judicial, and labor cooperation.

Secretary Yasay also paid a courtesy call on Sheikh Mohammad bin Rashid al Maktoum, UAE Prime Minister and Vice President and Ruler of Dubai, at the Zaabeel Sports Club on 03 March 2017. Sheikh Maktoum conveyed his personal congratulations as the Philippines assumed the Chairmanship of ASEAN in 2017.

EUROPE

Belgium

Secretary Cayetano met with Deputy Prime Minister and Minister of Foreign Affairs, Foreign Trade and European Affairs of the Kingdom of Belgium Didier Reynders, on the sidelines of the 72nd Session of the UN General Assembly in New York on 22 September 2017. They discussed economic relations and development projects.

Denmark

Then Acting Foreign Affairs Secretary Enrique A. Manalo and Danish Permanent Secretary of State for Foreign Affairs Ulrik Vestergaard Knudsen signed the Memorandum of Understanding (MOU) between the Government of the Republic of the Philippines and the Government of the Kingdom of Denmark on the Establishment of a Mechanism for Bilateral Consultations on 04 April 2017, Taguig City.

European Union

Foreign Affairs Undersecretary for International Economic Relations Manuel A.J. Teehankee met with Mr. Gunnar Wiegand, Managing Director for Asia and Pacific at the European External Action Service (EEAS), the EU's diplomatic service, on 25 May 2017, Pasay City.

On 02 June 2017, Secretary Cayetano met with EU Ambassador Franz Jessen in Pasay City to discuss the PH-EU Partnership and Cooperation Agreement (PCA) and EU's official development assistance to the Philippines.

On 18 July 2017, Secretary Cayetano met with four members of the Sub-Committee on Human Rights (DROI) of the European Parliament in Pasay Ctiy. The DROI Delegation was composed of Members of European Parliament (MEPs) Soraya Post (Socialists and Democrats [S&D], Sweden), Ádám Kósa (European People's Party, Hungary), Josef Weidenholzer (S&D, Austria), and Rikke Karlsson (European Conservatives and Reformists, Denmark).

Secretary Cayetano also held a meeting with Madame Federica Mogherini, the European Union's High Representative for Foreign Affairs and Security Policy and Vice President of the European Commission, on 08 August 2017 on the margins of the 50th ASEAN Ministerial Meeting and Post-Ministerial Conferences in Manila.

France

A five-member French Parliamentary delegation led by its Chairperson-Senator Gérard Miguel and accompanied by French Ambassador to the Philippines Thierry Mathou paid a courtesy call on then Foreign Affairs Secretary Yasay on 09 January 2017.

The French delegation, composed of members of the French-Southeast Asia Group in the French Senate, visited the Philippines on 06-09 January 2017 upon the invitation of of Senate President Aquilino Pimentel III.

Holy See

Secretary Cayetano had a bilateral meeting with Archbishop Paul Richard Gallagher, Secretary for Relations with States of the Holy See, on the sidelines of the 72nd UN General Assembly in New York, USA on 22 September 2017.

During the meeting, Secretary Cayetano took the opportunity to introduce to Archbishop Gallagher the Special Envoy of the President for Interfaith Dialogue, Fr. Alexander P. Balatbat.

Hungary

On 27-28 March 2017, Minister of Foreign Affairs and Trade of the Republic of Hungary Péter Szijjártó visited the Philippines and met with President Duterte, then Acting Secretary of Foreign Affairs Enrique A. Manalo and Trade Secretary Ramon M. Lopez.

Four agreements were signed during the visit: (1) Memorandum of Understanding on Cooperation between the Foreign Service Institute of the Philippines and the Institute of Foreign Affairs and Trade of Hungary; (2) Cultural Cooperation Program between the National Commission for Culture and the Arts of the Philippines and the Ministry of Human Capacities of Hungary; (3) Memorandum of Understanding Between the Philippine Chamber of Commerce and Industry and Hungarian Chamber of Commerce and Industry; and (4) Agreement Between the Government of the Republic of the Philippines and the Government of Hungary on Economic Cooperation.

Minister Szijjártó also formally re-opened the Embassy of Hungary in the Philippines on 28 March 2017 as part of their "opening to the East policy."

On 22 September 2017, Secretary Cayetano met with Minister Szijjártó on the sidelines of the 72nd UN General Assembly in New York, USA. The extension of the Educational and Scientific Exchange Program for the years 2018-2020 was signed during the meeting.

Ireland

On 19 September 2017, Secretary Cayetano held a bilateral meeting with Irish Minister for Foreign Affairs and Trade Simon Coveney, TD on the sidelines of the 72nd UN General Assembly in New York, USA. They discussed the forthcoming PH-Ireland political consultations, economic relations, and consular matters.

Poland

Russia

Russian Secretary of the Security Council Nikolay P. Patrushev paid an official visit to the Philippines on 13-17 February 2017. During the visit, he called on President Duterte, held consultations with National Security Adviser and Director General Hermogenes C. Esperon, Jr., and held a working meeting with Secretary of National Defense Delfin N. Lorenzana.

During the visit, eleven agreements were signed in the fields of defense cooperation, tourism, agriculture, trade and industry, energy, transportation, and culture and the arts.

On 24 October 2017, President Duterte received Russian Minister of Defense Sergey Shoygu in Clark, following his meeting with the Defense Ministers participating in the 11th ASEAN Defense Ministers Meeting (ADMM) and 4th ADMM-Plus.

President Rodrigo Duterte again met with Russian President Vladimir Putin on the sidelines of the Asia-Pacific Economic Cooperation (APEC) Leaders Meeting on 10 November 2017 in Da Nang, Vietnam.

President Duterte also met with Russian Prime Minister Dmitry Medvedev at the Coconut Palace in Pasay City on 13 November 2017, where they witnessed the signing of nine more agreements in the areas of security, energy, mass communication, intellectual property, and education.

Switzerland

The year 2017 was a milestone for Philippine-Swiss relations, as it marked the 60th anniversary of the establishment of diplomatic relations between the two countries.

Then Foreign Affairs Secretary Yasay met with Swiss Federal Councilor Didier Burkhalter on the sidelines of the 34th Session of the Human Rights Council's High Level Segment, kickstarting a series of engagements and activities to celebrate the anniversary. The meeting was held in Geneva, Switzerland on 27 February 2017.

Issues of mutual concern, particularly the Philippine peace processes, federalism, possible cooperation on technical vocational education and training, ratification of the PH-European Free Trade Association Free Trade Agreement (PH-EFTA FTA), PH Chairmanship of ASEAN, the Duterte Administration's campaign against illegal drugs, and death penalty were discussed during the meeting.

This was followed by the convening of the Special Political Consultations between the two countries' officials on 31 March 2017 in Makati. Discussions focused on peace and development, economic and cultural cooperation, human rights and human security.

The Philippine Embassy in Bern hosted a diplomatic reception on 16 June 2017 at the Rathaus, and then organized the first Philippine Fiesta on 17 June 2017 at Waisenhausplatz in the heart of Bern, to celebrate Philippine Independence Day and 60 years of diplomatic relations between the Philippines and Switzerland. Filipino communities all over Switzerland joined in celebrating the milestone year through parades, cultural shows, and culinary events.

Turkey

On 14 May 2017, President Duterte held a bilateral meeting with President Recep Tayyip Erdoğan of the Republic of Turkey on the sidelines of the Belt and Road Forum in Beijing, China.

On 4 August 2017, Secretary Cayetano welcomed to Manila his Turkish Counterpart Minister Mevlüt Çavuşoğlu, highlighting the historic first-time visit of a Turkish Foreign Minister to the Philippines.

United Kingdom

Secretary of State for International Trade Liam Fox, MP, of the United Kingdom of Great Britain and Northern Ireland called on President Duterte on 03 April 2017. Argentina

Secretary Cayetano met with Jorge Marcelo Faurie, Minister of Foreign Affairs and Worship of the Argentine Republic on 31 August 2017 on the sidelines of the 8th Forum for East Asia-Latin America Cooperation (FEALAC) Foreign Ministers' Meeting (FMM) in Busan, Republic of Korea.

The leaders discussed cooperation in agriculture, tourism, culture, education and sports as well as opportunities for trade and investments. They also shared views on Argentina's application to join the ASEAN Treaty of Amity and Cooperation.

Mexico



United States of America

Among the topics discussed during the meeting were continued cooperation between the PH and US militaries in humanitarian assistance and disaster relief operations, counter-terrorism efforts, and the fight against illegal drugs and other transnational crimes.

On 02-04 May 2017, then Acting Secretary Manalo visited the US and met with the following US government officials: Senate Foreign Relations Committee Ranking Member Ben Cardin; Asia Pacific Subcommittee Chair Senator Cory Gardner; US-PH Friendship Caucus Co-Chairs Representatives Steve Chabot and Bobby Scott; and officials from the National Security Council, and the Departments of State and Defense.

US Ambassador to the Philippines Sung Kim paid a courtesy call on President Duterte on 15 January and 27 March 2017, to discuss cooperation in counter-terrorism and counter-narcotics. The US provides support to the Armed Forces of the Philippines (AFP) through grant assistance and expedited sales of arms and munitions to support both long-term AFP modernization goals and urgent counter-terrorism requirements.

US Senator Cory Gardner called on President Duterte on 31 May 2017 and discussed further advancing PH-US relations through trade, investment, defense, and security. This was followed by a meeting between Secretary Cayetano and Senator Gardner in September, when the former paid an official visit to Washington and the two officials discussed ways to expand economic cooperation and other areas of bilateral relations.

Admiral Harris, commander of the US Pacific Command, called on President Duterte on 23 August 2017 in Manila, to discuss PH-US defense and security cooperation. The President thanked Admiral Harris for the close partnership of the US in the fight against terrorism, especially in Marawi.

After attending the 72nd Session of the UN General Assembly in New York, Secretary Cayetano visited Washington, D.C. on 25–28 September 2017, during which he met with key US government officials including National Security Advisor Herbert Raymond McMaster, Secretary of State Rex Tillerson, Senators John McCain, Ben Cardin and Cory Gardner; think tanks; and the Filipino community in Washington D.C..

US Secretary of Defense James Mattis, on the other hand, visited the Philippines on 24 October 2017 to participate in the ASEAN Defense Ministers Meeting Plus. President Duterte thanked Secretary Mattis for US assistance in the counterterrorism operations against the Maute Group in Marawi City.

On 13 November 2017, a bilateral meeting between President Duterte and US President Donald J. Trump was held on the sidelines of the 31st ASEAN and Related Summits in Manila, to discuss the full range of PH-US relations.

The Philippines and the US reaffirmed the enduring PH-US alliance and pledged to strengthen cooperation. They also touched on the ongoing PH campaign against criminality and drugs and committed to share best practices in addressing illicit drug use.

Uruguay

The 1st Philippines - Uruguay High-Level Bilateral Consultation took place on 23 August 2017 in Montevideo, Uruguay. Undersecretary Manalo is the highest Filipino official to make a bilateral visit to Uruguay since diplomatic relations were established between the Philippines and Uruguay on 29 December 1975. Undersecretary Manalo and Uruguay Vice Foreign Minister for Policy Enrique Loedel agreed to implement existing MOUs, such as on agriculture and sports.

ENHANCING REGIONAL AND MULTILATERAL ENGAGEMENTS

The Duterte Administration actively participated in regional and global platforms to pursue Philippine advocacies and interests in the international arena.

ASEAN CHAIRMANSHIP IN 2017

The Philippines led the ASEAN in its role as Chair during the regional organization's 50th foundation anniversary year, using the theme, *"Partnering for Change, Engaging the World."* The Philippines' Chairmanship had six thematic priorities, namely (a) a people-oriented and people-centered ASEAN; (b) peace and stability in the region; (c) maritime security and cooperation; (d) inclusive, innovation-led growth; (e) ASEAN's resiliency; and (f) ASEAN as a model of regionalism and a global player.

A total of 56 outcome documents were noted, issued, adopted, and signed by Leaders during the Philippine Chairmanship in 2017. Most noteworthy is the "ASEAN Consensus on the Protection and Promotion of the Rights of Migrant Workers" signed by the ASEAN Leaders at the 31st ASEAN Summit held in Manila on 14 November 2017.

This landmark document establishes a framework for cooperation in safeguarding the interests and welfare of the thousands of migrant workers in the region. It strengthens the social protection and access to justice and health services of the region's migrant workers, and ensures their humane and fair treatment.

Among its many provisions, the ASEAN Consensus document recognizes the fundamental rights of migrant workers; upholds fair treatment with respect to gender and nationality; takes necessary actions to prohibit overcharging of placement or recruitment fees and protect from violence and sexual harassment; regulates recruiters to eliminate recruitment malpractices; ensures right to fair and appropriate remuneration and benefits, and join trade unions and associations.

These included two Summits, 19 Ministerial Meetings, 42 Senior Officials' Meetings, and 78 Technical Working Group Meetings. In addition, the Philippines organized 79 commemorative activities to highlight ASEAN's 50th year throughout 2017.

In his keynote address, President Duterte reaffirmed the country's steadfast commitment to upholding the ideals of ASEAN through unity and cooperation which, according to him, have defined the regional community for more than five decades. The ceremony included the unveiling of the Philippines' Chairmanship Commemorative Coin and the Commemorative Stamp, as well as the launch of the ASEAN chairmanship theme song entitled ASEAN Spirit.

23rd Meeting of the ASEAN Intergovernmental Commission on Human Rights (AICHR) 13-15 February 2017, Boracay

At the 23rd Meeting of the AICHR, the AICHR Representatives had a Retreat session where they adopted the *Guidelines on Field Visits* for the AICHR Philippines-proposed project *Thematic Study on Women Affected by Natural Disasters*. The meeting also adopted in principle the concept note for the 2nd *Workshop on Developing ASEAN Legal Human Rights Instruments*.

President Duterte chaired the following Leaders' meetings during the 30th ASEAN Summit:

- 30th ASEAN Summit Plenary and Retreat

- ASEAN Leaders' Interface with ASEAN Youth Leaders
- 12th BIMP-EAGA Summit

The Leaders discussed the progress in ASEAN Community-building and the realization of the ASEAN Vision 2025, noted the need to achieve a modern, comprehensive, high-quality and mutually beneficial Regional Comprehensive Economic Partnership (RCEP) agreement amidst the sluggish economic environment and trends toward protectionism, and discussed developments in the South China Sea and in the Korean peninsula.

The Leaders also welcomed the operationalization of the Guidelines for Hotline, Communications among Senior Officials of the Ministries of Foreign Affairs of ASEAN Member States and China in Response to Maritime Emergencies in the Implementation of the Declaration on the Conduct of Parties in the South China Sea.

12th BIMP-EAGA Summit 29 April 2017, Manila

The Leaders of Brunei Darussalam, Indonesia, Malaysia and the Philippines, together with the ASEAN Secretariat and the Asian Development Bank as the BIMP-EAGA Regional Development Advisor, discussed the milestones and developments in the BIMP-EAGA sub-region. Highlighted during the Summit were the adoption of the BIMP-EAGA Vision 2025 (BEV 2025), the successor document to the BIMP-EAGA Implementation Blueprint 2012-2016, and the launching of the Davao/General Santos-Bitung ASEAN Roll-On / Roll-Off (RORO) Sea Linkage Route on 30 April 2017 in Davao City, Philippines.

President Duterte and Indonesian President Joko Widodo spearheaded the launch of the new shipping route which, in President Duterte's words, "will integrate our archipelago to the rest of the region", "strengthen inter-regional maritime connectivity", and "introduce new opportunities for trade expansion with larger and emerging economies outside the region". The launching of the ASEAN RoRo is an initiative that revitalizes trade in the EAGA area and cuts shipping time of goods (agriculture products and implements) between Davao City, General Santos City, and Bitung City on the northern coast of Sulawesi in Indonesia from two weeks to just two to three days.

They also recognized the important role of the AHA Centre in operationalizing the "ASEAN Declaration on One ASEAN One Response: ASEAN Responding to Disasters as One in the Region and Outside the Region" and extended appreciation for the prompt response in the delivery of relief items for the Northern Viet Nam flash flood and landslides victims and the displaced communities in Marawi City.

20th ASEAN-China Summit 13 November 2017, Manila

ASEAN Leaders conveyed their deep appreciation to Prime Minister Abe for his personal efforts to strengthen ASEAN-Japan dialogue relations. Prime Minister Abe was credited for his vision for East Asia that respects ASEAN's central role in the regional architecture while espousing Japan's "Proactive Contribution to Peace" as a fundamental security principle.

Cayetano led the Philippine delegation to the 18th Forum for East Asia-Latin American Cooperation (FEALAC) Foreign Ministers' Meeting (FMM) held in Busan, Republic of Korea on 31 August 2017. The Secretary delivered an intervention on the importance of FEALAC in facilitating meaningful dialogue and concrete cooperation between East Asia and Latin America, and the Philippines' commitment to reinvigorating its engagement with its Latin American partners as envisioned under President Duterte's independent foreign policy.

The meeting adopted the *Busan Declaration*, which provided a direction for deeper and more comprehensive cooperation for the future. It highlighted the following initiatives: Endorsement of the new FEALAC Action Plan; Establishment of a FEALAC Fund to finance the group's flagship and bi-regional projects and activities; and Creation of a FEALAC Experts Group Pool and FEALAC mechanisms to provide more tangible outputs.

Then Secretary Yasay led the PH delegation to the 25th Session of the General Conference of Agency for the Prohibition of Nuclear Weapons in Latin America and the Caribbean (OPANAL) and the 50th Anniversary of the Treaty of Tlatelolco on 14 February 2017 in Mexico City. The Secretary delivered an intervention on the important role of the Treaty of Tlatelolco in serving as a political, legal, and institutional model for the creation of nuclear weapon- free zones, and called for closer working relations between OPANAL and ASEAN towards the signing and ratifying of the Southeast Asia Nuclear Weapon Free Zone protocol.

UNITED NATIONS

Philippine Ratification of the Paris Agreement 23 March 2017, New York

The DFA facilitated the signing of the Paris Agreement on 22 April 2015, its ratification on 1 March 2017, legislative concurrence on 14 March 2017, and the deposit of the Instrument of Accession in the United nations in New York on 23 March 2017.

The Paris Agreement aims to hold global warming to less than 2 degrees Celsius and encourages Parties to make efforts to limit this rise to 1.5 degrees Celsius. The treaty also seeks to improve the resilience of communities to climate change impacts, and to promote the increase in financial flows to support mitigation and adaptation.


Senior Deputy Executive Secretary Medardo Guevarra and then Senator and Chair of the Senate Foreign Relations Committee Alan Peter Cayetano led the Philippine delegation to the third cycle review of the Philippines in the Universal Periodic Review (UPR) and participated in the interactive dialogue at the Human Rights Council on 08 May 2017 in Geneva. The UPR is the periodic review of the human rights records of all 193 UN member states.

The Philippines reported on its actions on the recommendations of the 2012 UPR. The 72nd UNGA opened on 12 September 2017 and the General Debate was held on 19-23 and 25 September 2017 at the U.N. Headquarters in New York.

Participation in the General Debate enabled the Philippines to present to the international community the key priorities of the administration of President Rodrigo R. Duterte. The Secretary also hosted an informal ASEAN Foreign Ministers Meeting and attended the group's meeting with the President of the 72nd UN General assembly and the UN Secretary General.

The DFA actively participated in the process leading to the adoption by the 72nd Session of the UN General Assembly of the text of the Treaty on the Prohibition of Nuclear Weapons (TPNW). The Treaty was opened for signature on the sidelines of the 72nd UNGA, and Foreign Secretary Cayetano signed the Treaty on 20 September 2017.

This historic treaty is the first legally-binding international agreement to prohibit nuclear weapons and addresses the legal gap in the prohibition and elimination of what was heretofore the only type of weapon of mass destruction without an International treaty. Despite the lack of universal acceptance, significant support for and adoption of the treaty will make nuclear weapons illegal in at least 122 countries.

Philippines Hosts its First Conference of the Parties of a UN Multilateral Environment Agreement 22-27 October 2017, Manila

The DFA assisted the DENR in hosting the 12th Session of the Conference of the Parties to the UN Convention on Migratory Species (CMS-COP12). This is the first environmental COP that the Philippines has hosted.

Among the outcomes of CMS-COP12 are the establishment of the Convention's Review Mechanism, the introduction of a COP Presidency that will perform intersessional work, and pledges by a number of countries to join the Convention, including the ratification commitment made by Cambodia, seen as a positive step towards bringing the rest of the nine ASEAN countries into the Convention and its work of protecting the flyways and habitats of migratory species in Southeast Asia.

Philippines elected President of the 61st Session of the General Conference of the International Atomic Energy Agency (GC-IAEA) 18-22 September 2017, Vienna

Ambassador Maria Zeneida Angara Collinson was elected as President of the 61st Session of the General Conference of the International Atomic Energy Agency (GC-IAEA) in Vienna. She became only the third woman and fourth Philippine official to have been elected President of the GC-IAEA since its establishment in 1956.

Philippine engagement with the IAEA are in the areas of health, nuclear safety and security concerns, nuclear science and technology, nuclear non-proliferation, and peaceful uses of nuclear energy, among others. The Philippines, represented by Agriculture Secretary Emmanuel Piñol, chaired the 40th Session of the FAO Conference held in Rome. This was the first time that a Filipino has chaired the Conference, which meets every two years, and is the highest policy-making body of the FAO. The Philippine chairmanship highlighted the threat posed by climate change on food production and called on governments to invest more in agriculture to ensure the availability and affordability of food and reduce poverty in the countryside.

The Philippine chairmanship of the FAO Conference is seen as an affirmation of confidence of the international community in the Philippines, which is becoming an important player in the multilateral fora for economic, development and food security issues. The DFA, through the Philippine Embassy in Rome, played a key role in securing the Philippine Chairmanship.

Ratification of International Labor Organization Convention No. 151 (C151) 10 October 2017, Geneva

As a Philippine commitment to protect the rights of employees in the public service to organize, President Duterte signed the instrument of ratification of International Labor Organization Convention (C151) or Convention Concerning Protection of the Right to Organise and Procedures for Determining Conditions of Employment in the Public Service, with the Senate concurring on 14 August 2017. The Philippine Mission in Geneva handed over the PH ratification documents to the ILO on 10 October 2017.

The Convention promotes sound labor relations between public authorities and public employees' organizations through the protection of the right to organize, granting of full facilities or privileges to its representatives, full development and utilization of machinery for negotiations terms and conditions of employment, and promotion of civil and political rights of public employees.

The DFA spearheaded efforts in several international candidatures, which resulted in the Philippines being elected to seats in the following international organizations:

PROMOTION AND ATTAINMENT OF ECONOMIC SECURITY

In 2017, the Philippines continued to actively participate in regional and international fora as part of efforts to contribute to sustainable development, and to shape a better global economic order.

The DFA worked closely with various agencies and business groups in the promotion of the country's economic interests, reinforcing the One Country Team Approach.

REGIONAL COMPREHENSIVE ECONOMIC PARTNERSHIP (RCEP)

The DFA continued to participate in all rounds of negotiations to forge the Regional Comprehensive Economic Partnership (RCEP) in 2017. The RCEP is a proposed free trade agreement (FTA) among sixteen parties, composed of the ten ASEAN Member States and its six FTA partners, namely: Australia, China, India, Japan, South Korea, and New Zealand.

The Philippines, led by the DTI, hosted the 18th RCEP Trade Negotiations Committee and Related Meetings on 02-12 May 2017 in Manila, the 5th RCEP Ministerial Meeting on 10 September 2017, and the RCEP Summit on 14 November 2017. The DFA participated in the rounds of negotiations.

Negotiations were not concluded in 2017. At the RCEP Summit in Manila, RCEP Leaders instructed the Ministers and negotiators to intensify efforts in 2018 to bring the RCEP negotiations to conclusion.

The Philippines hosted the Asia Cooperation Dialogue (ACD) Conference Towards Energy Security, Sustainability and Resiliency and its associated meetings, the 2nd ACD Energy Working Group Meeting and the 1st East Asia Energy Forum on 07-08 August 2017 at the Be Grand Resort in Panglao, Bohol. The Philippines is a Co-Prime Mover of the ACD Pillar on Food, Water and Energy Security.

The Energy Conference was hosted by the Department of Energy and is in fulfillment of the Philippine commitment during the 15th ACD Ministerial Meeting in Abu Dhabi in January 2017.

The 2nd ACD Energy Working Group Meeting was co-chaired by DFA Undersecretary Manuel A.J. Teehankee with ACD Secretary General Bundit Limschoon.

Since its establishment in 2002, the ACD has grown to become one of the flagship energy conferences in Asia where new ideas and best practices are exchanged to benefit the whole region.

WORLD TRADE ORGANIZATION

Implementing the World Trade Organization - Information Technology Agreement II (WTO - ITA 2)

The Instrument of Ratification of the Philippines to the World Trade Organization (WTO) – Information Technology Agreement II (ITA-2) was signed by the President on 28 February 2017. Executive Order No. 21, indicating the PH Schedule of Commitments, was consequently signed on 28 April 2017. The PH implemented the Law in 01 July 2017, with flexibility on some products until 01 July 2023.

ITA-2 is expected to make the Philippines more attractive to FDIs particularly from key ICT players such as the US, Japan, and the EU. The gains will redound to other sectors that use IT products as inputs, such as technology start-ups, manufacturing companies and the business processing and outsourcing (BPO) industry. The lower prices will improve access to technology that will facilitate education and accelerate innovation. The 201 products in the agreement is valued at \$1.3 trillion per year. The PH is the 14th largest exporter of the said products valued at USD14 billion.

Reinforcing the Multilateral Trading System: The 11th WTO Ministerial Conference (MC11)

The PH participated in the 11th WTO Ministerial Conference held on 10-13 December 2017 in Buenos Aires, Argentina. Ministerial decisions were delivered on a commitment to continue on Fisheries Subsidies, a Work Program on E-Commerce, an extension of the moratorium on TRIPS Non-Violation and Situation Complaints, a Work Program on Small Economies and the creation of the working party on accession for South Sudan.

The country's MC11 priorities were anchored on positions that support the Administration's determination to achieve inclusive Philippine economic development and address issues on rural and agricultural poverty, accessibility of public health goods and services, and integrating MSMEs into global value chains.

ASIA-PACIFIC ECONOMIC COOPERATION (APEC)

In 2017, the Philippines attended a total of 111 meetings hosted by the APEC 2017 Chair, Viet Nam. Besides the seven (7) core meetings of APEC (AELM, Ministers, SOM, Ministers Responsible for Trade), the Philippine delegation also attended technical meetings and several sectoral meetings, including five (5) meetings on Agriculture, three (3) meetings on Connectivity, and four (4) meetings on MSMEs.

The President participated in four (4) meetings during the APEC Economic Leaders' Week (AELW) on 06 to 11 November 2017 in Da Nang, Viet Nam. The following key messages were delivered during the President's interventions in these meetings:

- The need for inclusive growth
- APEC will only remain relevant if prosperity is shared by all
- Economies should institute more equitable terms in all facets of relations, like tariffs, terms and benefits of trade, and encouraged economies to addressing barriers to free and open trade
- CEOs need to include MSMEs in their retail operations and in their sourcing decisions in order to enable MSMEs to enter the global value chain
- Businesses should adopt inclusive business models to create and distribute wealth
- Measures must be instituted to address the challenge presented by the loss of human capital in developing economies, due to the migration of talent to developed economies

In the lead-up to the AELW, the DFA participated in three stand-alone Senior Officials' Meetings (SOMs).

PHILIPPINES – EUROPE TRADE RELATIONS

PH-European Free Trade Association (EFTA) Free Trade Agreement

On 08 December 2017, President Duterte signed the Instrument of Ratification for PH-EFTA Free Trade Agreement. The FTA covers trade in goods (industrial and agricultural goods, fish and other marine products), rules of origin, trade facilitation, sanitary and phyto-sanitary measures, technical barriers to trade, trade in services, investment, competition, protection of intellectual property rights, government procurement, and sustainable development. The DFA co-chaired the negotiations with the Department of Trade and Industry (DTI).

EU Generalized Scheme of Preferences (GSP) Plus

The DFA participated in the 2nd EU GSP+ Monitoring Mission held on 27 January – 02 February 2017. The EU GSP+ is a special trade arrangement where zero duties are imposed on Philippine exports to EU member countries. It currently covers 6,274 products. In exchange, the EU requires that the Philippines report on its compliance to 27 International Conventions on human rights, labor standards, environmental protection and good governance.

PH-European Union (EU) Free Trade Agreement

The DFA was also part of the PH negotiating team during the 2nd Round of PH-EU Free Trade Negotiations, which was held in Radisson Blu Hotel, Cebu on 13-17 February 2017. The FTA covers trade in goods (industrial and agricultural goods, fish and other marine products), rules of origin, trade facilitation, sanitary and phyto-sanitary measures, technical barriers to trade, trade in services, Investment, competition, protection of intellectual property rights, government procurement, and sustainable development.

Philippines-Latin America Economic Roundtable

The DFA organized the first Philippines-Latin America Economic Roundtable to discuss and exchange ideas on how to enhance and strengthen trade and economic relations between the Philippines and Latin America. Held at Casino Español de Manila on 27 September 2017, it was attended by the resident Ambassadors and other officials from the Embassies of Argentina, Brazil, Chile, Colombia, Mexico, Panama, and Venezuela in Manila.

Philippines-South Asia Economic Roundtable

The Philippines-South Asia Economic Roundtable was held at the Diamond Hotel Manila on 29 November 2017. Philippine officials met with the resident Ambassadors and other officials from the Embassies of India, Pakistan and Sri Lanka to explore economic cooperation in new and non-traditional areas.

CULTURAL DIPLOMACY

Cultural Diplomacy is increasingly getting recognition for the important role it plays in international affairs. It fosters understanding and builds relations among nations and peoples through the exchange of ideas, art, literature, music, sports, and other aspects of both high culture and popular culture.

The DFA, in partnership with other Philippine government agencies, the private sector, and its Embassies and Consulates General, undertook several initiatives in 2017 to promote awareness of Philippine culture and heritage. Highlights include the promotion of Philippine cuisine in the world's major cities through two culinary tours, Philippine participation in the 57th *Venice Art Biennale,* and the opening of a Center for Philippine Studies at the School of Oriental and African Studies (SOAS) in the University of London.

PROMOTION OF PHILIPPINE CUISINE OVERSEAS

The DFA's Cultural Diplomacy Unit organized two culinary tours to contribute to efforts that introduce Filipino food traditions to the international market, and to mainstream Philippine flavors in global cities possessing a diverse gastronomic landscape. The culinary tours complemented the objectives to promote goodwill and deeper people-topeople ties, and set the ground for an expanded trade in agriculture, food, and beverages as intended consequences.

KULINARYA: A GUIDE TO PHILIPPINE FOOD

Headed by Chef Myrna Segismundo, and joined by Chef Jill Sandique, Chef Raul Ramos and food writer Mikaela Fenix, *Kulinarya: A Guide to Philippine Food* was held in the cities of London, United Kingdom; Brussels, Belgium; The Hague, Netherlands and Berlin, Germany from 27 May to 24 June 2017.

The culinary team successfully delivered the following activities in each city: a photo exhibit on Filipino food using the pictures from the book "*Kulinarya: A Guidebook to Philippine Cuisine*"; a talk and cooking demonstration with food-tasting; and the preparation of a ticketed full-course dinner.




HIDDEN FLAVORS OF THE PHILIPPINE KITCHEN

PHILIPPINE PARTICIPATION IN THE VENICE ART BIENNALE IN COOPERATION WITH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) AND THE OFFICE OF SENATOR LOREN LEGARDA


The Philippines once again set a milestone in the international art community through its official pavilion in the 57th *Venice Art Biennale, entitled The Spectre of Comparison,* curated by Joselina Cruz and featuring Filipino artists Lani Maestro and Manuel Ocampo.

The Philippine Pavilion was opened to the public from 27 May to 26 November 2017. The pavilion exhibited the visual expression of the evolution of the Filipino worldview, whose origins are marked by the works of Maestro and Ocampo, and framed within the idea of "el demonio de las comparaciones", a line from Rizal's novel Noli Me Tángere.

Translated as "the spectre of comparisons," it refers to Crisostomo Ibarra's futile attempts to avoid comparing his beloved, though imperfect, Manila with Europe, the perceived idyll; thus, comparison cannot be avoided, making it a "demonio". Jose Rizal's phrase of "el demonio de las comparaciones" was the spectral pivot.

The Philippine Pavilion was located at the Artiglierie of the Arsenale in Venice, Italy.

- On 24 October 2017, the Department of Foreign Affairs through the Philippine Embassy in London and in cooperation with the Office of Senator Loren Legarda, awarded a grant of £74,700 to the School of Oriental and African Studies (SOAS) in the University of London for the opening of a Center for Philippine Studies. Over the next three years, the grant will cover Philippinerelated lectures, workshops, exhibitions, conferences and travel grants for students and academics doing research in the region, and for Philippine students and staff studying at SOAS. This will include an Annual Philippine Studies Workshop and publication, an Annual Postgraduate Conference on Southeast Asian Studies, Philippine film screenings, and the digitization of SOAS Philippine materials.

The opening ceremony of the exhibit was held at the DFA lobby and was attended by members of the diplomatic corps, government officials and civil society partners.

In their messages, DFA Undersecretary Linglingay F. Lacanlale, Assistant Secretary Maria Cleofe Natividad and Spanish Ambassador Luis Antonio Castaño Calvo all highlighted the two countries' shared heritage and their multi-faceted and mutually-beneficial partnership.

The guest speaker, Dr. Rene Escalante, Chairman of the National Historical Commission of the Philippines (NHCP), detailed through events and pronouncements in history the long-standing linkages and cooperation between the two countries.

The exhibit had on display 42 photographs from the photographic library of the Spanish news agency EFE, showcasing some highlights in PH-Spain relations such as exchange of high-level visits, signing of agreements and people-to-people exchanges.

The program's activities highlighted the 72 years of PH-UN partnership, particularly the ongoing collaboration towards ensuring that Philippine SDG commitments are pursued and achieved by 2030. The programme also featured cultural performances, including song numbers and folk dances depicting Philippine commitments to SDGs, like protecting people, promoting prosperity, preserving the planet, building peace and forging partnerships.

The UN Day event was attended by senior government and UN officials, members of the diplomatic corps and representatives from the academe and the media. PUBLIC DIPLOMACY

The Department conducts public diplomacy as a means to effectively communicate in a cohesive manner the implementation of Philippine foreign policy, as well as to shape public perception and opinion to secure both domestic and international support for the foreign policy priorities of the Philippines.

The DFA used traditional media through its press releases, photo releases, statements and advisories, while strengthening its online presence with an improved website and increased interaction with the public through social media sites such as Facebook, Twitter, and Youtube.

IMPLEMENTATION OF THE FREEDOM OF INFORMATION (FOI) BILL

The Department received its 2017 FOI Certificate of Compliance for complying with Memorandum Circular No. 2017-01, which provides that the FOI Manual shall be uploaded in the Agency Transparency Seal by 01 October 2017.

Throughout 2017, the Department responded to 24 FOI requests, with seven requests categorized as successful or partially successful. The other requests were either "Awaiting Clarification" or "Denied" due to various reasons such as Incomplete Information, Wrong Agency, under Exceptions List, or Invalid Request.

STEPPING UP PRESS ENGAGEMENT

The Department's Office of Public Diplomacy (OPD), in support of the Office of the Secretary and the Spokesperson of the Department, facilitated the arrangement and conduct of various media events to strengthen the relationship of the DFA with its Press Corps, the Philippine and foreign media.

The Department held a series of press briefings and conferences on ASEAN throughout the Philippine Chairmanship of ASEAN in 2017. Interviews were conducted on various topics including Marawi, passport issues, and assistance to nationals.

Secretary Cayetano hosted an end-of-year lunch and conference with the media on 14 December 2017.

STRENGTHENING THE CONDUCT OF PUBLIC DIPLOMACY

The Department disseminated information to the public through Press Releases, Photo releases, Statements and Advisories using various platforms such as traditional media, the DFA website, Facebook, and Twitter.

GROWING THE DFA VIA ONLINE AND SOCIAL MEDIA

Website

The DFA worked to maximize its online presence, implementing design and layout revisions in its website to make it more visually engaging and user friendly.

Social Media –Facebook, Twitter, Youtube

One of the basic improvements made by the DFA was the verification of Facebook accounts used by the different FSPs. This way, the public is guaranteed that the account he is following or consulting is a verified account of the Department's FSP. Related to this, and as part of the branding project undertaken by the Department in the social media realm, was the push towards uniformity in Facebook handles for all FSPs. To date, all FSPs with verified Facebook accounts are using uniform handles thus making it easier for the public to search for an account aside from the added perceived security.

BRINGING REGIONAL AND MULTILATERAL ENGAGEMENTS TO THE PUBLIC WORLDWIDE, IN "REAL TIME"

With the Philippines hosting ASEAN's golden year, the DFA worked to raise public awareness and deepen public understanding on ASEAN as a regional organization.

The DFA created 479 multimedia collaterals (468 infographics and 11 videos) in the first two months of the year focused on the ASEAN2017 thematic priorities. It created a comprehensive communication and campaign plan to make its efforts in spreading the news about ASEAN more effective.

PROVIDING SUPPORT TO CONSULAR AND OTHER UNITS

To strengthen the Department's frontline services, the DFA embarked on a massive information campaign on its Consular and Assistance to Nationals services by providing information to the public through its digital arm.

The DFA also addressed public sentiments and feedback coursed through the digital media and handled an average of 300-400 queries a day, mostly on consular matters.

ORGANIZATIONAL OUTCOME 2: Overseas Filipinos Protected and Engaged

The DFA continued to look after the welfare of Overseas Filipinos (OFs) by providing various forms of help to distressed OFs, including legal assistance when necessary. Guidelines on the use of the Assistance to Nationals (ATN) Fund were revised in December 2017 to help provide more effective and efficient assistance through the disbursement of the ATN Fund and the Legal Assistance Fund

The DFA also led efforts in pursuing advocacies that seek to ensure the protection of migrants, such as the fight against trafficking in persons.

The various flashpoints in the Middle East region, where millions of Filipinos have found employment, were constantly monitored to ensure that the political and security situation could be adequately responded to by the Philippine government to ensure minimal impact on OFs. Monitoring was expanded to include mapping missions to Caribbean countries.

ASSISTANCE-TO-NATIONALS (ATN)

The DFA was at the forefront of providing timely and efficient relief to overseas Filipinos in distress. Notable operations in 2017 include the following:

Libya

On 26 February 2017, the DFA led a delegation to Tripoli, Libya to take custody of nine Filipinos who were held hostage by ISIS militants in Sirte. They were accompanied to Istanbul, Turkey for a debriefing and medical consultation, and eventually repatriated to the Philippines on 05 March 2017.

Saudi Arabia

The DFA led a high-level delegation which visited the Kingdom of Saudi Arabia (KSA) on 10 August 2016, to meet the needs of Overseas Filipino Workers (OFWs) who were stranded in the work camps of Saudi Oger, MMG, Saudi bin Laden Group, and their subcontractors in Al Khobar, Riyadh, Jeddah, and nearby areas, due mainly to the drop in the price of oil. The Inter-Agency Composite Team, otherwise known as "Operation Bring Them Home," worked towards the repatriation of stranded OFWs.

By June 2017, a total of 5,123 Filipinos were repatriated under the "Operation Bring Them Home" program.

Aside from carrying-out the repatriation, the Department also facilitated the processing of the unpaid wages, end-of-service benefits, and other claims of the said OFWs with their respective Arab employers.

Another repatriation program was initiated as a result of the Kingdom of Saudi Arabia's campaign, "A Nation Without Violations," which allows residency and labor law violators to leave the Kingdom within 90 days, without penalties. The Philippine Government began facilitating the repatriation of Filipinos since the campaign started on 29 March 2017.

An inter-agency team, composed of representatives from the DFA, the Department of Labor and Employment, and the Department of Social Welfare and Development, was deployed to the Kingdom to assist Philippine Foreign Service Posts in processing the repatriation of Filipinos under this "90-Day KSA Mass Amnesty Repatriation" program. By June 2017, a total of 5,145 Filipinos had been repatriated to the Philippines under this program.

Meanwhile, four Filipinos on death row in Saudi Arabia were spared from the imposition of the death penalty following the settlement of their cases.

OFWs Paul Miquiabas, Jr., Victorino Gaspas, Jr., and Eduardo Genetiano were repatriated on 06 March 2017, while OFW Eduardo Oblea was repatriated on 13 March 2017.

Kuwait

On 07-16 August 2017, care packages for over 378 Overseas Filipinos in Kuwait were distributed by the DFA, as well as cash assistance for the 76 detained overseas Filipinos.

Evacuation of Filipinos who were devastated by Hurricanes Irma and Jose

The DFA facilitated the evacuation and eventual repatriation of 136 Filipinos from the British Virgin Islands, Puerto Rico, and Sint Maarten on 14-28 September 2017. The DFA provided voucher assistance for the subsistence of an estimated 600 stranded OFs who were caught in the catastrophe brought on by Hurricanes Irma and Jose.

Abu Dhabi

The DFA facilitated the mass repatriation of 101 distressed OFWs from Abu Dhabi on 01 November 2017, most of whom were alleged victims of human trafficking. All were given cash gift assistance through the ATN fund.

UTILIZATION OF ATN FUND AND LEGAL ASSISTANCE FUND (LAF)

The DFA disbursed a total of Php 556,241,298.31 from the Assistance to Nationals (ATN) Fund, and a total of Php 77,453,582.22 from the Legal Assistance Fund (LAF) from January to December 2017. There were a total of 15,282 beneficiaries of the ATN Fund, and 744 beneficiaries of the Legal Assistance Fund for the period.

MIGRATION GOVERNANCE

The DFA actively participated in Migration and Development initiatives, affirming the Philippines' commitment in maintaining its lead role in migration governance. It articulated and reinforced the Philippine position in migration issues in bilateral, regional, and international fora, with specific focus on the principle of shared responsibility and on the recognition and enforcement of rights of undocumented and inherently vulnerable migrant workers. The DFA participated in the following multilateral and bilateral engagements:

Global Compact for Safe, Orderly, and Regular Migration

Foremost among the DFA's engagements is its pursuit of the adoption of the Global Compact on Safe, Orderly, and Regular Migration (GCM) in 2018. The GCM is envisioned as the first comprehensive instrument that will define and shape a multi-year global migration governance framework through voluntary and actionable commitments of various states.

Among the various meetings and conferences that the DFA attended and/or convened are the following:

- 23-24 August 2017: Two-day Experts Workshop on the Global Compact on Safe, Orderly, and Regular Migration
- 06-08 October 2017: Asia Pacific Regional Preparatory Meeting for the Global Compact for Safe, Orderly, and Regular Migration
- 18-19 October 2017: Multi-Stakeholders meeting on the Global Compact for Safe, Orderly, and Regular Migration
- 02-07 December 2017: Stocktaking Consultation for the Global Compact for Safe, Orderly, and Regular Migration

The Philippines successfully negotiated the provisions of Objective 6, paragraphs 22 (g) and (h) of the Global Compact for Safe, Orderly, and Regular Migration, which make reference to opposition to the khafala system, the infamous employer-sponsored employment scheme widely practiced in the Middle East. The Global Compact will be adopted by States in Morocco in December 2018.

The Philippines, a model country of origin, has sealed a partnership with Bahrain, a GCC model country of destination, in advocating for labor reform in the Middle East.

The Philippines also made headway with the Kingdom of Bahrain as regards reaching into a model labor agreement based on the principles of the Global Compact that will significantly reduce the recruitment costs, protect the rights of Filipino migrant workers, and increase their privileges.

TRAFFICKING IN PERSONS

The DFA assisted a total of 1,476 alleged victims of trafficking in persons in 2017. Of this number, 726 were trafficked to the Middle East, most of whom ended up as household service workers and who experienced various forms of labor exploitation; 615 were trafficked to the Asia and the Pacific Region, 76 to Europe and 59 to the Americas.

On 11 April 2017, the Philippines and the US signed the Child Protection Compact Partnership (CPC), a four-year plan that aims to help address exploitation of children and child labor trafficking. The US will provide USD 3.5 Million in US foreign assistance to non-governmental or international organizations, while the Philippines, through the Inter-Agency Council Against Trafficking, will provide PHP 40 Million to improve the capacity of the government and civil society to prevent online sexual exploitation of children and child labor trafficking from occurring, to provide comprehensive, trauma-informed care for child victims of these crimes, and to prosecute and convict child traffickers.

MAPPING OF OVERSEAS FILIPINOS

The DFA embarks on mapping in order to actively and continually monitor the socio-economic and political conditions that may impact overseas Filipinos.

ATN and Mapping Missions were conducted in the following countries in 2017: Chile, Ecuador, Peru, Aruba, Bermuda, Cayman Islands, Jamaica, Turks and Caicos, Guam, Marshall Islands, Saipan, Palau, Germany, Belgium, Poland, and Denmark.

ORGANIZATIONAL OUTCOME 3: Consular Services Strengthened

In line with the President's directive for government offices to streamline processes and provide better government service, the DFA implemented measures to improve consular services through the drafting of an Executive Order that will enable the opening of additional Consular Offices, working with Congress to extend the validity of the passport, and successfully pursuing ISO 9001 Quality Management System certification for its passport and authentication processes.

REGIONAL CONSULAR OFFICES / SATELLITE OFFICES

Executive Order No. 45, entitled "*Providing for the Reorganization of the Field Offices of the Office of Consular Affairs of the Department of Foreign Affairs*", was signed by the President on 20 October 2017. The EO was drafted by the DFA in order to put in place a legal basis for the opening of additional Consular Offices (CO) and Passport Personalization Centers. Nine sites are planned to be opened in 2018, with the first two planned for San Nicolas, Ilocos Norte and Santiago, Isabela. Each CO will be set up with 10 Data Capturing Machines, effectively increasing the daily capacity of DFA-OCA by 5,600 once all the sites are operational.

In 2017, the DFA continued to sign agreements which base consular offices in malls in strategic locations. Mall-based consular offices make passport services accessible to the wider public and lessen the expenses (transportation, food, etc.) incurred by applicants in travelling.

- CO Cotabato was transferred to the Mall of ALNOR in January 2017
- On 14 September 2017, the DFA and NorthBeacon Commercial Corporation (NBCC) signed the renewal of the Memorandum of Agreement for the NBCC's continued hosting of the DFA's Consular Office at Marquee Mall in Angeles, Pampanga
- On 08 November 2017, the DFA and the Pacific Mall Corporation (PMC) signed the renewal of the Memorandum of Agreement for the PMC's continued hosting of the DFA's Consular Office in Pacific Mall, Lucena City
- CO Tacloban was transferred to Robinsons Place in North Tacloban in December 2017, in accordance with the 2011 Memorandum of Agreement signed between the DFA and Robinsons Land Corporation (RLC)

PASSPORT SERVICES

Upon the instructions of the President, the DFA worked with the Senate and the House of Representatives on the extension of the validity of the Philippine passport. The bill amending RA 8239 passed both the House of Representatives and the Senate in 2017. January 2018 will be the start of implementation of the 10-year validity of passports.

The DFA also streamlined documentary requirements for passport applicants. The revised Passport Application Form and streamlined requirements were designed to make it easier for applicants to comply with application requirements.

To address the increase in demand, the DFA increased its passport production capacity in 2017. There was a remarkable increase in passport issuance by 602,806 passports (19.38%) from 2016 to 2017. This was achieved despite no significant increase in the number of consular offices and staff.

In 2017 alone, DFA produced a total of 3,712,920 passports, of which 2,923,428 were processed in the Philippines.

OTHER SERVICES (VISA, AUTHENTICATION, CONSULAR RECORDS)

The DFA issued 935,572 visas in 2017, which was 35.9% higher than the 2017 target of 600,000, and 28.5% more than the 668,801 visas issued in 2016. Philippine Foreign Service Posts in China issued 881,806 visas in 2017, a 27% increase from the 645,526 visas issued in 2016. The increase was mainly due to more tourist arrivals from China resulting from the Philippines' enhanced relations with the country.

On 10 January 2017, the Authentication Cashiering System went "live". The new system is an electronic solution designed to print invoices and track the delivery time of products and services provided by the Authentication Division. With this system, the registration of the client's information, the computation of fees, and the recording of data are automated.

The DFA also worked with the Asia-Pacific Economic Cooperation (APEC), the Bureau of Immigration (BI), and business groups in the Philippines on the implementation of the APEC Business Travel Card (ABTC) system. The Philippines attended meetings of the APEC Business Mobility Group on 18-21 February 2017 in Vietnam to discuss ways to facilitate the secure and efficient travel of business people of APEC economies.

OVERSEAS VOTING



Overseas Voting (OV) registration for the 2019 National midterm elections for senators and party-list representatives started on 01 December 2016 and will continue until 30 September 2018. Before the start of this registration exercise, the total number of Active Registered Voters were at 1,034,929. This was after COMELEC purged the Certified List of Overseas Voters (CLOV) of those who failed to vote in the last two consecutive elections and those who decided to transfer their registration record back to their Philippine addresses.

From December 2016 to December 2017, the Department's Foreign Service Posts and Local OV Registration Centers processed a total of 404,298 new OV registrants bringing the total active registered OV to 1,439,227, an increase of 39.07%.

In January 2017, the DFA and the Commission on Elections (COMELEC) hosted and organized the signing of the tripartite memoranda of agreement with the Overseas Workers Welfare Administration (OWWA), the Commission on Filipinos Overseas (CFO), and the Maritime Industry Authority (MARINA) for the continuing registration and certification of qualified overseas Filipinos for the 2019 elections. The agreements will allow the above-mentioned agencies to jointly establish Pre-Departure Registration Centers for departing overseas Filipinos, providing accessible overseas voter registration facilities.

The DFA and COMELEC then signed a tripartite memorandum of agreement with the Philippine Overseas Employment Administration (POEA) for the continuing registration and certification of qualified overseas Filipinos for the 2019 elections.

In July 2017, the overseas voting campaign conducted by DFA-OVS, COMELEC and ABS-CBN's The Filipino Channel (TFC) #Vote4ASelfieWorthyPH, was presented with the "Award of Excellence" in the 15th Philippine Quill Awards by the International Association of Business Communicators (IABC) Philippines. The campaign was cited for excellent use of communication in the Corporate Social Responsibility category. Anchored on the selfie phenomenon, it encouraged overseas Filipinos to vote in the 2016 Elections as their vote can make a difference in making the Philippines more "selfie-worthy." Last March 2017, #Vote4ASelfieWorthyPH was also awarded Gold Anvil in the 52nd Anvil awards organized by the Public Relations Society of the Philippines (PRSP).

Meanwhile, two other election projects of the ABS-CBN, the "Ipanalo ang Pamilyang Pilipino: Championing The Filipino Family in the 2016 Philippine National Elections" and the "#Halalan2016 Digital Project" helped in further creating overseas voter awareness here and abroad. DFA actively partnered with ABS-CBN in these campaigns.

From October to November 2017, the DFA established Overseas Voter Registration Centers (OVRCs) at the DFA's Office of Consular Affairs in ASEANA, and at DFA's Satellite Offices in Robinson's Galleria, SM Manila, and Alabang Town Center. These are in addition to existing OVRCs at the Overseas Workers Welfare Administration (OWWA), the Commission on Filipinos Overseas (CFO), the Maritime Industry Authority (MARINA), and the Philippine Overseas Employment Administration (POEA).

In November and December 2017, DFA-OVS planned and implemented the on-site trainings on the amendments to COMELEC Resolution No. 10167, reboot of iREHISTRO and data privacy policy for overseas voting for purposes of the 2019 elections. The on-site training covered the following regions namely Middle East and Africa (Kuwait), Europe (Athens, Greece and Lisbon, Portugal) and Asia Pacific (Vientiane, Laos), Honolulu, Hawaii) and Taiwan (Taipei, Taiwan). One hundred seventy (170) Officers and staff from different Foreign Service Posts (FSPs) and Manila Cultural Economic Offices (MECOs) who act as Administering Officers and, Voter Registration Machine (VRM) Operators attended and participated in the trainings.

The DFA continued to review the Department's structure under the Institutional Strengthening and Productivity Improvement (ISPI) Program to ensure that its structure is aligned with its functions and responsibilities, and allows for organizational effectiveness and efficiency.

Early in the year, the DFA convened the Global Conference of Heads of Post to provide guidance to its key officials, and ensure that the plans and programs of the Department's various units are aligned with the DFA's Strategic Plan, the national development plan, and the priorities of the Duterte Administration.

Various seminars and workshops were offered to DFA employees throughout the year, with the goals of promoting competence, enhancing capabilities in delivering public service, and ensuring wellness among its personnel. The DFA also initiated projects in the areas of property acquisition and development, improvement of physical infrastructure, enhancing cybersecurity, and upgrading its technological systems.

The Department pursued the goal of ISO 9001 Quality Management System certification for its Passport and Authentication Services, to ensure the delivery of quality consular services. The efforts of the DFA resulted in being granted ISO 9001:2008 certification for Authentication services in early 2017, and third-party auditors recommending that it be given ISO 9001:2015 certification for both Passport and Authentication services by year-end.

WELLNESS PROGRAM

In 2017, the Department completed a review of its guidelines on Honorary Consular Officers, with the aim of creating an environment conducive for Philippine Honorary Consuls to respond to today's modern challenges and realities in the field of consular services, economic diplomacy, and assistance to nationals.

FINANCE

As of 29 December 2017, the DFA's Budget Utilization Rate (BUR) was at 90.98% of its 2017 Allotment of PhP 8.1 Billion and 71.03% of its 2016 Continuing Allotment of PhP 3.0 Billion. Obligations BUR is computed as total obligations excluding Personnel Services (PS) against total appropriate from all services both current and continuing year for FY 2017.

SYSTEMS AND PROCESSES

Quality Management System

On 06 January 2017, the DFA was granted ISO 9001:2008 Quality Management System (QMS) certification for its authentication services. Authentication, commonly known as "red ribbon", is the act of establishing or confirming that an official act of a notary public or certifying officer is genuine or authentic, for use as an instrument of evidence in a foreign country.

Throughout 2017, the DFA worked towards expanding the scope of its QMS to include its passport services. It also upgraded its QMS to comply with the new ISO 9001:2015 standards, in its effort towards continual improvement.

Internal Audit

The DFA's Internal Audit Service advises the Secretary of Foreign Affairs on matters relating to management control and operations audit for the strengthening the Department's internal control systems, improvement of existing systems and procedures, and promoting transparency and accountability.

The Department conducted Compliance and Management Audits and Operations Audits in five Regional Consular Offices and in seven Foreign Service Posts.

On 27 January 2017, the Department organized the *Seminar on National Guidelines on Internal Control System and Rules on Accountability*, which was attended by 80 Heads of Post and accountable officers in the Home Office.

INFRASTRUCTURE

Building Fund Program

Owning properties abroad to serve as Chanceries and/or Official Residences with upgraded premises and facilities is consistent with the Department's commitment to improve the quality of its services that will redound to the benefit of Filipinos and other clientele overseas.

The Department's Building Fund was utilized for the acquisition of properties in Milan, Nairobi, and Rome, and for the repair, renovation, and refurbishment of government-owned properties in Berlin, Berne, New York, Ottawa, Paris, Sydney, Singapore, Tokyo, Washington D.C., and Wellington, among others.

Car Re-fleeting Program for Foreign Service Posts

The Program aims to improve the current vehicle inventory of Foreign Service Posts, which is essential to the efficient delivery of services and fulfillment of official duties and functions.

In 2017, the Department procured nineteen vehicles for its Foreign Service Posts.

Cybersecurity

With the implementation of the DFA Advance Cybersecurity Solution, the Department was able to monitor and mitigate external and internal threats and attacks to its ICT assets.

Enterprise Resource Planning System (ERPS)

The DFA continued and renewed the implementation of the Enterprise Resource Planning System (ERPS) — Enterprise Content Management System (ECMS) to its four (4) pilot Administrative offices.

The DFA also procured and implemented three (3) additional Information Systems namely, the Human Resource Management Information System (HRMIS), the Payroll and Benefits Management Information System (PBMtS), and the Property and Inventory Management Information System (PIMIS). These Information Systems aim to streamline and facilitate Administrative functions / operations and ensure that personnel data and relevant information are sourced from single database.

POLICY PLANNING

Global Conference of Heads of Post


At the beginning of his presidency, President Duterte committed to institute changes in the country's governance, including the elimination of the drug menace and criminality, rooting out corruption in government, pursuing the peace process, and enhancing the country's security by forging friendly relations and closer engagement with its non-traditional allies with the ultimate goal of improving the lives of Filipinos. The DFA plays an important and multi-faceted role in the realization of these commitments, as its Foreign Service Posts serve as the country's primary agents in bringing the Philippine agenda forward in the international arena.

In order for the Department and the Foreign Service Posts to effectively respond to the needs of the government, it is imperative that the government's policy directions and thrusts are substantially communicated and understood. For this purpose, the DFA convened the Global Conference of Heads of Post from 30 January to 02 February 2017 in Makati City, only the second activity of its kind since the first Conference held in March 2007. The Conference adopted as its theme the Department's vision of "A resilient foreign service for a strong Philippines." Heads of Philippine Foreign Service Posts, heads and key officers of the Department, and officials from partner agencies attended the four-day event.

Briefings on specific segments were led by the Department's Undersecretaries and officials as well as officials of concerned agencies particularly the National Economic Development Authority, the National Security council, the Office of the Cabinet Secretary, and Office of the Presidential Adviser on the Peace Process. The program revolved around the DFA Strategic Plan which was approved by the Secretary on 15 August 2016 and submitted to the President on 15 September 2016. The Strategic Plan sessions were divided into the following segments on national security, economic security, civilian security, cultural diplomacy, assistance to nationals, consular services, public diplomacy, and organizational development. With the Philippines as chair of ASEAN in 2017, a module on how the Department could use ASEAN to leverage Philippine national interests was also conducted.

The conference participants also met with their respective geographic offices to discuss their respective roles and concerns related to the implementation of the DFA Strategic Plan, and to come up with their regional plans, which were presented to the plenary.


