With reference to <u>CIR-688-HRMO-2025</u> dated 28 March 2025, regarding the final reminder on the submission of 2024 Statement of Assets, Liabilities, and Net Worth (SALN), you are kindly reminded to submit three (3) originals of your duly accomplished SALN as of 31 December 2024 to HRMO on or before Thursday, 19 June 2025. Please ensure that your date of signing and the date on the subscribed and sworn statement are dated not later than 30 April 2025.

It is crucial to emphasize that the timely and complete submission of the 2024 SALN is a prerequisite for eligibility for the FY 2024 Performance-Based Bonus (PBB). Failure to submit your 2024 SALN may result in disqualification from receiving the FY 2024 PBB.

Furthermore, non-compliance with SALN submission deadlines constitutes a less grave offense under Rule 10, Section 50 D(8) of the 2017 Rules on Administrative Cases in the Civil Service (2017 RACCS). Penalties for such offenses include suspension ranging from one (1) month and one (1) day to six (6) months for the first offense, and dismissal from the service for subsequent offenses.

Your attention to this matter is highly appreciated for compliance and adherence to established Civil Service rules and regulations.
