- The Committee made the following clarifications:
  - One tenth of the cost of shipping of each parcel per working day of delay is calculated for liquidated damages and not the value of the parcel.
  - o There shall be no bid price included in the first envelope.

- o Certified True Copies (CTSs) of documents are considered original.
- The End-User will reevaluate on the Estimated Shipment per day.
- After reevaluation, if the End-User deem it necessary to change the quantities
  of estimated shipment per day, a Supplemental / Bid Bulletin will be posted to
  reflect the changes in the Terms of Reference.
- The schedule of activities will be as follows:
  - Submission and Receipt of Bids 26 March 2020, 9:00 a.m.
  - o Bid Opening 26 March 2020, 10:00 a.m.
  - o Post-Qualification 31 March 2020, 10:00 a.m.
