AGREEMENT FOR THE PREVENTIVE MAINTENANCE SERVICE OF SIX (6) UNITS HITACHI ELEVATORS AT MAIN BUILDING FOR C.Y. 2021

KNOW ALL MEN BY THESE PRESENTS:

This Agreement for the Department of Foreign Affairs' (DFA) for the modernization/upgrade service of six (6) units Hitachi elevators at main building (hereinafter, the AGREEMENT), entered into in Pasay City, Philippines, on 1 JAN 2022 between the:

Gil Puyat Ave., BEL-AIR, Makati City, represented by ASUNCION P. MANALO, who is duly authorized to enter into this Agreement pursuant to the Secretary's Certificate dated 25 September 2020, copy of which is attached as ANNEX "B" and made an integral part of this AGREEMENT.

WITNESSETH:

WHEREAS, the PROCURING ENTITY awarded to the Contractor, being the exclusive distributor and maintenance service provider of Hitachi Brand Elevators in the Philippines, the Department's preventive maintenance services of six (6) units Hitachi elevators in the premises of the "Procuring Entity" for twelve (12) months, and has accepted a bid by the CONTRACTOR to provide the said services in the amount of FORTY THOUSAND FIVE HUNDRED PESOS ONLY (PHP 40,500.00) inclusive of 12% VAT per month or a total contract price of FOUR HUNDRED EIGHTY SIX THOUSAND PESOS ONLY (PHP 486,000.00) only (hereinafter, the Contract Price) inclusive of all applicable taxes and other lawful charges.

WHEREAS, this Agreement, undertaken pursuant to BAC Resolution No. <u>NTC 03-21</u> dated <u>01 January 2021</u>, and Notice of Award (ANNEX "C"), complies with the applicable provisions of the Republic Act No. 9184 and its Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing premises, the PARTIES agree as follows:

- 4. The CONTRACTOR shall ensure that each of its personnel assigned in the Department shall execute and sign a Non-Disclosure Agreement which is to be submitted to the Department prior to commencement of the service.
- 5. For and in consideration of the performance of services, the PROCURING ENTITY shall pay the CONTRACTOR the above-mentioned Contract Price. The terms of payment shall be in accordance to Clause X in the Terms of Reference.
