BAC Resolution No. (OCA) 56- 21

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF AIR PURIFIERS OF CONSULAR OFFICE (CO)- CALASIAO

WHEREAS, the Consular Office (CO)-Calasiao intends to procure the supply and delivery of five (5) units of air purifiers for its official use;

WHEREAS, CO Calasiao's procurement of five (5) units of air purifiers, with an Approved Budget for the Contract (ABC) in the amount of *Sixty-Four Thousand Nine Hundred Seventy-Five Pesos* (PhP 64,975.00) only, is included in the Department's Supplemental Annual Procurement Plan (SAPP) for CY 2021;

WHEREAS, Section 53.9 of the 2016 revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2003, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website for three (3) days, starting on 11 June to 14 June 2021;

WHEREAS, the CO-Calasiao submitted to the OCA-Bids and Awards Committee (OCA-BAC) quotations from five (5) different suppliers/companies, namely: the *AirTech Engineering Services* (PhP 79,380.00; failed, quotation price is beyond the ABC and bidder is not compliant with the technical specifications); the *Saver's Electronic World, Inc* (PhP 37,490.00; failed, quoted price is within the ABC but bidder is not compliant with the technical specifications), the *Pacific Office Solutions, Inc.* (PhP 59,990.00; failed, bidder did not submit a formal quotation), *Hartly Electronics Trading* (PhP 64, 975.00; failed, bidder submitted late) and the *Robinson's Handyman, Inc. (Handyman Do It Best)*, which submitted the lowest calculated and

responsive quotation in the amount of *Sixty-Four Thousand Nine Hundred Seventy-Five Pesos* (PhP 64,975.00) only;

NOW, THEREFORE, we, the members of the OCA-Bids and Awards Committee of the Department, **RESOLVE** to **RECOMMEND** to the Head of the Procuring Entity (HOPE) the resort to Negotiated Procurement (Small Value Procurement) as the alternative method of procurement of five (5) units of air purifiers of CO Calasiao from the *Robinson's Handyman, Inc. (Handyman Do It Best)*, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
