RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF SUPPLIES OF MAINTENANCE PARTS FOR THE OFFICIAL VEHICLES OF THE OFFICE OF CONSULAR AFFAIRS (OCA) – ASEANA

WHEREAS, the Office of Consular Affairs (OCA) – ASEANA intends to procure the supplies of maintenance parts for its official vehicles;

WHEREAS, OCA-ASEANA's procurement of supplies of maintenance parts for its official vehicles, with an Approved Budget for the Contract (ABC) in the amount of *Two Hundred Seven Thousand Three Hundred Pesos* (PhP 207,300.00) only, chargeable against the OCA-ASEANA's FY 2021 MOOE-Repairs and Maintenance – Motor Vehicles, is included in the Department's Annual Procurement Plan (APP) for CY 2021;

WHEREAS, Section 53.9 of the 2016 revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2003, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof:

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, the OCA-ASEANA submitted to the OCA-Bids and Awards Committee (OCA-BAC) quotations from five (5) different suppliers/companies, namely: the *Excellente Enterprises* (PhP 207,090.00), the *Rodmanes Trading* (PhP 203,800.00), the *EGMJ Trading* (PhP 198,010.00), the *Mendo Enterprises* (PhP 151,765.00); failed, did not pass a formal quotation with company letterhead, and the *Fuzionic Marketing* (PhP 197,095.00), which submitted the lowest calculated and responsive quotation in the amount of *One Hundred Ninety-Seven Thousand Ninety-Five Pesos* (PhP 197,095.00) only;

NOW, THEREFORE, we, the members of the OCA-Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity (HOPE) the resort to Negotiated Procurement (Small Value Procurement) as the alternative method of procurement of the supplies of maintenance parts for the official vehicles of OCA-ASEANA from *Fuzionic Marketing*, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
