BAC Resolution No. NTC - 02 - 21

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT FOR THE PRINTING AND PUBLISHING OF THE *OPENING FOREIGN SERVICE POSTS A GUIDEBOOK*

WHEREAS, the Undersecretary for Administration (UA) intends to procure services for the printing and publishing of one hundred (100) copies of *Opening of Foreign Service Posts A Guidebook*;

WHEREAS, the procurement for the printing and publishing of said guidebook by the UA, with an Approved Budget for the Contract (ABC) in the amount of One Hundred Thousand Pesos (PhP 100,000.00) only, is included in the Department's Annual Procurement Plan (APP) for CY 2021;

WHEREAS, Section 53.9 of the 2016 revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website for three (3) days, starting on 23 February 2021;

WHEREAS, the UA sent requests for quotations to three (3) different companies, namely: the Lumandas Printing Services (did not submit a quotation), the S.D. Leal Graphics (PhP 53,040.00), and the Color1 Digital, Inc. (PhP 37,500.00); and received fourteen (14) quotations from PhilGEPS, namely: the Click to Print High Street Corp. (PhP 66,200.00), the Innovation Printshoppe, Inc. (PhP 25,980.00), the VJ Graphic Arts, Inc. (PhP 34,800.00), the Ornel Bookbinding & Printing (PhP 39,000.00; failed; did not pass the Technical Specifications; the Dolmar Press Inc. (PhP 46,000.00), the Qualipress Printing Services (PhP 50,000.00), the Regencia Printing Services (PhP 50,000.00), the Progressive Printing Palace Inc.
