BAC Resolution No. (NTC) 14 – 21

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF THREE HUNDRED TWENTY (320) KITS FOR THE OFMS PERSONNEL REFRESHER COURSE

WHEREAS, the Office of Fiscal Management Services (OFMS) intends to procure three hundred twenty (320) kits for the OFMS 2021 Personnel Refresher Course;

WHEREAS, the procurement of three hundred twenty (320) kits by the OFMS, with an Approved Budget for the Contract (ABC) in the amount of One Hundred Thirty Thousand Pesos (Php 130,000.00) only, is included in the Department's Annual Procurement Plan (APP) for CY 2021;

WHEREAS, Section 53.9 of the 2016 revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website for three (3) days, starting on 04 March 2021;

WHEREAS, the OFMS submitted to the Bids and Awards Committee (BAC) quotations from four (4) different companies, namely: the All Source Products Corporation (did not submit a quotation), Compuzel Enterprises (PhP 94,400.00; failed; did not meet the Technical Specifications), St. Pio Printing Services (PhP 128,000.00;

failed; did not meet the Technical Specifications) and the **E.E.L Garments Manufacturing Co.**, which submitted the lowest calculated and most responsive quotation in the amount of *One Hundred Twenty-Four Thousand Eight Hundred Pesos (PhP 124,800.00)* only;

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity (HOPE) to resort to Negotiated Procurement as the alternative method of procurement of three hundred twenty (320) kits for the OFMS Personnel Refresher Course from the **E.E.L Garments Manufacturing Co.**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.


