BAC Resolution No. (NTC) 31 - 21

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF TEN (10) UNITS OF EXECUTIVE CHAIRS FOR THE OFFICIAL USE OF THE OFFICE OF THE SECRETARY

WHEREAS, the Office of the Secretary (OSEC) intends to procure ten (10) units of executive chairs for its official use;

WHEREAS, the procurement of said chairs by the OSEC, with an Approved Budget for the Contract (ABC) in the amount of One Hundred Thirty Thousand Pesos (PhP 130,000.00) only, is included in the Department's Annual Procurement Plan (APP) for CY 2021;

WHEREAS, Section 53.9 of the 2016 revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website for three (3) days, starting on 13 April 2021;

WHEREAS, the OSEC submitted to the Bids and Awards Committee (BAC) quotations from eighteen (18) different companies, namely: 1.) the Asahi Design Centre Inc. (PhP 89,980.00), 2.) the Aurora (O.A.) Philippines, Inc. (PhP 110,580.00; failed; did not meet the technical specifications), 3.) the Coach Concepts & Office Furnishings, Inc. (PhP 127,000.00; failed; did not meet the technical specifications), 4.) the Cubix Office Inc. (PhP 80,000.00; failed; did not meet the technical specifications), 5.) the FilCrafters Inc. (PhP 120,000.00; failed; did not meet the technical specifications), 6.) the Gentleprince Inc. (PhP 64,750.00; failed; did not meet the technical specifications), 7.) the Henrose Marketing (PhP 125,212.50; failed; did not meet the technical specifications), 8.) the IKF Home Furnishings and Office Furnitures (PhP 26,990.00; failed; did not provide technical specifications despite request), 9.) the New A.G. Stylist Furniture (PhP 95,000.00), 10.) the Numenlex Corporation (PhP 91,000.00; failed did not meet the technical specifications), 11.) the Primewave Enterprises Inc. (PhP 105,000.00; failed; did not meet the technical specifications), 12.) the Realform Furniture Shop (PhP 120,689.66), 13.) the See Manufacturing Contractor (PhP 68,000.00; failed; did not meet the technical specifications), 14.) the Tadashitec Global Company (PhP 100,470.00; failed; did not meet the technical specifications), 15.) the A4 Luck Marketing Corp. (PhP 91,000.00; failed; did not meet the technical specifications), 16.) the Furn Apt Design Corporation (PhP 86,891.25), 17.) the Design Excellence (did not submit a quotation) and the **Peniton Trading**, which submitted the lowest calculated and most responsive quotation in the amount of *Seventy-Three Thousand Pesos* (PhP 73,000.00) only;

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity (HOPE) to resort to Negotiated Procurement as the alternative method of procurement of the aforementioned chairs from the **Peniton Trading**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.


