BAC Resolution No. NTC 35 - 21

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF ACRYLIC FACE SHIELDS FOR THE OFFICIAL USE OF THE OFFICE OF FISCAL MANAGEMENT AND SERVICES (OFMS)

WHEREAS, the Office of the Fiscal Management and Services (OFMS), intends to procure the supply and delivery of one hundred seventy (170) pieces of acrylic face shields for its official use;

WHEREAS, the procurement of acrylic face shields by the OFMS with an Approved Budget for the Contract (ABC) in the amount of *Fifty-One Thousand Pesos* (Php 51,000.00) only, is included in the Department's Supplemental Annual Procurement Plan (SAPP) for CY 2021;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website for three (3) days, starting on 22 April 2021 to 26 April 2021;

WHEREAS, the OFMS submitted to the Bids and Awards Committee (BAC) abstract of quotations from nine (9) different companies, namely: the Aljon International Corporation (Php 47,600.00), the Nicatto Events and Marketing (Php 24,990.00), the Azitorsog Inc High-End ID Solutions (Php 47,430.00), the ACE-Jsummit Innovations Inc (Php 28,900.00), the Big Vision International Trade and Industries Corp. (Php 49,980.00), the Glover Technologies Corporation (Php 25,500.00), the First Choice Industrial Safety Corporation (Php 42,500.00), the Glasdon Supply Inc (Php 25,500.00) and the **Ban Bee Commercial Co. Inc. (BanBee)** which

submitted the lowest calculated and responsive quotation in the amount of *Twelve Thousand Nine Hundred Twenty Pesos* (Php 12,920.00) only;

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity (HOPE) to resort to Negotiated Procurement as the alternative method of procurement of acrylic face shields from the **Ban Bee Commercial Co. Inc (BanBee)** subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
