BAC Resolution No. NTC (PB) – 25 – 21

**RESOLUTION RECOMMENDING AWARD OF THE
CONTRACT ON DATA CENTER REHABILITATION SERVICES**

WHEREAS, the Department of Foreign Affairs, through the authorized appropriations under the 2021 General Appropriations Act (GAA), intends to apply the sum of Six Million Pesos (*PhP 6,000,000.00*) only, being the Approved Budget for the Contract (ABC) for the *Procurement of Data Center Rehabilitation Services*;

WHEREAS, the ABC is chargeable against OAMSS' FY 2021 Capital Outlay – Information and Technology Equipment;

WHEREAS, on 4 December 2021, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the *Invitation to Bid* for the *Procurement of Data Center Rehabilitation Services* on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 13 December 2021, the BAC held a *Pre-Bid Conference*, to discuss the eligibility requirements and the technical and financial components of the contract to be bid, which was attended by Pronet Systems Integrated Network Solutions, Inc.;

WHEREAS, Supplemental/Bid Bulletin No. 1 (14 December 2021), amending and clarifying information in the bidding documents, were posted on the PhilGEPS and DFA websites for at least seven (7) consecutive days before the deadline for submission and opening of bids, pursuant to Section 22.5.2 of the IRR of RA 9184;

WHEREAS, on 27 December 2021, the deadline for the submission and receipt of bids as well as the date of opening thereof, only Pronet Systems Integrated Network Solutions, Inc. submitted a bid, the details of which are as follows:

WHEREAS, the BAC declared *Pronet Systems Integrated Network Solutions, Inc.* as having the Single Lowest Calculated Bid, and subjected it to Post-Qualification on 29 December 2021, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether

it complies with and is responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the post-qualification of bids and after careful consideration, the BAC determined that the bid of **Pronet Systems Integrated Network Solutions, Inc.** was compliant with and is responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the contract for the Procurement of Data Center Rehabilitation Services to **Pronet Systems Integrated Network Solutions, Inc.** for having submitted the Single Lowest Calculated and Responsive Bid in the amount of **Five Million Nine Hundred Twenty-One Thousand Two Hundred Forty Pesos (PhP 5,921,240.00)** only, pursuant to Section 37 of the revised IRR of RA 9184.


