RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON PROCUREMENT OF PURIFIED DRINKING WATER SUPPLY FOR THE DEPARTMENT OF FOREIGN AFFAIRS FOR 2022

WHEREAS, the Department of Foreign Affairs, through the authorized appropriations under the FY 2022 National Expenditure Program (NEP), intends to apply the sum of One Million Four Hundred Ninety-Seven Thousand Six Hundred Pesos (*PhP 1,497,600.00*) only – the Approved Budget for the Contract (ABC) for the *Procurement of Purified Drinking Water Supply for the Department of Foreign Affairs;*

WHEREAS, the ABC is chargeable against OAMSS' FY 2022 MOOE – for Water Expenses;

WHEREAS, on 09 November 2021, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the *Invitation to Bid* for the *Procurement of Purified Drinking Water Supply for the Department of Foreign Affairs for 2022* on the DFA and PhilGEPS websites, and at conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 16 November 2021, the BAC held a *Pre-Bid Conference*, to discuss the eligibility requirements and the technical and financial components of the contract to be bid, in which three (3) prospective bidders attended namely: Aquasure Water Trading, Daco Sales Corporation, and Golden Tiger Water Refilling Station;

WHEREAS, Supplemental/Bid Bulletin No. 1 (09 November 2021), amending and clarifying information in the bidding documents, was posted on the PhilGEPS and DFA websites for at least seven (7) consecutive days before the deadline for submission and opening of bids, pursuant to Section 22.5.2 of the IRR of RA 9184

WHEREAS, on 29 November 2021, the deadline for the submission and receipt of bids as well as the date of opening thereof, only Daco Sales Corporation submitted a bid which the BAC determined to be as follows:

WHEREAS, the BAC declared *Daco Sales Corporation* as having the Single Lowest Calculated Bid, and subjected it to Post-Qualification on 03 December 2021, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complied with and was responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the post-qualification of bids and after careful consideration, the BAC determined that the bid of *Daco Sales Corporation* was compliant with and responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the Contract on Purified Drinking Water Supply for the Department of Foreign Affairs for 2022 to Daco Sales Corporation for having submitted the Single Lowest Calculated and Responsive Bid in the amount of One Million Four Hundred Eight Thousand Six Hundred Eighty Pesos (PhP 1,408,680.00) only, pursuant to Section 37 of the revised IRR of RA 9184.
