RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON PROCUREMENT OF REPLACEMENT OF ESCALATORS AND ELEVATORS FOR OCA BUILDING – ASEANA

WHEREAS, the Department of Foreign Affairs, through the authorized appropriations under the FY 2021 Building Fund for Building, intends to apply the sum of Thirty-Two Million Pesos (*PhP 32,000,000.00*) only – the Approved Budget for the Contract (ABC) for the *Procurement of Replacement of Escalators and Elevators for OCA Building-Aseana*, which is included in the Department's Annual Procurement Plan (APP) for CY 2021;

WHEREAS, on 08 June 2021, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the *Invitation to Bid* for the *Procurement of Replacement of Escalators and Elevators for OCA Building-Aseana* on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 15 June 2021, the BAC held a *Pre-Bid Conference*, to discuss the eligibility requirements and the technical and financial components of the contract to be bid, in which three (3) prospective bidders attended namely, Dex International, Co., IFE Elevators Philippines, Inc., and MAKO Teknomecaniques Inc.;

WHEREAS, on 23 June 2021, the BAC posted a Supplemental/Bid Bulletin No. 1, amending and clarifying information in the bidding documents, that were posted on the PhilGEPS and DFA websites for at least seven (7) consecutive calendar days before the deadline for submission and opening of bids, pursuant to Section 22.5.2 of the IRR of RA 9184;

WHEREAS, on 7 July 2021, the deadline for the submission and receipt of bids as well as the date of opening thereof, two (2) bidders, namely, Dex International Co., and IFE Elevators Philippines, Inc. submitted their respective bids which the BAC determined to be as follows:

WHEREAS, the BAC declared *Dex International Co.,* as having the Lowest Calculated Bid, and subjected it to Post-Qualification on 13 July 2021, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complies with and is responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, on 23 July 2021, the TWG and the end-user representatives conducted an ocular inspection of Dex International Co.'s office and its completed projects, the results of which proved its technical capacity to undertake the project;

WHEREAS, during the post-qualification of bids and after careful consideration, the BAC determined that the bid of *Dex International Co.* was compliant with and is responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the contract for the Procurement of Replacement of Escalators and Elevators for OCA Building-Aseana to **Dex International Co.** for having submitted the Lowest Calculated and Responsive Bid in the amount of **Twenty-Eight Million Four Hundred Eighty-Eight Thousand Eight Hundred Eighty Pesos (PhP 28,488,880.00)** only, pursuant to Section 37 of the revised IRR of RA 9184.
