**BAC Resolution No. NTC (PB) – 26 – 21**

**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON  
PROCUREMENT OF JANITORIAL SERVICES FOR 2022**

**WHEREAS**, the Department of Foreign Affairs, through the authorized appropriations under the FY 2022 National Expenditure Program (NEP), intends to apply the sum of Fifty-Five Million Two Hundred Fifty Thousand Pesos (*PhP 55,250,000.00*) only – the Approved Budget for the Contract (ABC) for the *Procurement of Janitorial Services for 2022*;

**WHEREAS**, the ABC is chargeable against OAMSS' FY 2022 MOOE – for Janitorial Services;

**WHEREAS**, on 3 November 2021, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the **Invitation to Bid** for the *Procurement of Janitorial Services for 2022* on the DFA and PhilGEPS websites, and at conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

**WHEREAS**, on 10 November 2021, the BAC held a **Pre-Bid Conference**, to discuss the eligibility requirements and the technical and financial components of the contract to be bid, in which three (3) prospective bidders attended namely: Omniworx Inc., Starcom Manpower & Allied Services, Inc., and CBII Philippines International, Inc.;

**WHEREAS**, on 23 November 2021, the deadline for the submission and receipt of bids as well as the date of opening thereof, only CBII Philippines International, Inc. submitted a bid which the BAC determined to be as follows:

**WHEREAS**, the BAC declared **CBII Philippines International, Inc.** as having the Single Lowest Calculated Bid, and subjected it to Post-Qualification on 26 November 2021, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complied with and was responsive to all the requirements and conditions specified in the Bidding Documents;

**WHEREAS**, during the post-qualification of bids and after careful consideration, the BAC determined that the bid of **CBII Philippines International, Inc.** was compliant with and responsive to all the requirements and conditions specified in the Bidding Documents;

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award the Contract on Janitorial Services for 2022 to **CBII Philippines International, Inc.** for having submitted the Single Lowest Calculated and Responsive Bid in the amount of **Fifty-Five Million Sixty-Seven Thousand Eight Hundred Ninety-Two Pesos and Ninety-Nine Centavos (PhP 55,067,892.99)** only, pursuant to Section 37 of the revised IRR of RA 9184.
