BAC Resolution No. NTC (PB) – 32 – 21

**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON
2022 SECURITY SERVICES FOR THE DEPARTMENT OF FOREIGN AFFAIRS**

WHEREAS, the Department of Foreign Affairs, through the authorized appropriations under the FY 2022 National Expenditure Program (NEP), intends to apply the sum of One Hundred Fifty-Nine Million One Hundred Twenty-Seven Thousand Six Hundred Seventy-Eight Pesos and Sixty-Six Centavos (*PhP 159,127,678.66*) only, being the Approved Budget for the Contract (ABC) for the *Procurement of 2022 Security Services for the Department of Foreign Affairs*;

WHEREAS, the said Approved Budget for the Contract is chargeable against OAMSS and OCA's FY 2022 MOOE – Security Services;

WHEREAS, on 23 November 2021, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the *Invitation to Bid* for the *Procurement of 2022 Security Services for the Department of Foreign Affairs* on the DFA and PhilGEPS websites, and at conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 2 December 2021, the BAC held a *Pre-Bid Conference*, to discuss the eligibility requirements and the technical and financial components of the contract to be bid, in which four (4) prospective bidders attended namely: AGF Security Agency Corporation, NC Lanting Security Specialist Agency, Lockheed, and JSL Security Agency, Inc.;

WHEREAS, on 15 December 2021, the deadline for the submission and receipt of bids as well as the date of opening thereof, only NC Lanting Security Specialist Agency submitted a bid which the BAC determined to be as follows:

WHEREAS, the BAC declared *NC Lanting Security Specialist Agency* as having the Single Lowest Calculated Bid, and subjected it to Post-Qualification on 20 December 2021, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether

it complied with and was responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the post-qualification of bids and after careful consideration, the BAC determined that the bid of **NC Lanting Security Specialist Agency** was compliant with and responsive to all the requirements and conditions specified in the Bidding Documents;


NOW, THEREFORE, we, the members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the *Contract on 2022 Security Services for the Department of Foreign Affairs* to **NC Lanting Security Specialist Agency** for having submitted the Single Lowest Calculated and Responsive Bid in the amount of **One Hundred Forty-Nine Million Sixty Seven Thousand Two Hundred Eighty-Seven Pesos and Thirteen Centavos (Php 149,067,287.13)** only, pursuant to Section 37 of the revised IRR of RA 9184.
