**BAC Resolution No. NTC (PB) – 06 – 21**

**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON THE  
NEGOTIATED PROCUREMENT OF ONE (1) MOTOR VEHICLE FOR THE  
SECRETARY OF FOREIGN AFFAIRS**

**WHEREAS**, the Department of Foreign Affairs, through the Office of Asset Management and Support Services (OAMSS), intends to apply the sum of One Million Eight Hundred Thousand Pesos (*PhP 1,800,000.00*) only, from the Department's FY 2020 Continuing Appropriations, as the Approved Budget for the Contract (ABC) for the *Negotiated Procurement of One (1) Motor Vehicle for the Secretary of Foreign Affairs*;

**WHEREAS**, on 17 March 2021, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the ***Invitation to Bid*** for the *Negotiated Procurement of One (1) Motor Vehicle for the Secretary of Foreign Affairs* on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

**WHEREAS**, on 24 March 2021, the deadline for the submission and receipt of bids as well as the date of opening thereof, one (1) bidder, namely, North Luzon Autocity, Inc., submitted its bid which the BAC determined to be as follows:

**WHEREAS**, the BAC declared ***North Luzon Autocity, Inc.***, as having the Lowest Calculated Bid, and subjected it to Post-Qualification on 29 March 2021, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complies with and is responsive to all the requirements and conditions specified in the Bidding Documents;

**WHEREAS**, due to the implementation of the Enhanced Community Quarantine in Metro Manila and a full work-from-home arrangement for the entire Department from 29 to 31 March 2021, the BAC Secretariat issued a Notice postponing the scheduled post-qualification conference from 29 March to 5 April 2021;


**WHEREAS**, during the Post-Qualification Conference held on 5 April 2021, after careful evaluation and consideration, the BAC determined that the bid of **North Luzon Autocity, Inc.** was compliant with and is responsive to all the requirements and conditions specified in the Bidding Documents;

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the contract for the Negotiated Procurement of One (1) Motor Vehicle for the Secretary of Foreign Affairs to **North Luzon Autocity, Inc.**, for having submitted the Single Lowest Calculated and Responsive Bid in the amount of **One Million Eight Hundred Thousand Pesos (Php 1,800,000.00)** only, pursuant to Section 37 of the revised IRR of RA 9184.




