BAC Resolution No. NTC (PB) – 15 – 21

RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON THE
NEGOTIATED PROCUREMENT OF LOYALTY PINS AND FALSA MEDALS AND
PINS

WHEREAS, the Department of Foreign Affairs, through the authorized appropriations under the 2021 General Appropriations Act (GAA), intends to apply the sum of Six Million Three Hundred Fifty Thousand Pesos (PhP 6,350,000.00) only, being the Approved Budget for the Contract (ABC) for the *Negotiated Procurement of Loyalty Pins and FALSA Medals and Pins*;

WHEREAS, the said Approved Budget for the Contract is HRMO's 2021 MOOE for Representation Expenses;

WHEREAS, on 7 July 2021, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the *Invitation to Bid* for the *Negotiated Procurement of Loyalty Pins and FALSA Medals and Pins* on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 14 July 2021, the deadline for the submission and receipt of bids as well as the date of opening thereof, two (2) bidders, namely R&J Jewelry Class Ring & Metalcraft Inc. and Laricel's Jewelry, submitted their respective bids which the BAC determined to be as follows:

<i>Laricel's Jewelry</i>	Compliant	Five Million Nine Hundred Eighty-Three Thousand Nine Hundred Seventy-Five Pesos (PhP 5,983,975.00)

WHEREAS, the BAC declared *Laricel's Jewelry* as having the Lowest Calculated Bid. The BAC determined that the bid of *Laricel's Jewelry* was compliant with and is responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the contract for the Negotiated Procurement of Loyalty Pins and FALSA Medals and Pins to **Laricel's Jewelry** for having submitted the Lowest Calculated and Responsive Bid in the amount **Five Million Nine Hundred Eighty-Three Thousand Nine Hundred Seventy-Five Pesos (PhP 5,983,975.00)** only, pursuant to Section 37 of the revised IRR of RA 9184.
