**BAC Resolution No. NTC (PB) – 10 – 21**

**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON  
PROCUREMENT OF FLAGS AND SIMILAR SUPPLIES FOR THE DEPARTMENT OF  
FOREIGN AFFAIRS**

**WHEREAS**, the Department of Foreign Affairs, through the authorized appropriations under the 2021 General Appropriations Act (GAA), intends to apply the sum of Five Million Three Hundred Ninety Thousand Six Hundred Seventy-Five Pesos (PhP 5,390,675.00) only, being the Approved Budget for the Contract (ABC) for the *Procurement of Flags and Similar Supplies for the Department of Foreign Affairs*;

**WHEREAS**, the said Approved Budget for the Contract is chargeable against the various offices' FY 2021 MOOE – Other Supplies and Materials Expenses;

**WHEREAS**, on 19 May 2021, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the **Invitation to Bid** for the *Procurement of Flags and Similar Supplies for the Department of Foreign Affairs* on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

**WHEREAS**, on 26 May 2021, the BAC held a **Pre-Bid Conference**, to discuss the eligibility requirements and the technical and financial components of the contract to be bid, in which one (1) prospective bidder attended namely, Atlas Super Flags;

**WHEREAS**, on 8 June 2021, the deadline for the submission and receipt of bids as well as the date of opening thereof, one (1) bidder, namely, Atlas Super Flags submitted its respective bid which the BAC determined to be as follows:

**WHEREAS**, the BAC declared **Atlas Super Flags** as having the Single Calculated Bid, and subjected it to Post-Qualification on 11 June 2021, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complies with and is responsive to all the requirements and conditions specified in the Bidding Documents;

**WHEREAS**, during the post-qualification of bids and after careful consideration, the BAC determined that the bid of **Atlas Super Flags** was compliant with and is responsive to all the requirements and conditions specified in the Bidding Documents;


**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the contract for the Procurement of Flags and Similar Supplies for the Department of Foreign Affairs to **Atlas Super Flags** for having submitted the Single Calculated and Responsive Bid in the amount of **Five Million Three Hundred Seventy-Six Thousand Four Hundred Fifteen Pesos (PhP 5,376,415.00)** only, pursuant to Section 37 of the revised IRR of RA 9184.
