

INVITATION TO BID FOR THE PROCUREMENT OF THE SERVICES OF OUTSOURCED PERSONNEL OF THE OFFICE OF CONSULAR AFFAIRS – ASEANA AND CONSULAR OFFICES FOR OCTOBER TO DECEMBER 2021

- 1. The Department of Foreign Affairs, through the authorized appropriations under the FY 2021 General Appropriation Act (GAA), intends to apply the sum of Eleven Million Two Hundred Two Thousand Pesos (PhP 11,202,000.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of the Services of Outsourced Personnel of the Office of Consular Affairs Aseana and Consular Offices for October to December 2021. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Foreign Affairs now invites bids for the "Procurement of the Services of Outsourced Personnel of the Office of Consular Affairs Aseana and Consular Offices for October to December 2021", described as follows:

- 3. The Department of Foreign Affairs now invites bids for the above Procurement Project. Delivery of the Goods is stated on the Technical Specifications. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 4. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

Prospective Bidders may obtain further information from the Department of Foreign Affairs and inspect the Bidding Documents at 2330 Roxas Boulevard, Pasay City, 1300 from 8:00 a.m. to 5:00 p.m.

- 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 10. Bid opening shall be on 27 September 2021, 3:00 p.m. at the given address below and/or via *BAC Video Conferencing*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity through an online video conference. Late bids shall not be accepted.

The Department of Foreign Affairs reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
