RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF SIX (6) UNITS OF DIGITAL THERMAL SCANNER BUNDLED WITH AUTOMATIC ALCOHOL DISPENSER AND TWELVE (12) UNITS OF AUTOMATIC ALCOHOL DISPENSER FOR THE OFFICIAL USE OF THE OFFICE OF CONSULAR AFFAIRS (OCA)

WHEREAS, the Office of Consular Affairs (OCA) intends to procure six (6) units of digital thermal scanner bundled with automatic alcohol dispenser and twelve (12) units of automatic alcohol dispenser for its official use;

WHEREAS, the procurement of six (6) units of digital thermal scanner bundled with automatic alcohol dispenser and twelve (12) units of automatic alcohol dispenser, as listed in Purchase Request No. 07-01522, with an Approved Budget for the Contract (ABC) of *Eighty-Four Thousand Pesos (PhP 84,000.00)* only, is included in the Department's Supplemental Annual Procurement Plan (SAPP) for CY 2022;

WHEREAS, Section 53.9 of the 2016 revised Implementing Rules and Regulations ("IRR," hereinafter) of R.A. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, Annex H(IV)(J) of the IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the end-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website for three (3) consecutive days, starting from 13 July 2022 to 18 July 2022;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex H of the IRR, separate Requests for Quotation (RFQ) were also sent to at least three (3) potential service providers;

WHEREAS, in response to the solicitation of offers, quotations were received from the following:
