RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.10 (LEASE OF REAL PROPERTY/VENUE) FOR THE LEASE OF VENUE (INCLUSIVE OF MEALS) FOR THE 40TH ANNIVERSARY CELEBRATION OF UNCLOS ENTITLED "THE UNCLOS AND THE PHILIPPINES 40 YEARS HENCE: FROM NEGOTIATION TO APPLICATION: THE PHILIPPINES' ROLE IN ITS FOUNDATION AND ITS FUTURE" ON 9 DECEMBER 2022

WHEREAS, the Office of the Maritime and Ocean Affairs (MOAO) intends to lease a venue (inclusive of meals) for the 40th Anniversary celebration of UNCLOS on 9 December 2022;

WHEREAS, MOAO's procurement for the lease of venue, with an Approved Budget for the Contract (ABC) in the amount of *Three Hundred Fifty-Three Thousand Seven Hundred Sixty Pesos (PhP 353,760.0)* only, chargeable against MOAO's FY 2022 MOOE for Representation Expenses, is included in the Department's Annual Procurement Plan (APP) for CY 2022;

WHEREAS, Sec. 53.10 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows Negotiated Procurement as a mode of procurement for the lease of privately owned real property and venue for official use, subject to the Consolidated Guidelines for the Alternative Methods of Procurement of the 2016 Revised IRR of RA 9184;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, in compliance with Part V, Item D(9)(c)(i)(a), Annex "H" of RA 9184's IRR, requests for quotation were sent to at least three prospective lessors;


WHEREAS, in response to the solicitation of offers, a single calculated and responsive quotation was received from ***Philippine Diamond Hotel & Resort, Inc. (Phil Diamond Hotel & Resort, Inc.)*** in the amount of *Two Hundred Eight Five Thousand Five Hundred Pesos (PhP 285,500.00)* only.

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Alternate Head of Procuring Entity (HOPE) to resort to Negotiated Procurement (Lease of Real Property/Venue)






