RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.10 (LEASE OF REAL PROPERTY/VENUE) THE LEASE OF VENUE (INCLUSIVE OF MEALS AND ONE WAY AIRPORT TRANSPORT) FOR THE CONDUCT OF ECONOMIC OFFICERS' RETOOLING COURSE OF THE OFFICE OF THE UNDERSECRETARY FOR MULTILATERAL AFFAIRS AND INTERNATIONAL ECONOMIC RELATIONS (OUMAIER) FROM 13-16 DECEMBER 2022

WHEREAS, the Office the Undersecretary for Multilateral Affairs and International Economic Relations (OUMAIER) intends to lease a venue for the economic officers' retooling course on 13-16 December 2022;

WHEREAS, the lease of venue for said event by the OUMAIER, with an Approved Budget for the Contract (ABC) in the amount of *Two Million One Hundred Thousand Pesos (PhP 2,100,000.00)* only, chargeable to OUMAIER's 2022 MOOE - Training Expenses, is included in the Department's Supplemental Annual Procurement Plan (SAPP) for CY 2022;


WHEREAS, Sec. 53.10 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows Negotiated Procurement as a mode of procurement for the lease of privately owned real property and venue for official use, subject to the Consolidated Guidelines for the Alternative Methods of Procurement of the 2016 Revised IRR of RA 9184;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, in response to the solicitation of offers, quotations were received from: *Conrad Manila (failed; did not submit quotation), Sofitel Philippine Plaza Manila (PhP 1,875,000.00; failed, within the ABC but failed to comply with the technical specifications), and Philippine Diamond Hotel and Resort Inc., which submitted the lowest calculated and most responsive quotation in the amount of One Million Eight Hundred Ninety-Six Pesos (PhP 1,896,000.00) only;*

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of Procuring Entity (HOPE) to resort to Negotiated Procurement (Lease of Real Property/Venue) as the alternative method of procurement for the lease of venue for said event from the *Philippine Diamond Hotel & Resort Inc.* subject to the above- mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.




