


CONTRACT OF SERVICE

AND



WHEREAS, *DFA CO CALASIAO*, is desirous of engaging the services of *Bani Hidden Paradise Beach Resort* for the purpose of providing lease of venue, accommodation and meals for 20 participants on 28-29 October 2022.

NOW THEREFORE, in consideration of the foregoing premises and of the terms and conditions hereunder stipulated, the parties have agreed as follows;


1. That Bani Hidden Paradise Beach Resort shall provide transportation, room accommodation, full boards meals and team building amenities for 20 participants.
2. That for the provisions of lease of venue, transportation, room accommodation, full boards meals and team building amenities mentioned in the quotation shall pay from the Approved Budget for the Contract for CO Calasiao's Team Building Activity to Bani Hidden Paradise Beach Resort, the amount computed at the rate with a total of **Php 74, 440.00 (seventy four thousand four hundred forty – no extra charges and no hidden fees)** for 20 participants.
3. That payment through check will be issued by DFA CO Calasiao to Bani Hidden Paradise Beach Resort in full amounting to **Php 74, 440.00 (seventy four thousand four hundred forty)** upon receipt of DFA – Bids and Awards Committee (BAC) approval.


