RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE SUPPLY AND DELIVERY OF INTERNAL SOLID STATE DRIVE (SSD) AND RANDOM ACCESS MEMORY (RAM) FOR THE OFFICIAL USE OF THE OFFICE OF THE ASEAN AFFAIRS

WHEREAS, the Office of ASEAN Affairs intends to procure twenty-one (21) internal solid state drive (SSD), eleven (11) random access memory (RAM) for desktop and ten (10) random access memory (RAM) for laptop for its official use;

WHEREAS, the procurement of twenty-one (21) internal solid state drive (SSD), eleven (11) random access memory (RAM) for desktop and ten (10) random access memory (RAM for laptop, as listed in Purchase Request No. 04-03722 by the ASEAN Affairs, with an Approved Budget for the Contract (ABC) of *One Hundred Forty-Seven Thousand (PhP 147,000.00)* only, is included in the Department's Supplemental Annual Procurement Plan (SAPP) for CY 2022;

WHEREAS, Section 53.9 of the 2016 revised Implementing Rules and Regulations ("IRR," hereinafter) of R.A. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, Annex H(IV)(J) of the IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the end-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website for three (3) consecutive days, starting on 12 May 2022 to 18 May 2022;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex H of the IRR, separate Requests for Quotation (RFQ) were also sent to at least three (3) potential suppliers/contractors;

WHEREAS, in response to the solicitation of offers, quotations were received from: Advance Microsystems Corporation (PhP 138,600.00), Metos Offshore, Inc. (PhP 138,000.00), and Fuzionic Marketing, which submitted the lowest calculated and responsive quotation in the amount of One Hundred Twenty-One Thousand Eight Hundred pesos (PhP 121,800.00) only;
