RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.10 (LEASE OF REAL PROPERTYNENUE) FOR THE LEASE OF VENUE FOR GOOGLE WORKPLACE PRODUCTIVITY: DATABASE TRAINING/WORKSHOP FOR THE HUMAN RESOURCES MANAGEMENT OFFICE-BENEFITS AND WELFARE DIVISION (HRMO-BWD) PERSONNEL ON 23 TO 24 JULY 2022

WHEREAS, the Human Resources Management Office (HRMO) intends to lease a venue for the Google Workspace Productivity: Database Training/Workshop for HMRO-BWD personnel on 23 to 24 July 2022;

WHEREAS, the procurement for the lease of venue for said event by the HRMO, with an Approved Budget for the Contract (ABC) in the amount of *Six Hundred Thousand Pesos* (PhP 600,000.00) only, is included in the Department's Annual Procurement Plan (APP) for CY 2022;

WHEREAS, Sec. 53.10 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows Negotiated Procurement as a mode of procurement for the lease of privately owned real property and venue for official use, subject to the Consolidated Guidelines for the Alternative Methods of Procurement of the 2016 Revised IRR of RA 9184;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, Part IV, Item A, Annex "H" of the IRR allows the Procuring Entity to change the mode of procurement, if the original mode in the Annual Procurement Plan can no longer be pursued;

WHEREAS, in compliance with Part V, Item D(9)(c)(i)(a), Annex "H" of RA 9184's IRR, requests for quotation were sent to at least three prospective lessors;

WHEREAS, in response to the solicitation of offers, quotations were received from: the Holiday Inn Express (Resorts World Manila) (Php 375,000.00), and the Lucky Star Hotels and Recreation Inc. (Sheraton Manila Hotel) in the amount of Three Hundred Thousand Pesos (Php 300,000.00) only.

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of Procuring Entity (HOPE) to resort to Negotiated Procurement (Lease of Real PropertyNenue) as the alternative method of procurement for the lease of venue for said event from *Lucky Star Hotels and Recreation Inc. (Sheraton Manila Hotel)* subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
