## BAC Resolution No. NTC-228-22

#### RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.6 (SCIENTIFIC, SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE TECHNOLOGY AND MEDIA SERVICES) AS ALTERNATIVE METHOD OF PROCUREMENT FOR THE PROCUREMENT OF SERVICES FOR THE CULTURAL APPRECIATION FOR DFA SENIOR OFFICERS PROJECT

**WHEREAS**, the Office of the Public and Cultural Diplomacy (OPCD) intends to procure services for the provision of lights, sounds, projector, piano, and artists' talent fees for the cultural appreciation for DFA senior officers project;

WHEREAS, the procurement of services for the cultural appreciation for DFA senior officers project by the OPCD, with an Approved Budget for the Contract (ABC) in the amount of Three Hundred Forty-Nine Thousand Nine Hundred Fourteen Pesos (PhP 349,914.00) only, chargeable against UMAIER-CDU's FY 2022 MOOE for Other Professional Service Expenses, is included in the Department's Supplemental Annual Procurement Plan (SAPP) for FY 2022;

**WHEREAS**, Section 53 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2003, allows an agency to resort to Negotiated Procurement;

**WHEREAS**, further, Section 53.6 of the said Revised IRR can be resorted where Goods, Infrastructure Projects and Consulting Services can be contracted from a particular supplier, contractor or consultant as determined by the Head of the Procuring Entity (HOPE), for any of the following requirements (a) Work of art; commissioned work or services of an artist for specific artistic skills (*e.g.* singer, performer, poet, writer painter sculptor, etc.), *inter alia*;

WHEREAS, after conducting a thorough market study, the end-user unit determined that the identified service provider could undertake the project at more advantageous terms;

**WHEREAS**, the OPCD submitted to the Bids and Awards Committee (BAC) a quotation from the Sinematika Inc. for the procurement of services for the cultural appreciation for DFA senior officers project of the OPCD in the total amount of *Three Hundred Forty-Nine Thousand Nine Hundred Fourteen Pesos* (PhP 349,914.00) only;

**WHEREAS**, the Bids and Awards Committee (BAC), after taking into consideration all relevant factors, finds that the awarding of the procurement of services for the cultural appreciation for DFA senior officers project of OPCD may be done under Section 53.6 (a.) work of art; commissioned work or services of an artist for a specific artist skill (*e.g., singer, poet, writer, painter, sculptor, etc.*) of the 2016 revised IRR of R.A. 9184.

**NOW**, **THEREFORE**, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Undersecretary and Head of the Procuring Entity (HOPE) the resort to Negotiated Procurement under Section 53.6 as the alternative method of procurement of services for the cultural appreciation for DFA senior officers project of OPCD from *Sinematika Inc.*, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
