RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.6 (SCIENTIFIC, SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE TECHNOLOGY AND MEDIA SERVICES) AS ALTERNATIVE METHOD OF PROCUREMENT FOR THE PROCUREMENT OF SERVICES FOR THE CAREER MINISTER (CarMin) LEADERSHIP PROGRAM ON 09 – 30 SEPTEMBER 2022

WHEREAS, the Board of Foreign Service Examinations (BFSE) intends to procure services to develop and conduct the Career Minister (CarMin) Leadership Program on an exclusive and customized basis from 09 to 30 September 2022;

WHEREAS, the procurement of services for the Career Minister (CarMin) Leadership Program on 09 – 30 September 2022 by the BFSE, with an Approved Budget for the Contract (ABC) in the amount of Two Million Six Hundred Forty Thousand Pesos (PhP 2,640,000.00) only, chargeable against BFSE's 2022 MOOE for Training Expenses, is included in the Department's Annual Procurement Plan (APP) for FY 2022;

WHEREAS, Section 53 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2003, allows an agency to resort to Negotiated Procurement;

WHEREAS, further, Section 53.6 of the said Revised IRR can be resorted where Goods, Infrastructure Projects and Consulting Services can be contracted from a particular supplier, contractor or consultant as determined by the Head of the Procuring Entity (HOPE), for any of the following requirements (b) Scientific, academic, scholarly work or research, or legal services;

WHEREAS, after conducting a thorough market study, the end-user unit determined that the identified service provider could undertake the project at more advantageous terms;

WHEREAS, the BFSE submitted to the Bids and Awards Committee (BAC) a quotation from the *Ateneo de Manila University, Inc. (Ateneo Graduate School of Business – Center for Continuing Education (AGSB-CCE))* for the procurement of services for the Career Minister (CarMin) Leadership Program on 09 – 30 September 2022 in the total amount of *Two Million Six Hundred Forty Thousand Pesos* (PhP 2,640,000.00) only;

WHEREAS, the Bids and Awards Committee (BAC), after taking into consideration all relevant factors, finds that the awarding of the procurement of services for the Career Minister (CarMin) Leadership Program on 09 – 30 September 2022 may be done under Section 53.6 (b) Scientific, academic, scholarly work or


research, or legal services, of the 2016 revised IRR of R.A. 9184;


