BAC Resolution No. NTC-263-22

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.6 (SCIENTIFIC, SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE TECHNOLOGY AND MEDIA SERVICES) AS ALTERNATIVE METHOD OF PROCUREMENT FOR THE HIRING OF A FIRM TO HOLD AN ONLINE EVENT AND LAUNCH A VIRTUAL MUSEUM TOUR FOR THE CELEBRATION OF THE MUSEUM AND GALLERIES MONTH (MGM), OCTOBER 2022

WHEREAS, the Office of Public and Cultural Diplomacy (OPCD) intends to hire the services of a firm to hold an online event and launch a virtual museum tour for the celebration of the Museum and Galleries Month (MGM) in October 2022 pursuant to Presidential Proclamation No. 798, s. 1991;

WHEREAS, the procurement for the hiring of the services of a firm by the OPCD, with an Approved Budget for the Contract (ABC) in the amount of *One Million Nine Hundred Thousand Pesos* (PhP 1,900,000.00) only, chargeable against UMAIER-CDU's FY 2022 MOOE for Other Professional Service, is included in the Department's Supplemental Annual Procurement Plan (SAPP) for FY 2022;

WHEREAS, Section 53 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act of 2003, allows an agency to resort to Negotiated Procurement;

WHEREAS, further, Section 53.6 of the said Revised IRR can be resorted where Goods, Infrastructure Projects and Consulting Services can be contracted from a particular supplier, contractor or consultant as determined by the Alternate Head of the Procuring Entity (AHOPE), for any of the following requirements: (a) Work of art; commissioned work or services of an artist for specific artistic skills (e.g. singer, performer, poet, writer painter sculptor, etc.), *inter alia*;

WHEREAS, after conducting a thorough market study, the end-user unit determined that the identified service provider could undertake the project at more advantageous terms;

WHEREAS, the OPCD submitted to the Bids and Awards Committee (BAC) a quotation from the ***Exsight Three-Sixty Media Productions*** to hire the services of a firm to hold an online event and launch a virtual museum tour in October 2022 in the total amount of *One Million Eight Hundred Ninety-Eight Thousand Four Hundred Pesos* (PhP 1,898,400.00) only;


WHEREAS, the Bids and Awards Committee (BAC), after taking into consideration all relevant factors, finds that the awarding of the procurement for the hiring of services of a firm to hold an online event and launch a virtual museum tour for the celebration of the Museum and Galleries Month (MGM) may be done under Section 53.6 (a) of the 2016 revised IRR of R.A. 9184;

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Undersecretary and Alternate Head of the Procuring Entity (AHOPE) the resort to Negotiated Procurement under Section 53.6 as the alternative method of procurement of the services of the **Exsight Three-Sixty Media Productions**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.






