BAC Resolution No. NTC-047-22

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) THE SUPPLY AND DELIVERY OF 10,000 PIECES OF KN95 PROTECTIVE MASKS FOR THE DEPARTMENT OF FOREIGN AFFAIRS

WHEREAS, the Office of Asset Management and Support Services (OAMSS) intends to procure the supply and delivery of 10,000 pieces of KN95 protective masks for the use of Department of Foreign Affairs (DFA) personnel;

WHEREAS, the procurement of the aforementioned, with an Approved Budget for the Contract (ABC) of *Five Hundred Fifty Thousand Pesos* (Php 550,000.00) only, is included in the Department's Annual Procurement Plan (APP) for CY 2022;

WHEREAS, Section 53.9 of the 2016 revised Implementing Rules and Regulations ("IRR," hereinafter) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, Annex H(IV)(J) of the IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the end-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex H of the IRR, separate Requests for Quotation (RFQ) were also sent to at least three (3) potential suppliers;

WHEREAS, in response to the solicitation of offers, quotations were received from the following:
