RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.10 (LEASE OF REAL PROPERTY/VENUE) THE LEASE OF VENUE FOR THE TEAM-BUILDING ACTIVITY OF CO-SAN PABLO ON 10-11 DECEMBER 2022

WHEREAS, the Consular Office in San Pablo (CO-San Pablo) intends to lease a venue for their office team-building scheduled on 10-11 December 2022;

WHEREAS, the lease of venue for said event by the CO-San Pablo, with an Approved Budget for the Contract (ABC) in the amount of *Seventy Thousand Pesos (PhP 70,000.00)* only, chargeable against OCA's 2022 MOOE for Training and Expenses, is included in the Department's Annual Procurement Plan (APP) for CY 2022;

WHEREAS, Sec. 53.10 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows Negotiated Procurement as a mode of procurement for the lease of privately owned real property and venue for official use, subject to the Consolidated Guidelines for the Alternative Methods of Procurement of the 2016 Revised IRR of RA 9184;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex H of the IRR, separate Requests for Quotation (RFQ) were also sent to at least three (3) potential lessors;

WHEREAS, in response to the solicitation of offers, quotations were received from: Bakasyunan Resort and Conference Center, (*PhP 27,100.00; failed, quoted price if within the ABC, failed to submit PhilGeps Registration), Mountain Lake Resort, (PhP 49,000.00; failed; quoted price is within the ABC, failed to submit PhilGeps Registration), and Caliraya Resort Club, Inc.*, which submitted the lowest calculated and responsive quotation in the amount of Seventy Thousand Pesos (*Php 70,000.00*) only;

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of Procuring Entity (HOPE) to resort to Negotiated Procurement (Lease of Real Property/Venue) as the alternative method of procurement for the lease of venue for said event from the *Caliraya Resort Club, Inc.* subject to the above- mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
