RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.10 (LEASE OF REAL PROPERTY/VENUE) FOR THE LEASE OF VENUE FOR THE TEAM BUILDING ACTIVITY OF CONSULAR OFFICE (CO) BAGUIO ON 09 – 11 DECEMBER 2022

WHEREAS, the Consular Office (CO) Baguio intends to lease a venue for its team building activity on 09 – 11 December 2022;

WHEREAS, the lease of venue for the team building activity of Consular Office (CO) Baguio on 09 – 11 December 2022, with an Approved Budget for the Contract (ABC) of Eighty Thousand Pesos (PhP 80,000.00) only, chargeable against OCA's 2022 MOOE for Training Expenses, is included in the Department's Annual Procurement Plan (APP) for FY 2022;

WHEREAS, Sec. 53.10 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows Negotiated Procurement as a mode of procurement for the lease of privately owned real property and venue for official use, subject to the Consolidated Guidelines for the Alternative Methods of Procurement of the 2016 Revised IRR of RA 9184;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;


WHEREAS, in compliance with Part V, Item D(9)(c)(i)(a), Annex "H" of RA 9184's IRR, requests for quotation were sent to at least three prospective lessors;

WHEREAS, in response to the solicitation of offers, quotations were received from: the Jorisan Waterfront Resort (PhP 80,000.00; failed, bidder is not compliant with the Technical Specifications), Villas Buenavista (Hotel and Restaurant) (PhP 67,000.00; failed, bidder is not compliant with the Technical Specifications) and the **Prolific Corporation (Santiago Cove Hotel and Restaurant)**, which submitted the lowest calculated and responsive quotation in the amount of *Seventy – Five Thousand Five Hundred Eighty - Four Pesos* (PhP 75,584.00) only;

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of Procuring Entity (HOPE) to resort to Negotiated Procurement (Lease of Real Property/Venue) as the alternative method of procurement for the lease of venue for the team building activity of Consular

Office (CO) Baguio on 09 – 11 December 2022 from the **Prolific Corporation (Santiago Cove Hotel and Restaurant)** subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
