RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.10 (LEASE OF REAL PROPERTY/VENUE) FOR THE LEASE OF VENUE FOR THE TEAM BUILDING ACTIVITY OF CONSULAR OFFICE (CO) – TAGUM ON 26 – 27 NOVEMBER 2022

WHEREAS, the Consular Office (CO) – Tagum intends to lease a venue for the conduct of its team building activity on 26 – 27 November 2022;

WHEREAS, the lease of venue for the team building activity of CO – Tagum on 26 – 27 November 2022 by the CO – Tagum, with an Approved Budget for the Contract (ABC) of Seventy-Five Thousand Pesos (PhP 75,000.00) only, is included in the Department's Annual Procurement Plan (APP) for FY 2022;

WHEREAS, Sec. 53.10 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows Negotiated Procurement as a mode of procurement for the lease of privately owned real property and venue for official use, subject to the Consolidated Guidelines for the Alternative Methods of Procurement of the 2016 Revised IRR of RA 9184;

WHEREAS, Annex H(IV)(J) of the 2016 revised IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, in compliance with Part V, Item D(9)(c)(i)(a), Annex "H" of RA 9184's IRR, requests for quotation were sent to at least three prospective lessors;

WHEREAS, in response to the solicitation of offers, quotations were received from: the Club Samal Resort (PhP 135,720.00; failed, exceeded the ABC), the Pundaguitan Playa Inc. (El Don Resort) (PhP 75,630.00; failed, exceeded the ABC), and the ***Eden Mountain Resort, Inc. (Eden Nature Park & Resort***, which submitted the lowest calculated and most responsive quotation in the amount of *Seventy-Five Thousand Pesos (PhP 75,000.00) only*;

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of Procuring Entity (HOPE) to resort to Negotiated Procurement (Lease of Real Property/Venue) as the alternative method of procurement for the lease of venue for the team building activity of CO – Tagum on 26 – 27 November 2022 from the ***Eden Mountain***

Resort, Inc. (Eden Nature Park & Resort) subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
