CANCELLATION or POSTPONEMENT POLICY AND PROCEDURE

FORCE MARJEURE

Neither party may be held for any act, omission or circumstance due to an event beyond their control which that party could not have avoided with a reasonable effort, providing it advises the other party in detail and in writing, as soon as possible after the occurrence of the said event, and that it takes reasonable steps to remedy the situation quickly and remove the cause of those acts, omissions or circumstances. These acts, omissions or circumstances shall include but not be limited to:

War, declared or undeclared, revolution or action taken by public enemies; riots or civil disturbances; strikes, lock outs or work stoppage, affecting all or part of the Hotel staff; acts of God; fire, floods, storms; constraints imposed by any government or public authority; or any other cause that is reasonably beyond the control of one of the other party.

• The duty to remedy any one of these causes quickly in no way includes the duty to end strikes or industrial conflict by accepting the demands of the other party or parties.

The deposit/s already made will serve as down payment and should be consumed within six (6) months from the original date of booking. For force majeure due to government regulations by virtue of state of public health emergency, the consumption shall be from one (1) year from the lifting of the restrictions imposed by the government. Failure to consume within such time period shall mean forfeiture of the said amount.

NO SMOKING POLICY

In compliance with our policy in prohibiting smoking, we strictly do not allow smoking in any public areas inside and near Nurture.

GENERAL STORAGE:

Please advise the Hotel thirty (30) days in advance the delivery schedule of events materials, decoration items or equipments so that arrangement can be made to assist the delivery through the Hotel's receiving area. Articles are kept in the storage at the owner's risk and the Hotel shall not be held responsible for valuables left in the storage. If the articles are not claimed within one (1) day after the last day of the organized event, the Hotel shall be entitled to dispose the articles in any way it deems fit without any liability whatsoever. The Hotel shall be indemnified by the owner of the articles, for any loss or damage suffered by the Hotel or to any third party, howsoever caused by or in connection with the articles stored in the storage.

SET-UP & DECORATION

All set-ups to be installed by Organizer's appointed contractors shall be in compliance with safety and fire regulations prescribed by local laws and regulations and by Hotel's fire and safety standards, otherwise, the Hotel reserves the right to refuse such set ups. The Hotel shall not be responsible for any consequences arising from Organizer's breach of such laws, regulations and/or standards.

The Hotel must be notified at least 30 working days prior to the actual Event for use of any video, sound and/or audio equipment. The Hotel reserves the right to refuse or prohibit the use of such equipment if in Hotel's sole and absolute discretion the same shall cause disturbance to other functions within the Hotel or to other Hotel guests during rehearsal or on the day of the Event.

The contact person understood that no material is to be nailed, screwed, stapled or adhered to any wall, door or other surface of the building or the property. Also, the Hotel should be informed in advance all signages which will be installed during the event.

CONTRACTORS AND SUPPLIERS

Liability Contract must be signed and agreed upon prior the commencing of any work to be carried out within the Hotel's premised.

The contractors agree to submit to The Hotel a bond of Ten Thousand Pesos Php10, 000.00) one (1) week prior the event. The amount shall be refunded to the Contractor in full after a thorough inspection of the function area is completed by the Hotel's Banquet Service Manager or Captainin Charge in coordination with Contractor's on-site Supervisor.

The Hotel has every right to refuse entry to any contractors engaged by the Company, should the Liability Contract is not signed and return to the Hotel in time for the work to be carried out. Should there be any damage to the Hotel property during the contracted period which are directly caused by the Company or by the contractors engaged by the Company, the agreed party shall assume

the entire responsibility and liability for losses, damage, claims demands and expenses arising during the contracted work period.

SAFETY & SECURITY

All contractors engaged by the Organizer, shall adhere to all Hotel Policies, Rules & Regulations. The Organizer shall be responsible for ensuring that all fire escapes inside the function rooms are not obstructed by the set up for the Event. No flammable materials may be brought onto Hotel's premises without the prior written permission of the Hotel.

The Hotel shall in no event be under any liability for any loss or damage (including direct and indirect or consequential losses, loss of contracts, loss of profits economic or financial losses or anticipated savings) howsoever arising which may be suffered by the Company.

CONFIDENTIALITY

All rates should not be disclosed, directly or indirectly, unless explicit written approval is given by the Hotel.

ADVERTISING & PROMOTION

The Organizer shall not use the name, trademark, logo or other intellectual property proprietary to the Hotel or any of their subsidiaries, affiliates or associated companies in any manner whatsoever without the prior written approval of the Hotel.

DATA PRIVACY

The client hereby gives full consent to Nurture Wellness Village to collect, record, organize, store, update, use, consolidate, block, erase or otherwise process information, whether personal, sensitive or privileged, pertaining to yourself and the subject hereof which will be used for the implementation of his agreement. In this connection, you acknowledge that you have read, understood and / or have been duly informed of the terms and conditions pertaining to the data privacy practices of the company as reflected in the Company's Data Privacy policy at Nurture Wellness Village, Inc. and you hereby express your full conformity thereto.

HOTEL LIABILITY

The liability of the Hotel t arising out of any act carried out pursuant to this agreement, whether in contract or otherwise, will not in any case exceed the original fee to the company for the services pursuant to this agreement. Also, the Hotel shall in no event be under liability for any loss or damage howsoever arising which may be suferred by the company unless such loss or damage was due to the fault of negligence of the Hotel or it's employees, agents or representatives.

INDEMNITY

The Organizer shall waive against and indemnify, defend and hold the Hotel, and all of their affiliates, subsidiaries and associated companies, and their respective directors, officers, shareholders, employees ("Indemnified Parties") harmless from and against any and all losses, damages, claims, demands, actions, penalties, suits, costs, fees and liabilities arising out of, caused by or resulting from, in whole or in part, the Event (including any injury or damage to any persons or property on or about the Hotel), or any default of or breach by the Organizer under this Agreement.

This Agreement shall be governed by, and shall be construed, interpreted and applied in

Any dispute, controversy, or claim arising out of or in connection with this contract, including any question regarding its existence, validity, or termination, shall be finally resolved by arbitration under the Rules of Supreme Court currently in force, which Rules are deemed to be incorporated by reference into this clause. The tribunal shall consist of a [sole/three arbitrator(s)].

The Company will be obliged to have independent insurance coverage in respect of any equipment/ display items/valuables, etc. brought in by the company to the venue of the event and the Hotel shall not in any circumstances, be liable for any loss or damage suffered by the Company in respect of such equipment / display items / valuables during the course of the event (including the transportation of the same to and from the venue).
