BAC Resolution No. NTC-201-22

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF VARIOUS REPRESENTATIONAL GIFTS FOR THE OFFICIAL USE OF THE OFFICE OF THE SECRETARY

WHEREAS, the Office of the Secretary (OSEC) intends to procure various representational gifts for its official use;

WHEREAS, OSEC's procurement of various representational gifts, as listed in Purchase Request No. 07-06722, with an Approved Budget for the Contract (ABC) of *Two Hundred Twenty-Eight Thousand Pesos* (PhP 228,000.00) only, chargeable against OSEC's FY 2022 MOOE for Representation Expenses, is included in the Department's Annual Procurement Plan (APP) for FY 2022;

WHEREAS, Section 53.9 of the 2016 revised Implementing Rules and Regulations ("IRR," hereinafter) of R.A. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, Annex H(IV)(J) of the IRR allows the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue to be delegated to the end-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website for three (3) consecutive days, from 13 to 16 August 2022;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex H of the IRR, separate Requests for Quotation (RFQ) were also sent to at least three (3) potential suppliers/contractors;

WHEREAS, in response to the solicitation of offers, quotations were received from: *DVK Philippines Enterprises* (PhP 160,200.00; failed, bidder submitted 2021 quotation and did not comply with the technical specifications), and **Balikbayan Handicrafts Corporation**, which submitted the lowest calculated and responsive quotation in the amount of *Two Hundred Twenty-Eight Thousand Pesos* (PhP 228,000.00) only;

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity (HOPE) resort to Negotiated Procurement as the alternative method of procurement of various representational gifts for the official use of OSEC from **Balikbayan Handicrafts Corporation**, subject to the abovementioned requirements, and provided that existing auditing rules and regulations shall be strictly observed by the end-user.


