BAC Resolution No. NTC (PB) – 05 – 22

**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON
PROCUREMENT OF FLAGS AND SIMILAR SUPPLIES FOR THE DEPARTMENT OF
FOREIGN AFFAIRS**

WHEREAS, the Department of Foreign Affairs, through the authorized appropriations under the 2022 General Appropriations Act (GAA), intends to apply the sum of **SIX MILLION FIVE HUNDRED NINETY-FOUR THOUSAND FOUR HUNDRED FORTY-SIX PESOS AND 50/100 (PhP6,594,446.50)** only, being the Approved Budget for the Contract (ABC) for the *Procurement of Flags and Similar Supplies for the Department of Foreign Affairs*;

WHEREAS, the said Approved Budget for the Contract is chargeable against various DFA offices'/posts' FY 2022 MOOE – Other Supplies and Materials Expenses;

WHEREAS, on 18 March 2022, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the **Invitation to Bid** for the *Procurement of Flags and Similar Supplies for the Department of Foreign Affairs* on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 29 March 2022, the BAC held a **Pre-Bid Conference** to discuss the eligibility requirements and the technical and financial components of the contract to be bid, which was attended by Atlas Super Flags;

WHEREAS, on 12 April 2022, the deadline for the submission and receipt of bids as well as the date of opening thereof, only Atlas Super Flags submitted a bid which the BAC determined to be as follows:

WHEREAS, the BAC declared **Atlas Super Flags** as having the Single Calculated Bid, and subjected it to Post-Qualification on 18 April 2022, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complies with and is responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the post-qualification and after careful evaluation, the BAC determined that the bid of **Atlas Super Flags** was compliant with and is responsive to all the requirements and conditions specified in the Bidding Documents;


NOW, THEREFORE, we, the members of the Bids and Awards Committee, RESOLVE to RECOMMEND the award of the contract for the Procurement of Flags and Similar Supplies for the Department of Foreign Affairs to **Atlas Super Flags** for having submitted the Single Calculated and Responsive Bid in the amount of **Six Million Four Hundred Forty-Three Thousand Two Hundred Twelve Pesos and 50/100 (PhP 6,443,212.50)** only, pursuant to Section 37 of the revised IRR of RA 9184.


