RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON PROCUREMENT
OF SELF-ADMINISTERED RAPID-ANTIGEN TEST KITS

WHEREAS, the Department of Foreign Affairs, through the authorized appropriations under the Department's COVID-19 Pooled Savings, intends to apply the sum of Three Million Eight Hundred Forty Thousand Pesos (PhP 3,840,000.00) only, being the Approved Budget for the Contract (ABC) for the *Procurement of Self-Administered Rapid-Antigen Test Kits*;

WHEREAS, the said ABC is chargeable against the Department's COVID-19 Pooled Savings for Other Supplies and Materials Expenses;

WHEREAS, on 06 April 2022, the Bids and Awards Committee (BAC) Secretariat posted for seven (7) consecutive calendar days the *Invitation to Bid* for the *Procurement of Self-Administered Rapid-Antigen Test Kits* on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 13 April 2022, the BAC held a *Pre-Bid Conference* to discuss the eligibility requirements and the technical and financial components of the contract to be bid, which was attended by Labsolution Technologies Inc., Philippine Vision Group, Sunfu Solutions, Inc., Biosite Medical Instruments, Inc., RainPhil Inc., and Celltech Applied Sciences Inc.;

WHEREAS, on 26 April 2022, the deadline for the submission and receipt of bids as well as the date of opening thereof, Labsolutions Technologies Inc. and Sunfu Solutions Inc. submitted their bids which the BAC determined to be as follows:

WHEREAS, the BAC declared *Sunfu Solutions Inc.* as having the Single Calculated Bid, and subjected it to Post-Qualification on 29 April 2022, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complies with and is responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the post-qualification and after careful evaluation, the BAC determined that the bid of **Sunfu Solutions Inc.** was compliant with and is responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, RESOLVE to RECOMMEND the award of the contract for the Procurement of Self-Administered Rapid-Antigen Test Kits to **Sunfu Solutions Inc.** for having submitted the Single Calculated and Responsive Bid in the amount of **Two Million One Hundred Ninety Four Thousand Two Hundred Pesos (PhP 2,194,200.00) only**, pursuant to Section 37 of the revised IRR of RA 9184.
