

Service Contract

This Service Contract is entered by and between:

IMAGIK Events Management Services, whose principal place of business is at Unit 2091 JMP Building, Jose Cruz St. Bgy Ugong Pasig City, hereinafter referred to as Event Management Company; and

And

DFA Office of the United Nations and International Organizations DFA-UNIO, whose address is at Department of Foreign Affairs, 2330 Roxas Boulevard, Pasay City, hereinafter referred to as CLIENT.

Date of Commencement

The effectivity of this Contract shall be on December 4-5, 2023, the day on which the **Event Management Company** shall begin service.

Term of Engagement
