WHEREAS, the Office of Protocol ("OP") intends to procure services of an event management service provider for the Cultural Immersion Activity for Non-Resident Ambassadors (NRAs) entitled "Mesmerizing Manila" on 09 and 16 August 2023;

WHEREAS, the procurement of event management service provider for the Cultural Immersion Activity for Non-Resident Ambassadors (NRAs) entitled "Mesmerizing Manila" on 09 and 16 August 2023, as listed under Purchase Request No. 07-05823, with an Approved Budget for the Contract ("ABC") of *Three Hundred Thousand Pesos* (PhP 300,000.00) only, chargeable against OUMAIER-CDU FY 2023 MOOE for Professional Services – Other Professional Services, is included in the Department's Supplemental Annual Procurement Plan for FY 2023;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations ("IRR") of Republic Act ("RA") No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 revised IRR of RA 9184, a Request for Quotation ("RFQ") was posted on the Philippine Government Electronic Procurement System ("PhilGEPS") website for at least three (3) consecutive days, starting from 02 to 07 August 2023;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex "H" of the IRR, RFQs were sent to at least three (3) potential suppliers/contractors, namely: Partenaire PH, AR Travel and Tours, and Panthera Entertainment Production;

WHEREAS, in response to the solicitation of offers, quotations were received from: Red Root Artists and Artisans Multipurpose Cooperative (PhP 295,000.00; failed, bidder is not compliant with the Terms of Reference); Imaginimage Corporation (PhP 260,000.00; failed, bidder is not compliant with the Terms of Reference); and Partenaire Events Management Services (Partenaire PH), which submitted the lowest calculated and responsive quotation in the amount of Three Hundred Thousand Pesos (PhP 300,000.00) only;
