TERMS AND CONDITIONS

1. INCLUSIONS

Rates are inclusive of Gasoline, Toll, Parking and Driver meals and accommodation.

2. MODE OF PAYMENT

A Statement of Account will be sent together with the trip tickets after the tour. Payment will be made after receiving the Statement within thirty (30) days after receipt.

3. OVERLOADING

The maximum capacity of the car is FOUR (4) passengers, Van is TEN (10), coaster is TWENTY (20) passengers only for the Toyota Coaster and FORTY FIVE (45) passengers for the Buses. It is the responsibility of the charterer that this limit should not be exceeded. Any damage to the bus or injuries suffered by any of the passengers as a result of an overloading shall make the charterer primarily liable;

4. CANCELLATION

- a) Booking or cancellation shall be in writing. However, no cancellation fee will be charged to the charterer if the said cancellation is made TWO (2) WEEKS prior to the stipulated departure date and time, otherwise, a fee of 50% on the principal sum shall be charged to the charterer for any cancellation
- b) RNJAY TRANSPORT SERVICE reserved the right to cancel any trips covered by this agreement, if in its discretion and in good faith, it is of the belief that the continuation of the trip may endanger the lives of the passengers or may cause damage to the vehicle. Moreover, LESSOR shall not be liable for any damages that may be caused by.
- c) In the event of strikes, lockout, public or natural calamities or force majeure, RNJAY TRANSPORT SERVICE reserved the right to cancel the trip/s covered by this agreement and/or turn back to the nearest place of safety and in such event RNJAY TRANSPORT SERVICE shall not be liable for the damages that may be caused thereby.

5. INSURANCE CLAIMS

RNJAY TRANSPORT SERVICE obligates itself to provide its units with adequate insurance coverage to protect itself against the claims of the charterer's passengers should an accident occur and which damages/liabilities shall be limited to the insurance coverage of the bus. In this regard, it is obligation of the charterer that passengers shall obey all rules and regulations imposed by the LESSOR and any violation resulting in damages or injury to the passengers shall be the liability of the charterer;
