RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.6 (SCIENTIFIC, SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE TECHNOLOGY AND MEDIA SERVICES) FOR THE PROCUREMENT OF PROFESSIONAL SERVICES FOR "LARO, SINING AT IMAHINASYON: AN INTERACTIVE LEARN AND PLAY EXPERIENCE" AT THE MUSEO PAMBATA FROM OCTOBER TO NOVEMBER 2023

WHEREAS, the Office of Public and Cultural Diplomacy ("OPCD") intends to procure professional services for a hybrid event entitled "Laro, Sining, at Imahinasyon: Interactive Learn and Play Experience," wherein a video production and production of a 360° gamified virtual tour of Museo Pambata will be conducted, in celebration of Museum and Galleries Month (MGM) 2023 with the theme: "Exhibits and Reflections: Crafting Opportunities for the New World";

WHEREAS, the procurement of professional services for "Laro, Sining at Imahinasyon: An Interactive Learn and Play Experience" at the Museo Pambata with an Approved Budget for the Contract ("ABC") of *Two Million Five Hundred Thousand Pesos* (PhP 2,500,000.00) only, chargeable against UMAIER-CDU's MOOE FY 2022 Continuing Appropriations and MOOE FY 2023 under Other Professional Services, is included in the Department's Supplemental Annual Procurement Plan for FY 2023;

WHEREAS, Section 53 of the 2016 Revised Implementing Rules and Regulations ("IRR") of Republic Act ("RA") No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Negotiated Procurement;

WHEREAS, further, Section 53.6 of the said revised IRR can be resorted where Goods, Infrastructure Projects and Consulting Services can be contracted from a particular supplier, contractor or consultant as determined by the Head of the Procuring Entity ("HoPE"), for any of the following requirements, *inter alia*: (e) Media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media;

WHEREAS, after conducting a thorough market study, the end-user unit determined that the identified service provider could undertake the project at more advantageous terms;

WHEREAS, the OPCD submitted to Bids and Awards Committee ("BAC") the quotation from ***Exsight Three-Sixty Media Productions*** for the procurement of professional services for "Laro, Sining at Imahinasyon: An Interactive Learn and Play Experience" at the Museo Pambata, in the amount of *Two Million Four Hundred Ninety-Seven Thousand Six Hundred Pesos* (PhP 2,497,600.00) only;



WHEREAS, the BAC, after taking into consideration all relevant factors, finds that the awarding of the procurement of procurement of professional services for “Laro, Sining at Imahinasyon: An Interactive Learn and Play Experience” at the Museo Pambata may be done under Section 53.6(e) of the 2016 revised IRR of RA 9184;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity resort to Negotiated Procurement under Section 53.6 (Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services) as the alternative method of procurement for procurement of professional services for “Laro, Sining at Imahinasyon: An Interactive Learn and Play Experience” at the Museo Pambata from **Exsight Three-Sixty Media Productions**, subject to the abovementioned requirements, and provided that existing auditing rules and regulations shall be strictly observed by the end-user.


