

## CONTRACT AGREEMENT FORM

THIS AGREEMENT made this 2023-10-31 2023 between **Department of Foreign Affairs - Internal Audit Service - IAS** of the Philippines (hereinafter called "the Entity") of the one part and **DLCL Transport** with registered business address at **402 Kayumanggi St., Plainview, Mandaluyong City, Philippines** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Quotations for certain goods and ancillary services, viz., **Vehicle Rental for 3, 4 & 5 November 2023** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Sixty Eight Thousand Pesos (Php 68,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The Quotation Form and the Cost Distribution submitted by the Bidder shall be deemed to form and be read and construed as part of this Agreement;
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract;
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


