RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE LEASE OF MOTOR VEHICLES FOR THE OFFICIAL USE OF THE OFFICE OF PUBLIC AND CULTURAL DIPLOMACY (OPCD) FOR THE CULTURAL OFFICERS RETOOLING COURSE YEAR 2

WHEREAS, the Office of Public and Cultural Diplomacy (“OPCD”) intends to lease motor vehicles for its official use for the Cultural Officers Retooling Course Year 2 on 19 – 26 November 2023;

WHEREAS, the lease of motor vehicles for the official use of OPCD for the Cultural Officers Retooling Course Year 2, as listed under Purchase Request No. 10-10923, with an Approved Budget for the Contract (“ABC”) of *Nine Hundred Thousand Pesos* (PhP 900,000.00) only, chargeable against OUMAIER-CDU’s FY 2023 MOOE for Training Expenses, is included in the Department’s Supplemental Annual Procurement Plan (“SAPP”) for FY 2023;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (“IRR”) of Republic Act (“RA”) No. 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex “H” thereof;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex “H” of the 2016 revised IRR of RA 9184, a Request for Quotation (“RFQ”) was posted on the Philippine Government Electronic Procurement System (“PhilGEPs”) website for at least three (3) consecutive days, starting from 14 to 17 November 2023;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex “H” of the IRR, RFQs were sent to at least three (3) potential suppliers/contractors, namely: RNJAY Transport Service Corporation, A&W Tours En Transport Corporation, BICOL ISAROG Transport, and Kingyang Transport;

WHEREAS, in response to the solicitation of offers, a single calculated and responsive quotation was received from ***RNJAY Transport Service Corporation***, in the amount of *Five Hundred Twenty – One Thousand Pesos* (PhP 521,000.00) only;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity (“HoPE”) resort to Negotiated Procurement under Section 53.9 (Small Value Procurement) as the alternative method of procurement for the lease of motor vehicles for the official use of OPCD for the Cultural Officers Retooling Course Year 2 to

RNJAY Transport Service Corporation, subject to the abovementioned requirements, and provided that existing auditing rules and regulations shall be strictly observed by the end-user.


