RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF GO BAGS FOR THE OFFICIAL USE OF THE OFFICE OF ASSET MANAGEMENT AND SUPPORT SERVICES (OAMSS)

WHEREAS, the Office of Asset Management and Support Services ("OAMSS") intends to procure, for its official use, go bags for first aid and survival;

WHEREAS, the procurement of go bags for the official use of OAMMS, as listed under Purchase Request No. 10-13123, with an Approved Budget for the Contract ("ABC") of *Nine Hundred Thousand Pesos* (PhP 900,000.00) only, chargeable against OCA's FY 2023 MOOE under Other Supplies and Materials, is included in the Department's Supplemental Annual Procurement Plan for FY 2023;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations ("IRR") of Republic Act ("RA") No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 Revised IRR of RA 9184, a Request for Quotation ("RFQ") was posted on the Philippine Government Electronic Procurement System ("PhilGEPS") website for at least three (3) consecutive days, starting from 09 to 14 November 2023;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex "H" of the IRR, RFQs were sent to at least three (3) potential suppliers/contractors, namely: Beagiver, Subtledge Trading, and RND Marketing Corporation;

WHEREAS, in response to the solicitation of offers, quotations were received from: RND Marketing Corporation (PhP 597,750.00); Ban Bee Commercial Company (PhP 630,000.00); 999 Clique Enterprises (PhP 798,900.00); JM 3D Supply & Services Corp. (PhP 697,500.00); Reliqua Trading (PhP 792,150.00); and ***Ignis Liberandum Corporation***, which submitted the lowest calculated and responsive quotation in the amount of *Four Hundred Forty-Seven Thousand Seven Hundred Fifty Pesos* (PhP 447,750.00) only;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity resort to Negotiated Procurement under Section 53.9 (Small Value Procurement) as the alternative method of procurement for the procurement of go bags for the official use of OAMMS to ***Ignis Liberandum Corporation***, subject to the abovementioned

requirements, and provided that existing auditing rules and regulations shall be strictly observed by the end-user.

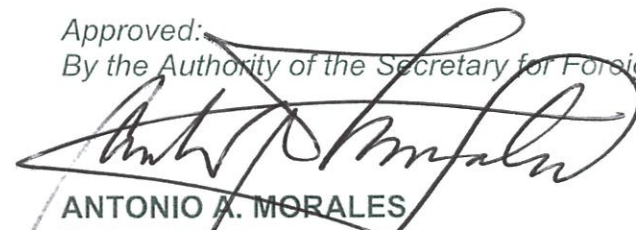

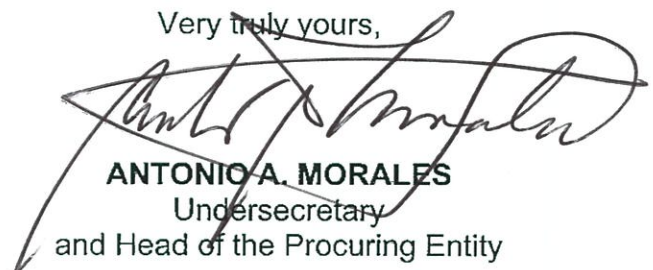
