RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 52.1(b) (SHOPPING) AS ALTERNATIVE METHOD OF PROCUREMENT FOR THE PROCUREMENT OF ICT EQUIPMENT FOR THE QUEUING MANAGEMENT SYSTEM OF THE OFFICE OF CONSULAR AFFAIRS (“OCA”)

WHEREAS, the Office of Consular Affairs (“OCA”) intends to procure ICT equipment for its Queuing Management System;

WHEREAS, the procurement of ICT equipment for the Queuing Management System of OCA, as listed under Purchase Request No. 05-07023, with an Approved Budget for the Contract (“ABC”) of *Nine Hundred Ninety Thousand Pesos* (PhP 990,000.00) only, chargeable against the Passport Revolving Fund (“PRF”) as approved by the Secretary of Foreign Affairs, is included in the Department’s Supplemental Annual Procurement Plan (“SAPP”) for FY 2023;

WHEREAS, Section 52.1(b) of the revised Implementing Rules and Regulations (“IRR”) of Republic Act (“RA”) No. 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Shopping as a method of procurement of goods whereby the procuring entity requests the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualification in the procurement of ordinary or regular office supplies and equipment not available in the Procurement Service involving an amount not exceeding one million pesos (PhP 1,000,000.00);

WHEREAS, the Office of Asset Management and Support Services (“OAMSS”) certified that the items being procured by OCA are not included in the Department of Budget and Management – Procurement Service (“DBM-PS”) price list. A copy of Certificate of Non-Availability of Stocks (“CNAS”) from the DBM-PS website is also attached;

WHEREAS, pursuant to Item No. (V)(C)(2)(b)(iii) of Annex “H” of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (“RFQ”) was posted on the Philippine Government Electronic Procurement System (“PhilGEPS”) website for three (3) consecutive days, from 20 to 25 July 2023:

WHEREAS, in compliance with Item No. (V)(C)(2)(b)(iv), Annex “H” of the IRR, RFQs were also sent to at least three (3) potential suppliers, namely: Columbia Technologies, Inc., JW Summit Group Inc., Richmark Computer Sales and Services, and Pronet Systems Integrated Network Solution Inc.;

WHEREAS, in response to the solicitation of offers, quotations were received from: the JW Summit Group Inc. (PhP 1,336,800.00; failed, quoted price is above the ABC), the BayanPC Technologies, Inc. (PhP 990,000.00), Richmark Computer Sales and Services (PhP 983,800.00) and the **Pronet Systems Integrated Network Solution Inc.**, which submitted the lowest calculated and responsive quotation in the amount of *Nine Hundred Seventy – Five Thousand Pesos* (PhP 975,000.00) only;

NOW, THEREFORE, we, the members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity (“HoPE”) resort to Shopping as the alternative method of procurement for the procurement of ICT equipment for the Queuing Management System of OCA from **Pronet Systems Integrated Network Solution Inc.**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.






