WHEREAS, on 02 May 2023, the BAC issued BAC Resolution CPM-PB-' declaring a failure of bidding for the Lease of Motor Vehicles for the Department of Affairs (May to December 2023);

WHEREAS, on 10 May 2023, the BAC Secretariat posted for five (5) consciously days the Notice of Conduct of Negotiated Procurement under Section

within the premises of the DFA, in accordance with Part IV(E) of Annex H Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 16 May 2023, the BAC conducted a **Negotiation Meeting** to the eligibility requirements and the technical and financial components of the contrabid, which was attended by A&W Tours En Transport Corporation and DLCL Trans

WHEREAS, on 23 May 2023, the deadline for the submission and receipt of the final offers, as well as the date of opening thereof, two (2) bidders, namely, A&W T Transport Corporation and DLCL Transport submitted their offers, which the determined to be as follows:
