**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON THE
PROCUREMENT OF SECURITY SERVICES FOR THE
DEPARTMENT OF FOREIGN AFFAIRS
(APRIL-OCTOBER 2023)**

WHEREAS, the Department of Foreign Affairs (DFA) intends to apply the sum of Seventy Four Million Nine Hundred Sixteen Thousand Two Hundred Ninety Eight Pesos and Three Centavos (PhP 74,916,298.03) only, being the Approved Budget for the Contract (ABC) to payments for the Procurement of Security Services for the DFA (April to October 2023);

WHEREAS, the said ABC is chargeable against the FY 2022 Continuing Appropriations for Security Services, OAMSS FY 2023 MOOE for Security Services, and Passport Revolving Fund;

WHEREAS, on 30 January 2023, the Bids and Awards Committee (BAC) conducted a *Pre-Procurement Conference* to assess the readiness of the procurement in terms of confirming the availability of funds and to review all relevant documents in relation to the Procurement of Security Services for the DFA (April to October 2023);

WHEREAS, on 08 March 2023, the BAC Secretariat posted for seven (7) consecutive calendar days the *Invitation to Bid* for the Procurement of Security Services for the DFA (April to October 2023) on the DFA and PhilGEPS websites, and at conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 15 March 2023, the BAC held a *Pre-Bid Conference*, to discuss the eligibility requirements and the technical and financial components of the contract to be bid which was attended by Manburg Security, Maximum Security and Services Corp., NC Lanting Security Specialist Agency, Lifeguard Archangels Security Agency Corp., Best Forces Security Services, and MBG Security and Investigation Services, Inc.;

WHEREAS, on 20 March 2023, the BAC issued Supplemental Bid Bulletin No. 1 clarifying the number of items mentioned in "Annex A. Equipment for the DFA Main Building/DFA Leased Premises and DFA-Aseana", particularly the number of vehicles, portable metal detectors, and handcuffs;

WHEREAS, on 29 March 2023, the deadline for the submission and receipt of bids as well as the date of opening thereof, only **NC Lanting Security Specialist Agency** submitted a bid which the BAC determined to be as follows:


WHEREAS, the BAC declared **NC Lanting Security Specialist Agency** as having the Single Calculated Bid, and subjected it to **Post-Qualification** on 31 March 2023, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complied with and was responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the post-qualification of bids and after careful consideration, the BAC determined that the bid of **NC Lanting Security Specialist Agency** was compliant with and responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, the Intelligence and Security Unit, the end-user for this procurement, also confirmed that the bid of **NC Lanting Security Specialist Agency** was compliant responsive to all the requirements and conditions specified in the technical specifications for the Procurement;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the *Contract on Security Services for the Department of Foreign Affairs (April to October 2023)* to **NC Lanting Security Specialist Agency** for having submitted the Single Calculated and Responsive Bid in the amount of **Seventy-Three Million One Hundred One Thousand Four Hundred Forty-Two Pesos and 61/100 (PhP 73,101,442.61)**, pursuant to Section 37 of the revised IRR of RA 9184.






