

AGREEMENT FOR THE SECURITY SERVICES FOR THE DEPARTMENT OF FOREIGN AFFAIRS (1 APRIL 2023 TO 31 OCTOBER 2023)

KNOW ALL MEN BY THESE PRESENTS:

This **AGREEMENT** for the procurement of security services for the Department of Foreign Affairs (hereinafter, the **AGREEMENT**), entered in Pasay City, Philippines, on APR 01 2023 between the:

DEPARTMENT OF FOREIGN AFFAIRS, (hereinafter, the **PROCURING ENTITY**), with principal office address at 2330 Roxas Boulevard, Pasay City, 1300 represented by the Undersecretary, and Head of the Procuring Entity (HOPE), ANTONIO A. MORALES,

and

NC LANTING SECURITY SPECIALIST AGENCY (hereinafter, the **CONTRACTOR**), a company duly organized and existing under and by virtue of the laws of the Philippines, as evidenced by the submitted Certificate of Business Name Registration issued by the Department of Trade and Industry on 24 June 2018, valid until 24 June 2023, attached as **ANNEX A**, with principal office address at 218 Malvar St., Ayala Alabang, Muntinlupa City, Fourth District, National Capital Region (NCR) represented by Ms. NIMFA DELA CRUZ LANTING, who is duly authorized to enter into this **AGREEMENT** as the Company Proprietress and General Manager.

WITNESSETH:

WHEREAS, the **PROCURING ENTITY** invited bids for the **SECURITY SERVICES FOR THE DEPARTMENT OF FOREIGN AFFAIRS (1 APRIL 2023 TO 31 OCTOBER 2023)** and has accepted a bid by the **CONTRACTOR** to provide said services in the sum of **Seventy-Three Million One Hundred One Thousand Four Hundred Forty-Two Pesos and Sixty-One Centavos (PhP73,101,442.61)** only (hereinafter, the **CONTRACT PRICE**), inclusive of all applicable taxes and other lawful charges.

NOW, THEREFORE, for and in consideration of the foregoing premise, the **PARTIES** agree as follows:



3. For and in consideration of the delivery of the performance of services, the **PROCURING ENTITY** shall pay the **CONTRACTOR** the above-mentioned **CONTRACT PRICE**. The



terms of payment shall be in accordance with the provision of Section 8 of **TECHNICAL SPECIFICATIONS (ANNEX F)**.


